## Employer pension plans (trusteed pension funds), second quarter 2013

The market value of Canadian employer-sponsored pension funds totalled \$1.2 trillion at the end of the second quarter, virtually unchanged from the previous quarter.

Pension fund investments in stocks declined 1.8% in the second quarter, as the value of shares on the Toronto Stock Exchange fell 2.7% during the same period. An increase in the value of real estate assets (+1.9%) and short-term investments (+6.5%) partially offset declines in the value of stocks, bond holdings (-1.9%) and mortgages (-2.8%).

Foreign investments rose 1.1% in the second quarter, as the share of foreign investments held in Canadian pension funds increased to 33.3% of total pension fund assets.

Total pension fund revenue declined 13.1%, primarily as a result of a 54.8% decrease in net profits on the sale of securities. Net losses on the sale of securities totalled \$2.1 billion and drove expenditures up 16.1% in the second quarter. Net income fell by 35.1% from \$20.6 billion in the first quarter to \$13.4 billion in the second quarter.

Pension fund contributions in the second quarter totalled close to \$14 billion, up 4.5% from the previous quarter. Benefits paid to retirees increased 3.8% to \$12.2 billion.

Just over six million Canadian workers are members of employer pension plans. Of this group, five million are members of trusteed plans. The remaining one million members with employer pension plans are managed principally by insurance company contracts. Data in this release refer only to trusteed plans and their pension funds.

## Travel arrangement services, 2012

Canada's travel arrangement and reservation services industry group continued to expand in 2012, posting its third straight year of growth. The industry's operating revenues grew 5.8% from 2011 to \$11.5 billion, driven largely by the strength of the tour operator industry.

The industry group comprises tour operators, travel agencies and reservation services industries.

Tour operators dominated the travel arrangement and reservation services industry group, accounting for more than three-quarters (76.0%) of total operating revenues.

Operating revenues for tour operators increased 7.0% to \$8.8 billion in 2012, compared with a 3.8% growth rate in 2011. Operating expenses also grew (+7.5%), narrowing the operating profit margin from 1.0% in 2011 to 0.5% in 2012.

The cost of tour package components typically represents the bulk of expenses for the tour operator industry. In 2012, it accounted for 86.7% of expenses, while the next largest expense item—salaries, wages and benefits—represented 4.2% of total operating expenses.

Travel agencies were the second largest industry in the group, accounting for 14.9% of overall operating revenues.

The operating revenues of travel agencies increased 1.5% in 2012 to \$1.7 billion, while expenses increased 2.1% to \$1.6 billion. The operating profit margin fell to 7.6% in 2012 from 8.2% in 2011. Despite the decrease, the travel agency industry maintained the strongest profit margin in the travel arrangement and reservation services industry group.

The travel agency industry mainly consists of small, labour-intensive firms; as such, salaries, wages and benefits accounted for 61.0% of total operating expenses.

Reservation services, the smallest of the three industries, represented 9.0% of the travel arrangement services industry operating revenues in 2012. Operating revenues for this industry continued to increase, up 3.2% to \$1.0 billion in 2012.

# Commercial and industrial machinery and equipment rental and leasing, 2012

Operating revenues for the commercial and industrial machinery and equipment rental and leasing industry grew 9.1% to \$9.2 billion in 2012. During the same period, operating expenses increased 8.4%, causing the operating profit margin to rise from 15.4% in 2011 to 16.0% in 2012.

The growth in equipment rental and leasing services was partly the result of strong economic conditions in key client industries, such as the Canadian construction industry, which is a major user of heavy equipment rental services.

The cost of goods sold, which includes the procurement of equipment to rent and lease, accounted for 23.3% of all operating expenses. Salaries, wages and benefits (21.8%) and amortization and depreciation (18.8%) followed closely in terms of relative importance. Shares of the top three expenses have remained fairly stable over the years.

Sales to other businesses comprised 89.5% of total sales in 2012, while sales to individuals, government, non-profit organizations, public institutions and clients outside the country made up the remainder.
