Releases

Natural gas sales, November 2013

Natural gas sales totalled 8 086 million cubic metres in November, down 0.4% compared with November 2012.

The volumes of sales to the residential (+0.7%) and commercial (+2.1%) sectors were up, while sales to the industrial (-1.5%) sector were down compared with the same month a year earlier.

Total sales in November were 31.1% higher compared with October.
