### Infographic: The faces of volunteers in Canada, 2013

An infographic illustrating data on volunteering in Canada is now available. Data cover the age, sex and education level of volunteers, as well as hours volunteered and the volunteering rate.

Data are primarily from the 2013 General Social Survey on Giving, Volunteering and Participating, which was undertaken to better understand how Canadians support individuals and communities on their own or through their involvement with charitable and non-profit organizations.

The data summarized in the CANSIM tables are drawn from the Legal Aid Survey, which is conducted annually on a fiscal year basis (from April 1 to March 31). The survey provides information on revenues, expenditures, personnel, and caseload statistics associated with the delivery and administration of legal aid in Canada.
