Capital and Repair Expenditures Survey: Update

The release of data from the Annual Capital and Repair Expenditures Survey (actual spending for 2013) is postponed to May 26, 2015, while data for 2014 (preliminary) and 2015 (intentions) will be released on July 6, 2015.

Statistics Canada is currently implementing changes and improvements to the business survey data processing infrastructure and systems, on which the Annual Capital and Repair Expenditures Survey depends, and requires additional time to complete this work.

Note to readers

As announced in The Daily on February 26, 2015, Statistics Canada has undertaken a comprehensive redesign of the Capital and Repair Expenditures Survey, also known as CAPEX. The redesign of CAPEX is part of a multi-year initiative conducted by Statistics Canada to further improve data coherence and quality across its economic statistics program.

Asphalt roofing, March 2015

Shipments of asphalt shingles decreased 9.1% from a month earlier to 4.6 million metric bundles in March. Production of asphalt shingles increased 19.7% to 4.1 million metric bundles.

Asphalt shingles shipments were 1.3% lower compared with March 2014, while the production of asphalt shingles was 0.1% higher.

Note to readers

The monthly survey, Asphalt Roofing, measures production, shipments and exports of asphalt roofing products, including the destination of shipments.

Data in this release are subject to revisions and not seasonally adjusted.
