REAL DOMESTIC PRODUCT

Indexes of Real Domestic Product by Industry, August 1971 - Advance information

Canada's real domestic product, seasonally adjusted, rose strongly in August. The increase in output of 1.2% was slightly stronger than the advances in March and May. Manufacturing, transportation, storage and communication, and the trade industries registered the most significant increases.

The rise in manufacturing output, the largest since January, originated mainly with the durable goods industries, led by a strong advance in the output of motor vehicles manufacturers. Within durables manufacturing, only the electrical products and the primary metal industries major groups decreased. Production of non-durables was also higher in August, based on increases in the pulp and paper and the printing and publishing industries.

In August, transportation, storage and communication recorded its second substantial increase for the year. As in May, when the previous large increase occurred, railway transport was particularly strong, with increased carriage of many commodities - notably ores, logs, automobiles, and pulp and paper. Most of the other components in this group of industries increased, with the Post Office and grain elevators reporting noteworthy advances.

Trade partially recovered from its large July decrease. Within wholesale trade, the wholesale merchants registering the more important increases were industrial and transportation equipment, construction materials, hardware, and newsprint and paper. Increases in department stores and new motor vehicle dealers and decreases in used car dealers and food stores were the most significant movements, contributing to a fractional advance, in retail trade.

The most significant changes in other industries were an increase of construction output (mainly residential) and a decrease in agriculture output (declines in livestock and poultry production). (It should be noted that the September forecast of production of field crops has been incorporated into the 1971 crop estimates. The revised monthly agriculture indexes and affected aggregates are listed in the first of the following tables. No other indexes have been revised for the first five months of 1971.)

Prices & Price Indexes (General Wholesale Index), September 1971 -
Advance information

The general wholesale index (1935-39=100) moved down 0.1% in September to 291.6 from the August index of 292.0. It was 2.5% higher than the September 1970 index of 284.4. Four of the eight major group indexes were lower, while four advanced.

The animal products group index rose 0.8% to 330.4 from 327.9 on higher prices for milk and its products, cured meats and eggs. The textile products group index moved up 0.6% to 263.9 from 262.3 in response to price increases for cotton fabrics and raw cotton. Increases of 0.2% or less occurred in two major group indexes; non-metallic mineral products to 227.1 from 226.7 and iron products to 318.4 from 318.2.

The vegetable products group index moved 1.4% lower in September to 232.8 from 236.0 on price decreases for potatoes, sugar and its products, grains, livestock and poultry feeds, and vegetable oils. A decline of 0.9% to 259.9 from 262.2 in the non-ferrous metal products group index was chiefly attributable to lower prices for silver and export sales of refined copper. The chemical products group index moved down 0.5% to 238.8 from 240.0. A decline of 0.4% to 403.7 from 405.3 in the wood products group index reflected price decreases for cedar, pine, spruce and building board.

Prices & Price Indexes (Industry Selling Price Indexes), September 1971 -
Advance information.

Industry selling price indexes (1961=100) were higher in September than in August for 37 manufacturing industries, lower for 24 and unchanged for 39.

Increases were recorded in the foods and beverages group reflecting higher price levels in the butter and cheese plants, pasteurizing plants, condenseries and breweries industries. Moderate declines occurred in the wood products group as a result of lower prices in the sawmills and planing mills industry. Decreases were registered in the primary metals group due to the smelting and refining industry.

The arithmetic average of the 100 industry indexes was 123.5 in September the same as in August. The average (unweighted) increase for those industries showing higher price movement was 0.9%, while the comparable figure for those showing decreases was 1.2%.

The Labour Force, September 1971 (71-001, 20¢/\$2).

In July 1971, the unemployment rate for students planning on returning to school was much smaller (9.8%) than for those not planning to return (23.2%). A year earlier the difference was not quite so marked (12.3% versus 21.1%).

July was the peak month for summer student employment as 42.8% of students between the ages of 14 and 24 who planned to return to school were either employed or looking for work, compared to 39.5% in August. The same pattern occurred in 1970, when participation peaked at 42.3% in July, and eased to 37.7% in August.

A thorough study of the student labour force in the summer is the first of a series of supplementary features to appear in the newly-enlarged bilingual monthly The Labour Force. Regular monthly additions include expanded data on the labour force, charts, seasonally-adjusted data, annual averages and more comparison with earlier months.

MERCHANDISING

Direct Selling in Canada, 1970 - Advance information

Direct selling to household consumers by manufacturers and specialist direct-sellers in 1970, increased 2.0% to \$718.3 million from the 1969 figure of \$704.5 million. (Annual sales of \$27,792.9 million were recorded through retail store locations.) The pattern of distribution of 1970 direct sales was similar to previous years: door-to-door canvassing accounted for 72%; mail order sales, 19%; counter sales at manufacturing premises, 6% and other channels, such as, house-parties and exhibitions, 3%.

Steel Ingots, Week ended October 23, 1971 — Advance information.

Steel Ingot production for the week ended October 23, totalled 222,945 tons, a decrease of 6.9% from the preceding week's total of 239,364 tons. The comparable week's total in 1970 was 224,287 tons. The index of production based on the average weekly output during 1967 of 183,227 tons equalling 100 was 121.7 in the current week, 130.6 a week earlier and 122.4 one year ago.

Oil Pipe Line Transport, August 1971 — Advance information.

Canadian oil pipe lines received 2,173,300 barrels per day of crude oil, condensate, pentanes plus and refined petroleum products in August. This was 8.3% more than the 2,006,300 B/D received a year earlier. Domestic oils increased 13.2% to 1,772,000 B/D, and imported oils decreased 9.1% to 401,300.

During the third quarter of 1971, Canadian manufacturers shipped 382,849 pounds of woven and/or needled papermakers' felts and jackets valued at \$3,357,528 to Canadian mills; this compared with 396,961 pounds and \$3,240,962 in the same quarter of 1970.
