New Statistics

Construction Price Statistics Service Bulletin (62-006, \$3 a year), Vol. 1, Nos. 5, 6 and 8:

Indexes of selected pay supplements have been determined for 12 important construction trades in 14 major Canadian cities. These have been published, along with related basic union wage rate indexes, for the years 1961 to 1971 in Volume 1, Numbers 5 and 6 of the Construction Price Statistics Service Bulletin. Coverage includes 60 pages of descriptive text and discussion of index movement, analytical tables and charts.

Indexes of basic wage rates are up-dated through the first two quarters of 1972 in Volume 1, Number 8.





The Labour Force, January 1973 – Advance Information.

The labour force increased to 8.88 million in January 1973, from 8.58 million a year earlier and 8.34 million in January 1971. Employment increased to 8.19 million from 7.92 million and 7.67 million: unemployment to 688,000 from 665,000 and 668,000. The January unemployment rate was 7.7 per 100 in the labour force) in both 1973 and 1972, down from 8.0 in 1971.

Seasonally adjusted, unemployment was lower in January (566,000) than it had been since June (555,000). The adjusted unemployment rate was 6.2 in January versus 6.7 in December, 6.9 in September and 6.3 in June. (It should be noted that, as is customary in January, the seasonal adjustment factor has been revised – including all above figures – to incorporate last year's seasonal pattern).

Corporation Financial Statistics, 1970 – Advance Information.

There were nearly 220,000 active corporations reporting under the Income Tax Act for 1970, compared with nearly 207,000 in 1969. Total income increased 7% to \$141.3 billion, but total reported expenses rose considerably faster resulting in a 5% decline in net profits to \$8.45 billion (before taxes and non-recurring items). Despite a marked increase in losses reported for 1970, the aggregate amount of income taxes (provision for taxes) declined by only 2% to \$3.4 billion, resulting in a sharp decline in net profits after taxes. Profits of corporations in the mining industry rose 22% and those in transportation, communications and utilities advanced 15%, but substantial declines were registered in manufacturing (20%) and in construction (21%).

In general, the size of corporations was directly correlated to profit performance. Profits of com-(continued)

Additional new financial ratios have been added to the previously published selected ratios for 182 industries, and will cover the three years 1968, 1969 and 1970. panies with assets of \$25 million and over increased by \$107 million while, on the othe hand, companies with assets of \$1-25 million reported declines in profits of \$343 million, and those in the asset size group of under \$1 million registered declines of \$218 million. In aggregate 240 corporations with assets of \$100 million and over in 1970 accounted for 53% of all corporate assets, and for 44% of all corporate profits. More than three quarters of all corporations had assets of less than \$250,000 and accounted for

Hospital Statistics, Volume II – Hospital Services, 1970 – Advance Information.

Public general hospitals reported over 10,191,000 radiology examinations in 1970, 7.4% more than in 1969. Of this total, 53.8% were for out-patients. Radiographic examinations (excluding tuberculosis screening chest X-ray examinations) per 100 adult and child admissions, however, decreased slightly to 123.0 in 1970 from 123.7 in 1969.

Opearting room visits by in-patients per 100 adult and child admissions increased to 46.5 in 1970 from

45.9 in 1969 and the average daily number of emergency unit visits climbed to 27.9 from 24.4.

The number of mothers delivered in all general and allied special hospitals increased only 0.8% to 375,744. Of this total, 4,759 were still births, 2.1% less than in 1969, and 22,264 were Caesarian section deliveries, up 11.3%.

Citizenship of Full-Time Teaching Staff in Universities, 1971-72 – Advance Information.

Information covering 97% of full-time teaching staff in Canadian universities showed that 63.3% held Canadian citizenship in 1971-72, up from 61.8% the previous year.

Salaries of Full-Time Teaching Staff at Canadian Universities and Colleges, 1972-1973 – Advance Information.

A selection of 30 universities representing 13,382 full-time teachers or approximately one half the full-time teaching force in Canadian universities indicate that the average salary is \$17,572. This is a 7.2% increase over last year's average and supersedes figures provided in December based on the salaries of 9,241 full-time teaching staff.

Federal Government Employment, Third Quarter 1972 – Advance Information.

The federal government had 417,487 employees on September 30, 1972, 5,028 fewer than on June 30. The decrease was primarily due to the ending of seasonal employment of students and other casual employees. Total payroll for the quarter decreased by \$22.8 million to \$888.5 million.

Passenger Bus Statistics, December 1972 – Advance Information.

In December, 43 intercity and rural bus companies carried 3.24 million passengers. This was 12.3% less than the 3.70 million carried a year earlier. Their busses travelled 10.4 million vehicle miles (down 0.8) and consumed 1.35 million gallons of diesel oil (down from 1.40 million) and 93,751 gallons of gasoline down from 94,231. Total operating revenue increased 7.8 to \$8.28 million.

Weekly Railway Carloadings, January 21, 1973 - Advance Information.

Railways in Canada loaded 4,361,156 tons of revenue carload freight during the 7-day period ending January 21. This was 21.2% more than in the comparable period of 1972. Railway Operating Statistics, October 1972 – Advance Information.

Twenty-four common carrier railways operating in Canada reported revenues totalling \$177.8 million for the month of October, 1972. This was 9.0% higher than the \$163.0 million reported for October, 1971. Operating expenses rose 9.6% to \$160.2 million making net operating income 3.9% or \$0.7 million higher at \$17.6 million.

Revenue freight ton-miles rose 4.4% to 11.7 million. Revenue passenger-miles declined 20% to 127.7 million reflecting a decline to 61 from 85 in the number of passengers carried per passenger train-mile.

Canadian mines shipped 3.14 million tons of iron ore in December 1972, compared to 2.80 million a year earlier. This brought the twelve months output to 42.7 million tons from 47.4 million (revised) a year earlier.

Petroleum and Coal Products Industries (Industry Group 18), 1971, Census of Manufactures – Advance Information.

The petroleum and coal products industries shipped \$2,113 million worth of products of own manufacture in 1971. This was 16.2% more than in 1970. The total value added by these industries increased 20.3% to \$434 million, the number of employees decreased 0.8% to 15,517, and total salaries and wages increased 7.4% to \$173 million.

Pulpwood and Wood Residue, December 1972 – Advance Information.

Roundwood production increased by 7.8% to 1,479,864 cunits in December 1972 from 1,372,610 cunits a year earlier. Consumption of roundwood and wood residue increased by 5.6% to 2,194,293 cunits from 2,076,967 cunits and the closing inventory of these two products decreased by 12.2% to 8,737,756 cunits from 9,946,109. Receipts of wood residue increased by 13.7% to 695,850 cunits from 611,774.

Electric Power Statistics, December 1972 – Advance Information.

In December 1972 net generation rose 12.7% to 23.2 billion kwh. from 20.6 billion a year earlier. There were increases in net generation in all provinces. The largest increases were 166.7% in Newfoundland and 16.3% in New Brunswick. Hydro generation increased 19.0% while thermal production decreased 1.8%.
