Retail Trade

Retail sales in Canada reached \$3.39 billion in January, an increase of 15.7% from a year earlier. Sales were up in 25 of the 28 trade groups with the largest gains recorded by book and stationery stores (43.0%) and grocery, confectionery and sundries stores (27.1%).

All provinces and territories reported sales increases over January 1974 with highs of 22.9% for Nova Scotia and 22.0% in New Brunswick. Sales rose 13.4% in Vancouver, 13.1% in Toronto, 11.9% in Montreal and 2.0% in Winnipeg.

Building Permits

Building permits taken out in Canada in January totalled \$494.3 million, up 9.7% from \$450.4 million a year earlier.


Lower totals were recorded in the latest month for residential permits at \$157.6 million (\$213.8 million a year earlier) and institutional and governmental permits at \$57.4 million (\$76.6 million). Increases were registered for commercial permits at \$237.9 million (\$122.3 million) and industrial permits at \$41.3 million (\$37.7 million).

Building permits taken out in January, by province and with January 1974 totals in brackets:

Ontario, \$278.8 million (\$185.7 million); Alberta, \$66.8 million (\$45.7 million); British Columbia, \$63.4 million (\$83.0 million); Quebec, \$39.6 million (\$89.7 million); Nova Scotia, \$13.5 million (\$25.1 million); New Brunswick, \$11.6 million (\$2.9 million); Manitoba, \$11.2 million (\$8.4 million); Saskatchewan, \$7.2 million (\$7.8 million); Newfoundland, \$1.2 million (\$1.9 million); and Prince Edward Island, \$764,000 (\$128,000).

Employment, Earnings and Hours

Average weekly earnings in Canadian industry at \$191.92 in January were up 14.4% from \$167.72 a year earlier.

First estimates show that average weekly earnings (by province) were highest in British Columbia (\$216.53), followed by Ontario (\$195.18), Alberta (\$194.02), Quebec (\$187.52), Newfoundland (\$181.89), Saskatchewan (\$173.98), Manitoba (\$172.34), New Brunswick (\$171.20), Nova Scotia (\$165.18) and Prince Edward Island (\$143.96).

Average weekly earnings in January (by industry division) were as follows: construction, \$267.01; mining, \$257.68; forestry, \$233.24; transportation, communication and other utilities, \$216.94; manufacturing, \$202.84; finance, insurance and real estate, \$185.50; trade, \$152.37; and service, \$137.26.


Industrial Corporations, Financial Statistics

Revised data show Canadian industrial corporations recorded after-tax profits of \$2.26 billion for the fourth quarter of 1974, a decrease of \$68 million (2.9%) from the corresponding period a year earlier.

Industrial corporations' sales in the latest quarter amounted to \$50.3 billion, up \$7.4 billion (17.2%) from the fourth quarter of 1973.

Assests of these corporations rose \$19.1 billion (16.0%) during 1974.

Motor Vehicle Production

Canadian production of motor vehicles totalled 107,041 units in February, a drop of 21.5% from 136,302 a year earlier.

Passenger car production declined to 77,151 units from 107,098, while production of commercial vehicles increased to 29,890 units from 29,204 in February 1974.

For the first two months of 1975, Canadian production of motor vehicles totalled 199,071 units, down 31.3% from 289,835 in January-February 1974.

Preliminary Report on Job Vacancies

Preliminary estimates for the three-month period ending in February show a further decline in the average number of vacant jobs.

Vacancies for full-time, part-time and casual jobs numbered 62,100 compared with 105,700 in the preceding three months and 77,300 a year earlier.

Full-time job vacancies declined to 56,900 from 94,000 in the preceding period and 72,400 at February 28, 1974.

For every 1,000 existing jobs in the surveyed three-month period, eight jobs were vacant, down from 13 in the preceding period and from 10 a year earlier.

Coal and Coke Statistics

Canadian coal production increased 11.6% in January to 2.27 million tons from 2.03 million tons in January 1974. Imports rose to 765,202 tons from 133,135 tons.

Industrial consumers used 2.26 million tons of coal in the latest month (down 11.9% from a year earlier) and 504,356 tons of coke (down 0.1%).

Provincial Government Employment

Canada's provincial and territorial governments (excluding British Columbia) employed a total of 320,038 persons in general government services during the last pay period of December 1974.

Gross payrolls for the fourth quarter of 1974 amounted to \$825.1 million.

Real Domestic Product

Canada's seasonally-adjusted index of real domestic product (1961=100) decreased 0.5% in January to 201.7 from a revised December level of 202.7.


Most of the decline originated with the goods-producing industries, where output dropped 1.1% during the month. Service-producing industries' output decreased 0.1%.


Major contributors to the over-all January decline in real domestic product were manufacturing (-2.0%), mining (-3.1%), transportation (-2.0%), forest-ry (-6.4%) and construction (-1.3%).

Durable goods manufacturing fell 5.0% - the largest decline since September 1970. Decreases in production as well as layoffs were recorded by motor vehicle manufacturers and manufacturers of major appliances and household radio and television sets.

Within non-durables manufacturing, which increased 1.2%, most of the increase originated with distilleries (because of strike recovery) and manufacturers of industrial chemicals.

The Wheat Review

Total exports of wheat from the four traditional major exporters during August 1974 – January 1975 have amounted to 977.8 million bushels, down 1% from 986.5 million in the year-earlier period.

Total supplies of wheat remaining in these countries at February 1, 1975 for export and for carryover at the end of their respective crop years amounted to 1,561.9 million bushels, slightly below the 1,569.0 million on hand at the same date in 1974.

Supplies were held as follows, in millions of bushels and with last year's comparable figures in brackets: United States, 699.0 (572.7); Canada, 530.1 (598.7); Australia, 294.8 (309.9); and Argentina, 38.0 (87.7).

Residential Building Construction Input Price Index (1971=100)

The residential building construction input price index for Canada advanced to 135.7 in February, an increase of 0.8%

135.7 in February, an increase of 0.8% from the January level and up 4.5% from a year earlier.

Prices of building materials used in residential construction increased 0.2% over the twelve months from February 1974; labour costs rose 12.3%.

During this period, residential building construction input price indexes advanced in all regions of Canada, with increases recorded as follows:

• Quebec, 6.0%; Prairie Provinces, 5.2%; Atlantic Provinces, 4.3%; British Columbia. 4.1%; and Ontario, 3.5%.

Preliminary Statement of Canadian Trade In February, seasonally-adjusted exports declined 4.3% and imports 1.1% from January levels. Canada's merchandise trade deficit widened to \$211 million from \$120 million in January.

Exports declined to \$2.69 billion in February from \$2.81 billion the previous month with most of the decrease concentrated in shipments to countries other than the United States and the continental European Economic Community. Exports to the United Kingdom rose 20% to \$201 million.

The value of shipments to the U.S. rose 1% in February to \$1.76 billion, on a seasonally-adjusted basis. Lower deliveries of crude petroleum and some fabricated goods partly offset increased exports of automotive products. A sharp decline in wheat shipments — caused in part by a labour dispute involving grain handlers and in exports of some crude materials and metals contributed to reduced shipments to overseas destinations.


Seasonally-adjusted imports declined 1.1% in February to \$2.90 billion, but the level of imports in the latest three months was 3.5% above that of September-November 1974.



Oil Pipe Line Transport

Canadian oil pipe lines received 2.83 million barrels per day of crude oil, condensate, pentanes plus and refined petroleum products in January, a decrease of 8.3% from a year earlier.

Railway Carloadings

Railways operating in Canada reported a total of 17.3 million tons of revenue carload freight loaded in February, an increase of 8.6% from a year earlier. Non-carload shipments rose 34.2% to 155,613 tons.

Commodities showing notable tonnage increases in the latest month included: sulphur (up 48.5%); copper-nickel ores and concentrates (up 26.3%); iron ore (up 25.7); coal (up 19.4%); and wheat (up 18.1%). Major tonnage declines were registered for lumber (- 20.6%) and pulpwood (- 9.9%).

For the first two months of 1975, total carload traffic at 35.0 million tons was up 6.3% from January-February 1974. Copper-nickel ores, sulphur, wheat, coal and iron ore haulings were all substantially higher in the latest period.
