
Heart Disease Still Leading Cause of Death

Heart disease (Ischaemic) remained the leading cause of death in Canada, accounting for approximately 26% of the 181,323 deaths occurring in 1985. Cancer mortality was just slightly behind at the national level – causing 25.6% or 46,333 deaths. The gap between these two major causes of death has been narrowing over the last several years as deaths from heart disease decrease and cancer mortality increases.

Cancer appears to be replacing heart disease as the leading cause of death much more rapidly for women than for men. Cancer was the leading cause of female death for the third consecutive year in 1985, while the highest death rate for males continued to be heart disease.

The age-standardized death rate (which removes the effect of an aging population) for lung cancer in males decreased, but it remains to be seen

whether this represents a reversal of the upward trend which has been observed for many years. For women, the death rate from lung cancer showed a greater increase than the increase in the death rate for breast cancer. However, mortality from breast cancer was still considerably higher.

According to preliminary abridged life tables, average life expectancy at birth increased by approximately one year for both males and females.

However, the rate of increase from 1980-82 to 1983-85 was somewhat slower than in previous periods. The life expectancy for males and females has been converging for a number of years, but female life expectancy was nearly seven years greater than that of males.



Declining Number of Unemployment Insurance Beneficiaries

In August, the number of unemployment insurance beneficiaries was down on a year-over-year basis for the seventeenth consecutive month. However, the rate of decline has slowed in recent months. The rate of decrease in the number of beneficiaries has dropped from -8.5% in January, to -3.1% in August.

Saskatchewan, Alberta and Newfoundland have reported more beneficiaries for the last several months, while the remaining provinces continue to record fewer beneficiaries.

In August, total unemployment insurance payments were \$725 million, down 9.4% from July, but up slightly (0.5%) from August 1985. Payments for the first eight months of 1986 amounted to \$7.3 billion, virtually unchanged from the same period of last year. The number of claims received was also essentially unchanged. Disqualifications and disentitlements, on the other hand, have dropped on a year-over-year basis for seven months.

Growth in Industrial Employment Slows

In August, the total number of Canadian industrial employees was estimated to have risen by 94,000 or 1.0% from August 1985. The yearly rate of change in the service-producing industries, which averaged 2.1% in the preceding three months, was down slightly to 1.8% in August. Employment in transportation, communication and other utilities has been declining steadily since March, while the yearly rate of change in trade has been increasing during the same period.

In the goods-producing industries, employment was down 1.1% from August 1985. The annual rate of change in these industries has been declining steadily since January when it was 5.2%. From July to August, declines were noted in forestry, mining and manufacturing. Employment in these three industries

usually increases at this time of year but strikes and lay-offs contributed to the month-to-month decrease in August.

Compared to August 1985, total average weekly earnings increased by 2.4%. This was slightly lower than the yearly rate of change observed since the beginning of the year. Average earnings in the goods-producing industries rose by 2.0%. The year-to-year growth rate in manufacturing, which accounts for over 70% of employment in the goods-producing sector, has decreased steadily since the start of the year. It has dropped from 4.6% in January, to 2.5% in August. In August, the rate of change in the service-producing industries was 2.8%, slightly lower than the 3.2% growth rate observed in the previous two months.

Gross Domestic Product Essentially Unchanged


In August, real Gross Domestic Product at factor cost was essentially unchanged from July. Following gains of 0.2% and 0.6% in June and July, real GDP was 4.0% higher than it was a year earlier. For the last eight months year-over-year increases in real GDP have averaged 4.3%.

Output from the goods-producing industries slipped 0.1% in August. Manufacturing production fell by 2.9%, much of this decrease occurred in industries that were affected by major labour diputes in British Columbia. Three industries (forestry, wood products, and paper and allied products) recorded a combined drop of 12% in August.

However, production increases recorded in the mining and construction industries almost offset the declines noted above. These were the first month-over-month advances registered by these industries

since April 1986. Most of the growth in mining was due to a pick-up of oil and gas exploration activity, especially in the offshore and northern regions. The gain in the construction industry was mainly due to increased residential construction.


Output from the service-producing industries was unchanged in August. The finance, insurance and real estate industry was the only one reporting significant growth. This particular industry has generally followed an upward trend since February 1986. Declining output was registered by the transportation, wholesale trade and communications industries in August.

Wholesale Trade Remains Well Up over 1985

Following a advance of 13.1% in July, preliminary estimates of wholesale merchants' sales for August were only 8.0% higher than a year earlier. This increase was also lower than the increase in cumulative sales for the first seven months of the year (12%).

All major trade groups, except food wholesalers, registered increased sales from a year earlier. The drop in sales by food wholesalers was the third year-over-year decrease in the last six months. The trade groups which had the most significant impact on the overall sales increase were machinery, equipment and supplies (15.0%), and lumber and building materials (24.3%).



... Wholesale Trade

Dealers in lumber and building materials have reported year-over-year increases in sales for 15 consecutive months. The average advance in 1985 was a moderate 4.5%, as sales declined on a year-over-year basis for the first five months of the year. Cumulative sales for January to August 1986 were up 24.4% from the same period of 1985. This increase reflects the current high level of activity in the construction industry. The value of building permits issued by Canadian municipalities, which indicates the level of building intentions, was up by approximately 25% in July 1986.

All regions posted year-over-year sales increases in August. They ranged from 11.4% in Ontario, to 3.7% in the Atlantic provinces. To date in 1986, the average of year-over-year advances in Ontario and British Columbia, the Yukon and Northwest Territories exceed those recorded in 1985. In the remaining regions of Canada wholesale trade has grown but at a slower rate than in 1985.


Bond Sales to Non-residents Nearly Double

In August, sales of outstanding Canadian securities to non-residents totalled \$3.7 billion and purchases from non-residents of \$2.9 billion resulted in a net inflow of \$863 million. Excluding April 1986, non-residents have been net purchasers of Canadian securities since February 1984.

Net sales to non-residents of outstanding Canadian bonds doubled to a record \$785 million in August. This record was largely attributable to a surge in investment from Japan. Year-to-date net investment from Japan amounted to \$2.1 billion, surpassing the amount recorded in all of 1985. A sharp rise in investment from Japan has been noted in recent years.

Net sales of outstanding Canadian stocks were \$77 million in August.

Trading in outstanding foreign securities resulted in a net sale by residents (reduction in holdings) of \$167 million in August which follows a net purchase of a similar amount in the previous month. In spite of this volatile investment pattern, residents have added, on a net basis, some \$300 million to their holdings in the first eight months of the year. Investments in overseas stocks have shown the most notable advance in 1986.

Federal Government Employment is Stable

Compared to the second quarter of 1985, general government employment remained stable in June 1986. There were 392,698 employees in departments and special funds, up slightly (0.2%) from June 1985. The rate of growth in general government employment has declined since June 1983.

The relatively small increase was due primarily growth at Statistics Canada and National Defence. he increase at Statistics Canada was the result of hiring temporary staff for the 1986 Census of Population. Without this increase, general government

employment would have decreased by 1.3%. The gain at National Defence was due to higher recruitment of military personnel under the Youth Training Program.

Employment by government enterprises dropped 1.9%, to 207,603 in June. This decrease resulted from the sale of de Havilland Aircraft and Northern Transportation Company to the private sector. In addition, lay-offs by CNR, CMHC and CBC further reduced employment. These decreases were partially offset by an increase in Petro-Canada employees which resulted from the acquisition of Gulf Canada in September 1985.
