Strong growth pushed the value of imports above exports and resulted in a merchandise trade deficit of \$421 million in October.

Sales of motor vehicles dropped 11.8% in October, offsetting a similar-sized advance in September and returning to the general downward trend evident in 1989.


New Housing Prices Still Rising

Merchandise Trade Deficit Recorded

The value of merchandise exports amounted to \$11.4 billion in October, up 0.6% from September. The level of exports has fluctuated since the start of the year but has generally followed a downward trend.


Imports jumped sharply (5.5%) following three declines in the preceding four months. Imports of machinery and equipment, which were particularly strong during the first half of the year, rallied in October after declining in September.

As a result of the more significant growth in imports, the merchandise trade balance slipped to a deficit of \$421 million, down from a surplus of \$134 million in September. The trade balance declined in the first five months of the year and was relatively stable during the summer before it resumed its downturn in the current month.

On a cumulative basis, the trade surplus amounted to \$4.0 billion for the first ten months of the year, less than half the surplus registered for the same period of 1988.

Capacity Utilization Rates Continue to Slip


Canada's manufacturing industries operated at 81.7% of capacity during the third quarter of 1989. The drop of 0.7% from the second quarter was the fourth consecutive quarterly decline in capacity utilization rates. Although the drop in the third quarter was small, it represents an acceleration in the rate of decline.

Capacity utilization rates for durable goods manufacturers dropped (-0.6%) for the fourth consecutive quarter. Following strong growth in 1987, capacity utilization rates for this sector stabilized early in 1988, before turning down in the fourth quarter.

Utilization rates for manufacturers of non-durable goods also decreased (-1.0%) in the third quarter, following a drop of 0.7% in the second quarter and marginal growth in the first quarter of 1989.

Motor Vehicle Sales Post Sharp Decline

Sales of new motor vehicles registered a sharp decrease of 11.8% in October. This decline contrasts with a significant surge in sales a month earlier. The advance in September coincided with incentive programs offered by manufacturers and contrasted with a general downward trend in motor vehicle sales in 1989. Lower sales were registered in October for both passenger cars and commercial vehicles.

Passenger car sales dropped 12.7% in October, after rising for two months. The decrease was based on a decline of 19% in North American-built car sales. Imported car sales were up following a drop in September. Imported car sales had been showing signs of weakness, but have risen twice in the last three months. Commercial vehicle sales were down 9.9%, resuming the trend of softer sales noted since the start of the year.

New Housing Prices Still Rising


The new housing price index rose 0.3% in October, continuing the rising trend that was interrupted by a minor decline in August. The house only component increased 0.3% during the month, while the land only portion advanced 0.4%. Higher land prices have been a major factor in price increases all across Canada throughout the year.

This index of Canadian housing contractors' selling prices stands 11.2% higher than a year earlier. The residential building materials price index continued to register moderate growth, rising 2.8% on a year-over-year basis.

St. Catharines-Niagara posted a large monthly increase in October, but over the year its growth rate has been similar to those registered in other Southern Ontario cities. Growth in the index for Toronto has slowed markedly since March and has been relatively stable for the last four months.

In Calgary and Edmonton, new housing prices were up by more than 1% during October, in line with increases posted in recent months. The housing market in both cities has strengthened in 1989.

New Housing and Building Material Price Indexes





Moderate Growth in Employment and Unemployment

The results of the labour force survey show moderate employment growth in November, continuing the period of marginal change noted for the last three months. Employment gains were concentrated among women, accompanied by a large increase in their labour force participation.

The rise in employment was entirely due to increased female employment. The number of employed women aged 25 and over rose by 44,000, while male employment registered a marginal decline. Part-time employment was also a major contributor to the overall advance. It rose by 25,000.

Unemployment rose 30,000, with the increase concentrated in Ontario. The unemployment rate rose 0.2 percentage points to 7.6%, the average rate recorded during the first two quarters of the year.

Farm Product Prices Advance Slightly

In October, the farm product price index (1981 = 100) was up 0.2% from the previous month, following two consecutive decreases.

The crops component was unchanged as higher cereal prices offset a continuation of declines for both oilseeds and potatoes. Improved market conditions for barley and some grades of wheat have resulted in higher initial prices offered by the Canadian Wheat Board.

The livestock and animal products component was up 0.4% in October. Generally, the livestock index has moved in a relatively narrow range since November 1987 despite substantial fluctuations in the prices of some of its component parts.





Gross Domestic Product




Gross domestic product by industry rose 0.5% in September, the largest monthly increase recorded in 1989.

Composite Leading Indicator




The composite leading indicator posted a small gain (0.2%) for the second consecutive month in September.

Consumer Price Index




The year-over-year change in the CPI was 5.1% in October, down slightly from September.
