OVERVIEW

Merchandise Trade Surplus Registered in November

As a result of a marked drop in imports and a slight increase in exports, the trade balance showed a surplus of \$679 million.

Little Change in Labour Market Conditions

The unemployment rate posted a slight increase for the third consecutive month in December, while employment and unemployment were essentially unchanged.

Relatively Steady Growth in Labour Income


Labour income was up 8.3% on a year-over-year basis in October, matching the increase in cumulative income for the first ten months of the year.

Numbers of Tourists Continue to Rise

The volume of foreign tourists was up slightly for the fourth consecutive month in November.

The farm product price index rose for the second consecutive month in November, following declines in August and September.


Merchandise Trade Surplus Registered in November

The seasonally adjusted value of exports edged up 0.5% to \$11.5 billion in November, rising for the second consecutive month. However, these two increases did not offset a decline of 3.0% in September. Exports have remained within a narrow range for the last six months.

Sharp increases in exports of wheat, cars and aircraft contributed most of the growth in November. Starting in the first quarter, wheat exports had dropped significantly, but recovered in recent months. Exports of cars rebounded sharply in November to reach their highest level in the last eight months.

Imports totalled \$10.8 billion in November, down nearly \$1.0 billion from October. This was the largest monthly decline posted since July 1988. The drop of 8.3% followed a gain of 5.6% in October and was the fourth decline in six months.

The slump in imports was mainly attributable to the drop of almost \$500 million in imports of automotive products, particularly motor vehicle parts and cars. In addition, imports of machinery and equipment fell considerably following strong growth in October, and are now closer to the levels registered in preceding months.

As a result of the marked drop in imports and the slight increase in exports, the trade balance showed a surplus of \$679 million. This was a definite reversal from the \$356 million deficit observed in October. The trade balance has been under \$600 million a month since June.

Little Change in Labour Market Conditions


The results of the labour force survey show little overall change in the labour market in December. The unemployment rate reached 7.7%, posting a slight increase for the third consecutive month. Employment edged down for the third time in four months, while unemployment rose marginally for the third month in a row.

The decrease in employment was primarily concentrated in Quebec where employment levels were down by 18,000. The rise in unemployment occurred in Ontario and Quebec. No other provinces registered significant changes in employment or unemployment.

Over the year, employment rose moderately (2.0%) following strong gains in 1988. Much of the growth occurred in female employment levels. The 1989 annual averages also show that full-time employment advanced by 2.3% while part-time

employment showed little change. The growth was also concentrated in the 25 years and over age group. Employment for persons 15 to 24 years declined slightly from 1988.

Provinces on the two coasts registered the strongest gains in employment. The average annual employment level was up 5.7% in British Columbia and 4.0% in Newfoundland. The unemployment rate was basically unchanged in Central Canada, although Ontario did show a marginal gain in employment (1.8%).

Relatively Steady Growth in Labour Income

Labour income was estimated to be \$30.2 billion in October, up 8.3% from the same month a year earlier. This growth rate matched the increase in cumulative labour income for the first ten months of the year (8.3%).

The seasonally adjusted estimate of wages and salaries, which accounts for 90% of labour income, was up 0.9% in October, slightly higher than the average monthly advance of 0.7% recorded in the preceding nine months. The monthly increase in September was unusually small due to strike activity in education and related services, health and welfare services and provincial administration in Quebec, as well as smaller than usual amounts of special payments.

Numbers of Tourists Continue to Rise

The seasonally adjusted volume of foreign travellers to Canada staying for one or more nights rose for the fourth consecutive month in November. The number of international tourists had followed a downturn from January to June.

Trips of one or more nights by Canadian residents to the United States continued to follow a rising trend in November. Travel to all other over-


Farm Product Prices Advance Slightly

In November, the farm product price index (1981 = 100) was up 0.3% from the previous month, the second consecutive increase following two declines.

The crops component rose 1.1%, the first significant advance since May. Both oilseed and potato prices improved after several months of sharp declines. Cereal prices continued to strengthen during the month.


The livestock and animal products component was down 0.3% in November. Generally, the livestock index has moved in a relatively narrow range since November 1987 despite substantial fluctuations in the prices of some of its component parts.


