OVERVIEW

Little Change in Labour Market Conditions

The unemployment rate was down slightly to 7.7% in February, returning to the level registered in November and December.

■ Growth of Wages and Salaries Moderates

Wages and salaries rose 0.4% in December, the fifth month of generally slower growth.

■ Motor Vehicle Sales Rise Sharply

The jump in new motor vehicle sales in January was in line with the trend of fluctuating sales levels, but contrasts with the downward trend evident in 1989.

■ Slight Acceleration in Growth of New House Prices

The new housing price index rose 0.5% in January, marginally higher than the increases posted in recent months.

Continuing Advance in Farm Product Prices

The farm product price index was up 0.5% in January, maintaining the upward trend observed in the previous four months.

Number of Tourists Resumes Upward Trend

In January, the number of tourists to Canada resumed the rising trend observed from August to November.

Little Change in Labour Market Conditions

The results of the February labour force survey show little overall change in labour market conditions. The unemployment rate edged down to 7.7%. The unemployment rate has changed very little in the last four months. Employment showed modest growth, while unemployment decreased slightly for the first time since September.


Employment was up by 22,000 in February, the second month in a row of growth. The gains were concentrated among persons 25 years of age and over. Employment for persons aged 15 to 24 declined slightly, extending a downward trend noted in recent months. The downturn has affected young men in particular.

Full-time employment showed a notable increase for the second consecutive month after registering a decline in the last quarter of 1989. The



February increase was concentrated among women. Part-time employment, on the other hand, was unchanged as a decline among women was offset by a gain for men.

The level of employment rose by 27,000 in Ontario, the first significant change since October 1989. In British Columbia, employment dropped by 18,000, the second downward movement in three months.


Growth of Wages and Salaries Moderates

Seasonally adjusted wages and salaries increased 0.4% in December over the previous month. December was the fifth month in which the growth rate of wages decelerated. The average monthly increase in 1989 was 0.8%, marginally higher than 0.7% recorded in each of the two preceding years.

Wages and salaries in education and related services posted a strong increase of 2.3% in December. This gain followed strike activity in the fall. In manufacturing, the industry group with the largest payroll, wages rose 0.2% to continue the trend of slower growth noted in the three previous months. Higher wages and salaries were also noted for commercial and personal services, the second month of stronger growth.

Motor Vehicle Sales Rise Sharply

Seasonally adjusted sales of new motor vehicles totalled 127,000 units in January, up 8.8% over December. The sharp rise following a decrease in December was in line with fluctuating sales levels in recent months, but contrasted with the general downward trend in sales evident in 1989. The January increase in sales was mainly attributable to incentives and cut-rate financing on selected models during the month.

Higher sales were posted for both commercial vehicles and passenger cars. Commercial vehicle sales were up 18.2%, contrasting with the trend to softer sales noted in 1989. Car sales rose for the third consecutive month. Other than these increases, car sales have declined for the last two years, with the rate of decline accelerating in 1989.

The increase in car sales was due to a large jump in sales of cars manufactured overseas. Imported car

sales were essentially flat in 1989. Sales of cars built in North America (which includes production of domestic and foreign-owned companies) were down slightly from December, continuing the downward trend evident throughout 1989.

Slight Acceleration in Growth of New House Prices

The new housing price index rose 0.5% in January, slightly higher than the monthly increases posted in recent months. Housing prices escalated throughout 1989, but increases were generally more moderate in the last half of the year. Alberta and British Columbia have recently been a major source of upward pressure on the index.

In Calgary and Edmonton, new housing prices were up by more than 1% during January, in line with increases posted in recent months. The housing market in both cities strengthened noticeably in 1989. The monthly advances in British Columbia were even larger: 5.2% in Victoria and 3.2% in Vancouver. The index for Vancouver indicated sharply rising prices throughout 1989 and surpassed its 1981 reference level.

Cities in Southern Ontario continued to post more moderate gains in January. Most cities registered increases lower than the advance at the national level.


Rising Trend in Farm Product Prices Maintained

In January, the farm product price index (1981 = 100) was up 0.5% over the previous month, the fourth consecutive increase. The index had dropped sharply in August when the Canadian Wheat Board initial prices for the 1989-90 crop year came into effect. The advance in January was due to higher prices for crops.

The crops component rose 4.4%, the most significant monthly advance since August 1988. Prices for cereals, oilseeds and potatoes all rose in January. Potato prices continued to escalate as stocks reached their lowest level since January 1984

The livestock and animal products component was down 2.0% in January. This decline runs counter to the trend of higher prices evident throughout 1989.

Number of Tourists Resumes Upward Trend

The seasonally adjusted volume of foreign travellers staying in Canada for one or more nights increased in January, resuming the rising trend observed from August to November. Despite these increases, the number of international tourists has yet to reach the levels recorded prior to a downturn from January to June 1989.

Trips of one or more nights by Canadian residents to the United States increased following a

sharp decline in December. The growth of 7.6% was slightly higher than the strong gains posted in preceding months. Travel to overseas countries was down after a five-month upturn. The volume of trips lasting less than 24 hours resumed the rising trend that had been interrupted in December.



Real gross domestic product increased by a moderate 0.5% in the fourth quarter of 1989, while the implicit price index rose 0.9%.




The composite leading indicator rose for the fourth consecutive month in December.

Consumer Price Index




In January, the CPI posted a year-over-year rise of 5.5%, up noticeably from 5.1% in December.

Unemployment Rate and Employment




The unemployment rate was down slightly to 7.7% in February, returning to the level registered in November and December.
