# **Exports and Imports Decline**

In August, merchandise exports fell 4.2% from July, registering a second straight drop. Imports fell 2.2% to \$11.1 billion.

# Farm Product Price Index Drops Sharply

The Farm Product Price Index fell 4.7% in August, a second consecutive decline.

# **Exports and Imports Decline**


In August, merchandise exports declined 4.2% to \$12.0 billion, a second consecutive decline. The drop was largely the result of a downturn in exports of passenger automobiles and chassis (-32%), which offset increases in the previous two months. A 29% decline in exports of aircraft also contributed to the overall drop.

Merchandise imports fell \$249 million to \$11.1 billion. Imports of machinery and equipment fell sharply for the second time in three months, this time by 8.5%. Imports of automotive parts also fell, but imports of passenger cars rose, resulting in an overall drop of \$52 million in the automobile products sector.

The merchandise trade surplus was \$960 million in August, \$278 million lower than the surplus registered in July. The decline, however, was less than half of the drop posted in July.

Moreover, the \$7.2 billion surplus posted for the first eight months of 1990 was much higher than the surplus for the corresponding period in 1989 (\$5.2 billion).

# Farm Product Price Index Drops Sharply

The Farm Product Price Index fell 4.7% in August. Large declines in Saskatchewan, Manitoba and Alberta more than offset smaller gains in the Atlantic provinces.


The crops index fell 11.2%, after a slight decline in July. The cereals component fell 16.1% to its lowest level since March 1988, mainly because of falling prices for wheat, oats and barley. The oilseeds component fell 6.8%, a third consecutive decline. The potatoes component dropped 4.4%, continuing the generally declining trend evident in the previous four months.

The livestock and animal products index fell slightly, mainly due to a 4.7% decline in the price of pork. The cattle and calf component rose 1.1% and the eggs component rose 2.6%.

# Number of Foreign Visitors Rebounds

In August, the seasonally adjusted number of foreign overnight travellers to Canada rose 2.8% over the previous month, following a loss of 3.1% in July. These changes were largely the result of movements in the number of travellers from the United States. The volume of overnight travel to Canada from other countries declined slightly after a large drop in July, continuing the generally declining trend evident since February.

Same-day trips by Canadians to the United States increased slightly (0.5%), contributing to a cumulative gain of 7.5% since May. Same-day trips to Canada by United States visitors rose 2.2%, after generally declining since January.

An increase in overnight trips by Canadians to the United States (1.5%) contributed to a cumulative increase of 6.6% since May. Tourism by Canadians to other countries fell 1.8% after three strong increases.

## Canadian Economic Observer

The October 1990 issue of the Canadian Economic Observer includes an article on the pattern of quits and layoffs in the Canadian economy, particularly in recessions.

The research needed for this article was made possible by a new data source developed by Statistics Canada from information provided by Employment and Immigration and from Labour Force Survey data. Here are a few of the article's highlights:

- The turnover rate for the economy has been generally stable since 1978, except during the 1982 recession when a 42% drop in quits more than offset a 31% increase in permanent layoffs, resulting in a lower permanent separations rate.
- Labour mobility declined in the 1982 recession, as hiring fell about 50% and more workers stayed with their firm, despite layoffs.
- Quits and layoffs vary considerably by industry. Goods industries have more temporary layoffs than services industries. Permanent separations are highest in the primary

and construction industries, while quit rates are highest in the low-wage consumer services.
