OVERVIEW

New Housing Prices Post Small Gain

In March, the New Housing Price Index (1986 = 100) increased 0.3% from a year ago, its lowest rate of change since October 1992.

Dual-earner Families Edge Down

In 1992, the number of two-earner families represented 60.8% of all husband-wife families, continuing a slight decline since 1989.

Unemployment Rises in April

The unemployment rate rose to 11.0% in April, due to a sharp increase in the number of adults entering the labour force but in search of work.

Farm Product Prices Up in March

The Farm Product Price Index (1986 = 100) rose to 107.6 in March, up 1.9% from February's level.

New Housing Prices Post Small Gain

The New Housing Price Index (1986 = 100) recorded a slight increase (+0.1%) from February's level. At 136.1, the index stood 0.3% higher than a year ago, the lowest year-over-year rate of change since October 1992.

Of the 20 urban areas for which the index is calculated, eight registered increases, seven remained unchanged and five posted declines. According to the builders in the cities which registered price increases, the upward price movement was caused by higher material costs, lumber in particular.

Winnipeg (+1.6%), Calgary (+0.6%) and Hamilton (+0.5%) posted the largest gains in March, while significant monthly declines were recorded in St. Catharines-Niagara (-0.8%), Vancouver (-0.5%), St. John's (-0.4%) and Ottawa-Hull (-0.2%).

The House Only Index edged down to 125.4, 0.1% below the previous period, but remained unchanged from March 1993. The Land Only Index posted a slight increase of 0.1% from February to a level of 169.3 in March and was up 1.0% from a year ago.

Dual-earner Families Edge Down

In 1992, the proportion of families where both spouses reported income from employment edged down for the third consecutive year, to 60.8%.


The proportion of families with only one spouse earning has changed slightly over the last four years; the proportion of husband single-earner families continued to decline; and that of wife single-earner families continued to climb. In families in which neither spouse earned income, the results show a continuing slow upward trend, reflecting the aging of the population and an increasing tendency for early retirement.

The incomes of single-earner families fell by 4.8% to \$47,817 in 1992, compared to \$50,213 in 1991. Two-earner families' incomes increased slightly to \$67,352, compared to \$66,087 in 1991 and

families in which neither spouse earned income also recorded a small gain to \$34,185, compared to \$32,941 in 1991.

Ontario's dual-earner families recorded the largest income in 1992, followed by those in British Columbia. Ontario and British Columbia again ranked first in single-family earners' incomes at \$51,722 and \$48,199, respectively.

The earnings of the husband in dual-earner families accounted for 55.1% of the total family income in 1992 and the wife's earnings contributed 30.7%. The remainder of family income (14.2%) came from other family members' earnings, investment income, transfer payments and pensions.

Unemployment Rises in April


The unemployment rate rose 0.4 percentage points to 11.0% in April, following a decrease of 0.5 percentage points in March. In April, there were 65,000 more persons looking for work, due mainly to an increase of 70,000 adults in the labour force. The participation rate rose 0.3 to 65.1%, the first increase in 1994.

The level of employment was little changed in April, following strong employment growth in February and March. Since April 1992, employment for adults aged 25 and over has been increasing, gaining 432,000 (+4.2%). Employment decreased by 17,000 in April for youths aged 15 to 24. Over the past two years, employment among youths has fallen by 81,000 (-4.0%).

In the manufacturing sector, employment remained unchanged in April, following gains which totalled 74,000 in February and March. Employment increased in the construction sector (+23,000) and in transportation, communications and other utilities (+19,000). However, employment declined by 19,000 in trade and by 12,000 in public administration.

Employment in Manitoba recorded the largest gain in April (+7,000), up 1.4% from March. This brought the total gain over the latest three months to 10,000, offsetting January's sharp decline.





Employment edged up in Ontario (+0.3%), which brought the latest three months' gains to 49,000, offsetting the loss of 41,000 in January. The other provinces showed no significant changes.

Farm Product Prices Up in March

The Farm Product Price Index (1986=100) rose to 107.6 in March, up 1.9% from February's level. The index rose 0.9% above its year-earlier level, following three months of year-over-year decreases.

The crops index increased 5.4% in March to 96.4. The cereals index contributed mainly to this increase, reaching 76.7, an 8.9% increase over February. The index was 19.6% below its year-earlier level. The oilseeds index rose 3.8% to 139.7, reaching the highest level since September 1988. Soybeans, flaxseeds and canola prices all rose in most provinces. The potatoes index increased 4.2% to 172.6 and stood 80.9% above the previous year's level.

The livestock and animal products index rose 0.3% to 114.5, in March. Since September 1992, the index has been above year-earlier levels. The cattle and calves index increased 2.3% in March to 124.3, recording higher price levels since the beginning of 1993. The index stood 4.9% above the year-earlier level. The hogs index dropped 3.4% in March to 93.7, but stood 12.9% above the level recorded a year ago.

Census tracts are presented in numerical order within each centre. Data for the component census subdivisions are also shown.






CURRENT TRENDS



Real gross domestic product at factor cost crept up 0.1% in February, the same rate of increase reported in January.




The leading indicator continued to advance in March, rising by 0.7% from February. This increase follows a revised monthly gain of 0.9% in February — a 29-month high.




In March, the year-over-year change in the all-items CPI was 0.2%, the same rate of increase reported in February. The food index rose by 0.1%.



In April, the unemployment rate rose 0.4 percentage points to 11.0%. The increase was due to a growth in the number of adults entering the labour force in search of work.



Canadian manufacturers' shipments fell 0.3% in February to \$26.1 billion. The level of unfilled orders rose 0.8% to \$25.5 billion.



In February, the value of merchandise exports fell by 1.5% to \$15.4 billion, while imports remained virtually unchanged at \$14.7 billion.
