External Trade: Canadian commodity imports during June rose 4.6% to \$941,343,000 from \$900,909,000 in the 1966 month. During the January-June period imports increased 14.2% to \$5,475,308,000 from \$4,794,222,000. Corresponding 1965 totals were \$794,692,000 for the month and \$4,070,187,000 for the six-month period. (Page 2)

Toll Facilities: Twelve bridges, one tunnel and seven ferries functioning as toll facilities for vehicles and pedestrians between Canada and the United States had a net income of \$4,391,948 in 1966.

Manufacturing: Production of lumber by sawmills east of the Rockies increased to 303,795,000 feet board measure in August from 279,701,000 in the 1966 month. Production of lumber and ties in coast and interior mills of British Columbia dropped to 659,900,000 feet board measure in August. Plywood shipments rose 23% to 223,357,000 square feet in August. Rubber consumption during July increased 16.9% to 28,687,000 pounds from 24,540,000 in the 1966 month. Steel ingot production during the week ending October 21 totalled 198,162 tons. (Page 3)

Transportation: Twenty-three common carrier railways in Canada reported operating revenues of \$125,262,186 for July, 6.1% above those of the previous year. Railway operating expenses rose 8.1% resulting in an operating profit of \$1,826,926. (Page 7)

Household Facilities: Proportions of Canada's households with electrical and other modern conveniences are continuing to increase in 1967 according to advance information which will be contained in the annual Dominion Bureau of Statistics report, "Household Facilities and Equipment". (Page 7)

Prices: In 31 manufacturing industries, industry selling price indexes(1956=100) were higher in September, 7 more than the 24 increases recorded in the July-August period. The general wholesale index (1935-39=100) moved up slightly in September to 264.7 from the August index of 264.6 and was 1.5% higher than the September 1966 index of 260.7.

Business: Value of cheques cashed in 51 clearing centres in July totalled \$45,088,495,000, 4.9% above last year's corresponding total of \$42,987,017,000. Cheques cleared during the January-July period at \$339,189,814,000 were 11.7% over the 1966 period. (Page 10)

Merchandising: Department store sales during September rose 7.3% over the corresponding 1966 month and during the week ending October 7 were up 9.7% over the same week last year. (Page 10)

Construction: Building permits for 16,573 units were issued during July, a rise over the July 1966 total of 11,327. (Page 10)

5. Commodity Imports Canadian commodity imports during June rose 4.6% to \$941,343,000 from \$900,909,000 in the 1966 month and during the January-June period increased 14.2% to \$5,475,308,000 from \$4,794,222,000. Corresponding 1965 totals were \$794,692,000 for the month and \$4,070,187,000 for the January-June period.

United States provided goods in greatest quantity during the month followed by the United Kingdom, Japan, Federal Republic of Germany, Venezuela, France Italy, Australia, Netherlands Antilles and the Netherlands. Commodities in greatest demand included motor vehicle parts, except engines, new closed sedans, coal, crude petroleum, trucks, truck tractors, and chassis, motor vehicle engines, fuel oil, new wheel tractors, electronic computers, combine reaper-threshers.

6. International Toll Bridges, Tunnels and Ferries Twelve bridges, one tunnel and seven ferries functioning as toll facilities for vehicles and pedestrians between Canada and the United States had a net income of \$4,391,948 in 1966. Operating revenues totalled \$16,135,316 and operating expenses, \$7,950,423. Employees numbering 812 received

Comparable 1965 figures for 21 facilities show net income totalling \$4,554,391 with operating revenues amounting to \$15,306,178 and operating expenses, \$7,319,972. Employees numbering 736 received salaries totalling \$3,179,907.

*3. Canadian Labour Force Decreasing importance of the primary occupations for the male Canadian labour force over the 1951-1961 decade was much greater for the younger than for the older age groups. The proportion of the male labour force in these occupations was reduced from 23 to 13% for 20 to 24 year olds but only from 35 to 32% for those 65 and over. For younger males the proportions in white-collar occupations, especially "Professional and technical" and "Clerical" increased over the decade from 21 to 29% with increases from 4 and 9% to 8 and 12% for the two groups mentioned. For 15 to 19 year old males the "Sales" and "Service and recreation occupations" groups showed the greatest increases in importance over the decade. Males past the usual retirement age (65 and over) had lower proportions in the "Craftsmen, production process and related workers" group in 1961 than in 1951(21% in 1961 and 28% in 1951) and a larger percentage in "Service and recreation occupations" (13% in 1961 and 10% in 1951). In the middle age groups the shifts were less dramatic with the general drop in the proportions in "Primary" occupations resulting in increases in the percentages in white-collar (especially for 25 to 34 year old males the "Professional and technical" group) and "Service and recreation occupations".

Distribution of the married female labour force of 1961 (much greater in size than in 1951) showed greater percentages of these females in white-collar (especially "Clerical" and "Professional and technical") occupations and smaller proportions in the "Craftsmen" group than in 1951. Proportions in white-collar occupations increased from 49 to 53% with an increase from 23 to 27% for the "Clerical" portion and from 9 to 12% for the "Professional and technical" portion. About 19% of the married female labour force were reported as "Craftsmen" in 1951 as contrasted with only 13% in 1961. For single females, in contrast, although there was a drop in the percentage found in the "Craftsmen" group from 15 to 11% the "Clerical" group increased only marginally in importance. However, the percentage of single women reporting "Professional and technical" occupations increased from 18 to 21% reflecting in part the greater importance of these occupations for the 20 to 24 year old age group of women who formed a significant portion of the single female labour force. For all 20 to 24 year old females in the labour force the proportion reporting "Professional and technical" occupations increased from 16 to 22%.

These and other aspects of the changes in the occupational structure of the labour force as revealed by Census statistics are reviewed in report 7.1-12 "The Canadian Labour Force" of the General Review Volume of the 1961 Census, Catalogue No. 99-522, released recently. In addition to the material on trends this report also contains analytical material on various features of the labour force as found in the 1961 Census, including previously unpublished data on the industrial distribution of occupation groups for regions.

*4. Industry & Production Notes, 1966

The following summarized statistics for the rubber footwear manufacturers industry will appear later in detail in a regular publication of the Manufacturing and Primary Industries Division. Concepts and definitions employed together with an account of recent changes will also be included in the report.

Rubber Footwear Manufacturers (Cat. 32-206): Factory shipments from the rubber footwear manufacturers industry increased in 1966 to \$43,234,000 from \$43,228,000 in 1965. Cost of materials, fuel and electricity rose in the year to \$16,959,000 from \$15,780,000 in the preceding year and value added by manufacturing activity (value of production less value of materials, fuel and electricity) to \$27,319,000 from \$27,061,000. Industry added (manufacturing plus non-manufacturing activity) advanced from \$28,869,000 to \$29,012,000.

Seven establishments (7 in 1965)reported 4,810 employees (4,876), including 3,967 directly employed in manufacturing operations(4,035). Salaries and wages for all employees aggregated \$17,594,000 (\$16,902,000) with manufacturing employees accounting for \$13,160,000 (\$12,770,000). Paid man-hours in manufacturing operations numbered 7,677,000 versus 8,022,000 the previous year.

^{*1.} Veneers and Plywoods Plywood shipments during August rose 23% to 223,357,000 square feet from 181,476,000 in the 1966 month and veneer shipments dropped 8% to 143,525,000 square feet from 155,740,000 according to advance information which will be included in the Dominion Bureau of Statistics report, "Peeler Logs, Veneers and Plywoods". End-of-August stocks of veneers were up 41% to 193,923,000 square feet from 137,828,000 and stocks of plywoods were up17% to 172,607,000 square feet from 147,327,000.

^{4.} Rubber Consumption Consumption of rubber during July rose 16.9% to 28,687,000 pounds from 24,540,000 in the 1966 month. Stocks on hand at the end of July totalled 19,797,000 pounds compared with 23,034,000 in the same period last year.

Concrete Products Production of specified concrete products during August was as follows: concrete bricks, 8,860,542 (9,484,060 in the 1966 month); concrete blocks, except chimney blocks, 20,501,274 (20,787,172); concrete drain pipe, sewer pipe, water pipe and culvert tile, 120,539 tons (128,697); ready-mixed concrete, 1,361,565 cubic yards (1,635,380).
- 1. Cement Shipments during August dropped 12.3% to 939,548 tons from 1,071,738 in the 1966 month. Stocks on hand at the end of the month totalled 950,669 tons this year against 782,107 in the 1966 month. Shipments during the eight-month period dropped to 5,087,928 tons this year from 5,874,805.
- 7. Asphalt Roofing Shipments of asphalt roofing during August totalled 461,847 roof squares, up from the August 1966total of 401,225. During the eight month period shipments increased to 2,474,386 roof squares this year from 2,101,631.
- 5. Salt Shipments of dry salt and salt content of brine totalled 401,004 tons during August and 3,224,676 in the January-August period. Producers' stocks at the end of August totalled 434,623 tons.
- *2. Steel Ingots Steel ingot production during the week ending October 21 totalled 198,162 tons, a 5.6% increase over the preceding week's total of 187,644. Output during the comparable week of 1966 was 187,097 tons. The index of production, based on the average weekly output during 1957-1959 of 96,108 equalling 100, was 206 in the current week, 195 a week earlier and 195 one year ago.

*8. Railway Operating Statistics Twenty-three common carrier railways in Canada reported operating revenues of

\$125,262,186 for July, 6.1 per cent above those of the previous year, according to an advance release of data that will be contained in the July issue of the D.B.S. report, "Railway Operating Statistics". Railway operating expenses rose 8.1 per cent during July, resulting in an operating profit of \$1,826,926 compared to one of \$3,867,068 in July 1966.

A total of 20,357,705 tons of revenue freight was handled by the railways during July, up 8.7 per cent from the 1966 month, while ton-miles increased 2.2 per cent to 8,092,550. Average miles of road operated (first main track) fell from 43,987 to 43,907. Passengers carried at 2,068,208 were up 4.4 per cent from July 1966. Commuter movements registered a 4.3 per cent increase and non-commuter traffic rose 4.5 per cent.

HOUSEHOLD FACILITIES

*1. Household Facilities and Equipment Proportions of Canada's households with electrical and other modern conveniences are continuing to increase in 1967 according to advance information which will be contained in the annual Dominion Bureau of Statistics report, "Household Facilities and Equipment".

Electricity is used for cooking in 73.0% of Canadian homes this year compared with 70.7% in 1966 while home freezers are found in 27.8% against 24.8% last year. Automatic washing machines are used in 30.0% of Canadian households, up from 1966's 25.6% while other electric washing machines are used in 55.2% a decline from last year's 59.5%. Clothes dryers are found in 34.5% of all household this year as compared to 30.1% in 1966.

F.M. radio receivers are found in 34.3% of all household this year as compared to 28.4% last year while phonograph record players are found in 64.4% against 61.2%. One or more automobiles are owned by 75.8% of all households, an increase from last year's 75.1%, while two are owned by 15.0%, a rise from 1966's 14.1%.

*8. Industry Selling Price Indexes In 31 manufacturing industries, industry selling price indexes (1956 = 100) were higher in September, 7 more than the 24 increases recorded in the July-August period. Industry indexes which declined numbered 19 in September, 1 more than the 18 decreases recorded in the previous month. Of the 102 industry indexes, 52 remained the same in September, 8 less than in August when 60 were unchanged. The average level of the 102 industry indexes rose slightly to 115.4 from the August average of 115.3. The median moved lower to 114.9 from the August median of 115.1.

9. General Wholesale Index The general wholesale index (1935 - 39 = 100) moved up slightly in September to 264.7 from the August index of 264.6, and was 1.5% higher than the September 1966 index of 260.7. Five of

the eight major group indexes increased while three declined.

Non-ferrous metals products group index rose 1.9% in September to 244.6 from the August index of 240.0 in response to higher prices for nickel. The chemical products group index moved up 0.7% to 213.8 from 212.3 reflecting price increases for paint and paint materials, and organic chemicals. An advance of 0.4% to 295.4 from 294.1 occurred in the animal products group index as a result of price increases for fishery products, livestock, fresh meats and milk. The wood products group index rose 0.4% to 349.3 from 348.0 on higher prices for cedar, and pine lumber. An increase of 0.1% occurred in the iron products group index to 274.3 from 273.9.

The vegetable products group index moved 1.4% lower in September to 228.0 from the August index of 231.2 on price decreases for grains, potatoes, and milled cereal foods. A decline of 0.5% in the textile products group index to 251.6 from 252.9 reflected lower prices for cotton fabrics, domestic and imported raw wool, and worsted and wool cloth. The non-metallic minerals products group index moved down slightly to 200.0 from 200.1.

9. Cheques Value of cheques cashed in 51 clearing centres in July totalled \$45,088,495,000, 4.9% above last year's corresponding total of \$42,987,017,000. Clearings in the Atlantic Provinces were up 14.8%; British Columbia, 5.2%; Prairie Provinces, 5.0%; Ontario, 4.6%; and Quebec, 4.4%. Value of cheques cleared during the January-July period at \$339,189,814,000 was 11.7% higher than last year's \$303,633,628,000 total.

MERCHANDISING

- 7. Department Store Sales Department store sales during September rose 7.3% over the corresponding 1966 month with regional changes as follows: Atlantic Provinces, +4.5%; Quebec, -0.5%; Ontario, +7.4%; Manitoba, +6.9%; Saskatchewan, +9.7%; Alberta, +16.2%; British Columbia, +9.7%.
- Radio and Television Sets Sales of domestic radio receiving sets during July totalled 61,042 units and during the January-July period numbered 729,011 units. Total sales of television receiving sets numbered 34,147 during the month and 298,548 during the seven-month period.
- 2. Department store Sales Department store sales by regions in the week ending October 7 were up 9.7% over the same week last year with regional changes as follows: Atlantic Provinces, +5.1%; Quebec, -0.4%; Ontario, +10.2%; Manitoba, +1.3%; Saskatchewan, +5.4%; Alberta, +19.8%; British Columbia, +20.4%.
- 6. Paints, Varnishes and Lacquers Sales of paints, varnishes and lacquers totalled \$18,357,648 in August, a rise from the 1966 month total of \$17,115,547. During the January-August period sales increased to \$137,810,707 this year from \$131,393,520 last year.

CONSTRUCTION

1. Building Permits Building permits for 16,573 units were issued during July, a rise over the July 1966 total of 11,327. Value of residential and non-residential construction during the month totalled \$344,203,000, up from the 1966 month total of \$332,509,000. During the seven-month period permits increased to 97,008 from 75,776 last year and the value of residential and non-residential construction was up to \$2,236,571,000 from \$2,094,930,000.

- *1. Tobacco Consumption Production of tobacco products during September as indicated by the sale of excise duty stamps showed a 10.7% decline in cigarette consumption to 3,848,156,175 from 4,308,164,270 in September 1966 while cigar consumption rose 12% to 42,086,085 from 37,544,835. Other tobacco products entered for consumption were as follows: cut tobacco, 1,313,151 pounds (1,552,444 in September 1966); plug tobacco, 52,935 pounds (80,305) snuff, 82,056 pounds (78,033) and Canadian raw leaf tobacco, 53,830 pounds (64,600). Cigarettes released for export during the month numbered 26,735,200 and for ships' stores, 13,105,000.
- 2. Farm Wages Averages wages of male farm help per hour as of August 15 in Canada (excluding Newfoundland) were \$1.18 with board and \$1.38 without board. Corresponding 1966 hourly wages were \$1.10 with board and \$1.27 without board.
- Fluid Milk Sales Sales of standard, special and two per cent milk, excluding skim milk, buttermilk and chocolate drink, totalled 130,104,000 quarts in August, 3% higher than the corresponding 1966 total and during the January-August period totalled 1,030,290,000 quarts, 1% higher than that of last year.
- *4. Process Cheese Production of cheddar base and other hard or cream cheese base during September totalled 8,754,209 pounds, up 24.1% from September 1966's total of 7,055,561. During the nine-month period output rose 6.5% to 64,618,458 pounds from 60,699,507. Stocks on hand at September totalled 5,276,242 pounds, up 26.0% from last year's 4,187,842 pounds total.

- 6. Milk Production Production of milk in September is estimated at 1,712,000,000 pounds, 1.5% below production in the corresponding month last year. This brings the total estimated production for the nine-month period to 14,213,000,000 pounds or 1.3% below that for last year's same period. Revised figures for August place the month's output at 1,882,045 pounds against 1,878,167.
- 8. Coarse Grains Total supplies of Canadian feed grains rose 9% in 1966-67 due to higher levels in production of most of the feed grains, barley, rye, corn, buckwheat and mixed grains, as well as larger carryover stocks of barley and rye.
