PROPERTY OF THE

PRELIMINARY REPORT ON COAL PRODUCTION

Coal production during June amounted to 777,000 tons making a total production of 6,463,570 tons for the first six months of the year. In comparison with the corresponding month of last year, production showed a decrease of 14.9 per cent.

Landed imports of coal during the month amounted to 2,712,680 tons, making a total of 9,269,852 tons imported during the first six months of this year. This was an increase of 6.5 per cent compared with the tonnage imported in the corresponding month of last year.

Coal exported during June amounted to 21,736 tons, as compared with 55,436 tons exported in June, 1956.
