PETROLEUM AND NATURAL GAS PRODUCTION IN CANADA, SEPTEMBER, 1935

and

GASOLINE SALES IN CANADA, AUGUST, 1935.

PETROLEUM - The Canadian production of crude petroleum in September reached a total of 123,918 barrels according to a report just issued by the Dominion Bureau of Statistics at Ottawa. In August, 117,652 barrels were produced while in September, a year ago, the output was 115,011 barrels. During the nine months ending September Canada produced 1,074,723 barrels of crude petroleum as compared with 1,070,517 barrels in the corresponding period of 1934.

Alberta's output in September totalled 109,143 barrels consisting of 104,063 barrels of crude naphtha and 1,379 barrels of light crude oil from the Turner Valley field, 1,689 barrels of light crude oil from the Red Coulee field, 1,776 barrels of heavy crude oil from the Wainwright field and 236 barrels of heavy crude oil from the Skiff field.

Petroleum and its products exported from Canada in September were valued at \$125,125, an advance of 251.2 per cent over the preceding month's import valuation.

Canada imported petroleum, asphalt and their products to a value of \$4,766,804 in September as against the August total of \$4,518,707. The September imports were obtained from the following sources: the United States, 76.8 per cent; Peru, 8.8 per cent; Colombia, 8.3 per cent; Dutch West Indies, 2.6 per cent; Venezuela, 2.3 per cent, and Roumania, India, Great Britain, Alaska, Germany, Belgium, France, Sweden and Japan, the remainder. Receipts of crude petroleum during September totalled 127,017,748 gallons, made up of 97,998,459 gallons from the United States, 14,813,757 gallons from Colombia, 7,535,976 gallons from Venezuela, and 6,669,556 gallons from Peru.



NATURAL GAS - Natural gas production from Canadian wells during September amounted to 1,070,777 thousand cubic feet; in August 928,263 thousand cubic feet were produced while in September, 1934, the output was 1,244,683 thousand cubic feet. The Canadian production during the nine months ending September totalled 15,597,345 thousand cubic feet as against 17,033,804 thousand cubic feet in the corresponding period of 1934.

Imports of mixed gas (natural and artificial) into Canada during September rose to 14,370 thousand cubic feet worth \$9,205 from the August total of 11,626 thousand cubic feet at \$7,495.


