## MONTHLY REPORT

## PETROLEUM AND NATURAL GAS PRODUCTION AND GASOLINE SALES IN CANADA - AUGUST, 1936.

<u>CRUDE PETROLEUM</u> - The Dominion Bureau of Statistics at Ottawa reports that the Canadian output of crude petroleum in August amounted to 139,789 barrels as compared with 139,940 barrels in July and 121,517 barrels in August, 1935. During the eight months ending August, 962,807 barrels were produced in Canada; in the corresponding months of 1935 the output was 957,275 barrels.

Production from Alberta sources advanced to 124,287 barrels from the July total of 122,771 barrels. The August output was made up of 120,644 barrels from the Turner Valley field, 1928 barrels from the Red Coulee field and 1,715 barrels from the Wainwright field.

The Canadian exports of petroleum and its products in August were valued at \$332,972 as against the July export valuation of \$63,759.

Canada imported petroleum, asphalt and their products to a value of \$5,536,291 in August; during the preceding month the imports were appraised at \$4,805,663. The August importations were obtained from the following countries: the United States, 75.8 per cent; Peru, 13.4 per cent; Colombia, 9.0 per cent; Venezuela, 1.1 per cent and India, Germany, Great Britain, Roumania, Switzerland, Belgium, the Netherlands, Alaska, Norway, France and Trinidad, the remainder. Crude petroleum importations into Canada in August included 104,768,639 gallons from the United States, 20,975,875 gallons from Peru, 18,301,641 gallons from Colombia and 3,787,891 gallons from Venezuela.




**MATURAL GAS** - The Canadian production of natural gas in August was recorded at 1,140,433 thousand cubic feet; the July output amounted to 1,210,414 thousand cubic feet. Production during August, 1935, totalled 1,054,043 thousand cubic feet. During the eight months ending August the Canadian output aggregated 18,159,602 thousand cubic feet or 10.7 per cent above the total for the corresponding period of 1935.

Customs' records show that Canada imported 9,729 thousand cubic feet of mixed gas (natural and artificial) worth \$5,837 as compared with 10,720 thousand cubic feet at \$7,383 imported in July.
