



Highlights

August 1988

The production of crude petroleum and equivalent hydrocarbons during August 1988 amounted to 8 622.8 thousand cubic metres compared to 8 460.5 thousand cubic metres in August 1987, an increase of 1.9%.

The disposition of crude and equivalent for August 1988 is as follows: 7 404.8 thousand cubic metres (69.7%) were sent to Canadian refineries and 3 468.6 thousand cubic metres (32.7%) were exported. The 2.4% difference between supply and sales is accounted for by inventory change, industry own use, etc. Imported crude for the same period amounted to 1 998.7 thousand cubic metres, a decrease of 14.7% over August 1987.

Natural gas net new production increased 13.7% to 9 791.8 million cubic metres from 8 611.3 million cubic metres in August 1987. Marketable production for August 1988 amounted to 6 760.5 million cubic metres, an increase of 18.3%.

The disposition of natural gas for August 1988 is as follows: 2 694.0 million cubic metres were net deliveries to storage and injection operations; 1 549.0 million cubic metres were used and unaccounted for in fields and processing plants; 2 627.5 million cubic metres were exported; 2 620.7 million cubic metres which include direct sales were sold to ultimate customers in Canada. The remaining difference of 300.6 million cubic metres between production and disposition was accounted for by other deliveries, pipeline fuel, losses and line pack fluctuations.

Note to Data Users

Table 1 data for Northwest Territories includes all offshore (Arctic and Atlantic) production and disposition.

Faits saillants

Août 1988

En août 1988, la production de pétrole brut et d'hydrocarbures équivalents s'est chiffrée à 8 622.8 milliers de mètres cubes comparativement à 8 460.5 milliers de mètres cubes en août 1987, soit une augmentation de 1.9%.

L'utilisation de pétrole brut et d'équivalents au cours du mois d'août 1988 se répartit de la manière suivante: 7 404.8 milliers de mètres cubes (69.7%) destinés aux raffineries canadiennes et 3 468.6 milliers de mètres cubes (32.7%) destinés à l'exportation. La différence de 2.4% entre l'approvisionnement et l'utilisation provient des variations des stocks, de la consommation par l'industrie pétrolière, etc. Les importations de pétrole brut se sont élevées, au cours de la même période, à 1 998.7 milliers de mètres cubes, soit une baisse de 14.7%.

La production originale nette de gaz naturel a augmenté de 13.7% passant de 8 611.3 millions de mètres cubes en août 1987 à 9 791.8 millions de mètres cubes. En août 1988, la production de gaz naturel marchand a atteint un volume de 6 760.5 millions de mètres cubes, soit une augmentation de 18.3%.

Au cours du mois d'août 1988, l'utilisation de gaz naturel a été le suivant: 2 694.0 millions de mètres cubes sont des livraisons nettes aux entrepôts de stockage et des opérations d'injection; 1 549.0 millions de mètres cubes ont été utilisés sur les chantiers et dans les usines de traitement; 2 627.5 millions de mètres cubes ont été exportés et 2 620.7 millions de mètres cubes incluant les ventes directes ont été vendus aux consommateurs canadiens. La différence entre la production et l'utilisation, soit 300.6 millions de mètres cubes, représente d'autres livraisons, le carburant utilisé par les pipe-lines, les pertes dans les pipelines et les fluctuations de pression dans les réseaux.

Avis aux Utilisateurs

Les données portant sur la production et la disposition de pétrole provenant des régions aux large des côtes (arctique et atlantique) sont comprises dans la région des Territoires du Nord-Ouest du tableau 1.

Definitions

Crude Oil

Crude oil. A mixture mainly of pentanes and heavier hydrocarbons that may be contaminated with sulphur compounds, that is recovered or is recoverable at a well from an underground reservoir and that is liquid at the conditions under which its volume is measured or estimated, and includes all other hydrocarbon mixtures so recovered or recoverable except raw gas or condensate.

Synthetic crude oil. A mixture mainly of pentanes and heavier hydrocarbons that may contain sulphur compounds, that is derived from crude bitumen and that is liquid at the conditions under which its volume is measured or estimated, and includes all other hydrocarbon mixtures so derived.

Crude bitumen. A naturally occurring viscous mixture, mainly of hydrocarbons heavier than pentane, that may contain sulphur compounds and that, in its naturally occurring viscous state, will not flow to a well.

Condensate. A mixture mainly of pentanes and heavier hydrocarbons that may be contaminated with sulphur compounds, that is recoverable at a well from an underground reservoir and that is gaseous in its virgin reservoir state but is liquid at the conditions under which its volume is measured or estimated.

Pentanes plus. A mixture mainly of pentanes and heavier hydrocarbons which ordinarily may contain some butanes and which is obtained from processing of raw gas, condensate or crude oil.

Gas Utilities

Total marketable gas. Receipt of gas from fields, processing or reprocessing plants after re-injection. Field uses, reprocessing plant or reprocessing plant shrinkage, plant use and losses have been deducted.

Imports. Receipts of gas, by pipeline, into Canada.

Other receipts. Includes liquified petroleum gases for peak shaving and receipts from non-reporting companies.

Exports. Export of gas, by pipeline, to the United States.

Direct sales. Represents direct, non-utility, deliveries for consumption.

Pétrole brut

Pétrole brut. Un mélange constitué principalement de pentanes et d'hydrocarbures plus lourds, qui peut être contaminé par des composés du soufre, qui est récupéré ou récupérable à partir d'un puits foré jusque dans un réservoir souterrain, qui est liquide dans les conditions où son volume est mesuré ou estimé et qui comprend tous les autres mélanges d'hydrocarbures ainsi récupérés ou récupérables à l'exception du gaz naturel ou d'un condensat.

Pétrole brut synthétique. Un mélange constitué principalement de pentanes et d'hydrocarbures plus lourds, qui peut être contaminé par des composés du soufre, qui est tiré du bitume brut, qui est liquide dans les conditions où son volume est mesuré ou estimé et qui comprend tous les autres mélanges d'hydrocarbures qui en sont tirés.

Bitume brut. Un mélange visqueux naturel constitué principalement d'hydrocarbures plus lourds que le pentane, qui peut être contaminé par des composés du soufre et qui, dans son état visqueux naturel, s'écoule difficilement.

Condensat. Un mélange constitué principalement de pentanes et d'hydrocarbures plus lourds, qui peut être contaminé par des composés du soufre, qui est récupérable à partir d'un puits foré jusque dans un réservoir souterrain et qui est gazeux à l'état vierge dans le gisement mais liquide dans les conditions où son volume est mesuré ou estimé.

Pentanes plus. Un mélange constitué principalement de pentanes et d'hydrocarbures plus lourds pouvant contenir normalement une certaine quantité de butanes, qui est obtenu par traitement du gaz brut, du condensat ou du pétrole brut.

Services de gaz

Total de gaz marchand. Arrivages de gaz en provenance des champs, des usines de traitement et des usines de recyclage après le retranchement des volumes utilisés dans les champs, dans les usines, pour la ré-injection, ainsi que des volumes perdus en cours de traitement et autres pertes.

Importations. Arrivages par pipeline au Canada de gaz en provenance des États-Unis.

Autres arrivages. Comprend les gaz de pétrole liquéfiés utilisés pour le nivelage des pointes de forte demande et les arrivages en provenance des sociétés non-déclarantes.

Exportations. Exportations de gaz naturel, par pipe-line, aux États-Unis.

Ventes directes. Représente les livraisons directes de gaz (non-service) pour la consommation.

Natural Gas Liquids

Propane. In addition to its normal scientific meaning, a mixture mainly of propane which ordinarily may contain some ethane or butanes.

Butanes. In addition to its normal scientific meaning, a mixture mainly of butanes which ordinarily may contain some propane or pentanes plus.

Ethane. In addition to its normal scientific meaning, a mixture mainly of ethane which ordinarily may contain some methane or propane.

Propane. Outre l'acception scientifique habituelle, un mélange constitué principalement de propane pouvant contenir normalement une certaine quantité d'éthane et de butanes.
