## MONTHLY REPORT

## FELDSPAR AND SALT PRODUCTION IN CANADA - JULY, 1937.

FELDSPAR - Shipments of feldspar by Canadian producers totalled 2,458 tons in July, according to a statement just issued by the Dominion Bureau of Statistics at Ottawa. In June, 1,801 tons were shipped while in July, 1936, shipments amounted to 2,499 tons. During the seven months ending July, Canadian producers shipped 11,307 tons as compared with 8,910 tons a year ago.

Imports of ground feldspar into Canada in July rose to 140 tons valued at \$2,348; in June, 90 tons at \$1,434 were imported.



<u>SALT</u> - Canadian producers shipped 23,487 tons of commercial salt in July as compared with 24,841 tons in the preceding month and 20,962 tons in July, 1936. Shipments during the first seven months of 1937 aggregated 135,892 tons; this represented an increase of 13.8 per cent over the tonnage shipped a year ago.

Canada exported 968 tons of salt in July; in the preceding month, 658 tons were exported. During the seven months ending July, 3,115 tons were exported as against 4,254 tons in the corresponding period of 1936.

Imports of salt into Canada in July declined to 9,566 tons worth \$40,423 from the June total of 14,482 tons at \$51,359. The July importations included 7 tons of table salt, 3,990 tons of salt for sea or gulf fisheries, 2,106 tons of salt in bulk, n.o.p., and 3,463 tons of other salt in bags, barrels, and other coverings. Great Britain supplied 33.1 per cent of the July imports; Italy, 26.1 per cent; the United States, 25.4 per cent; British West Indies, 15.1 per cent, and Newfoundland, the remainder.
