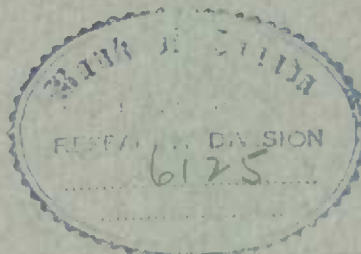

MANUFACTURING STATISTICS OF THE PROVINCE OF BRITISH COLUMBIA AND THE  
YUKON TERRITORY, 1933.

---

The general decline in industrial activity experienced by the manufacturing industries of Canada was halted in 1933 as far as British Columbia is concerned. Compared with the previous year, there was an increase of 4.7 per cent in employment, 6.6 per cent in the cost of materials, 3.5 per cent in the value of production and .8 per cent in the value added by manufacture. In spite of an increase in the number of persons employed, salaries and wages paid were, however, 6.1 per cent lower. Of all provinces, British Columbia made the greatest recovery in 1933. Ontario and Quebec which are the two dominant provinces in Canada did not fare so well. Ontario reported declines of 1.4 per cent in the number of employees, 8.5 per cent in salaries and wages paid and 2.2 per cent in value of production, while Quebec, in spite of an increase of 1.3 per cent in the number of employees, reported a drop of 6.7 per cent in the salaries and wages paid and 2.3 per cent in the value of products made.

In 1933 reports were received from 1,697 establishments operating in British Columbia and the Yukon Territory. The combined output of these establishments was valued at \$145,490,955. Employment was furnished to 30,896 persons who were paid \$31,168,339 in salaries and wages. The cost of materials used was \$70,297,698, while the value added by manufacture amounted to \$75,193,257. To these figures, the Yukon Territory contributed seven establishments, \$452,263 in capital invested, twenty-seven employees, \$50,358 in salaries and wages, \$14,983 to the cost of materials used, \$116,811 to the value of production and \$101,828 to the value added by manufacture.

In comparison with 1932, the industries of British Columbia and the Yukon Territory showed the following variations in their manufacturing activities. The number of establishments reporting increased by fifty-four with a drop in the capital invested, however, of \$1,629,086. The number of persons employed increased by 1,408, but there was a loss in the payroll of \$2,042,066. The amount spent on materials was \$4,337,130 more, while the rise in the value of production was even greater, viz., \$4,952,939. The increase in the value added by manufacture was, therefore, \$615,809. The totals and variations referred to are shown in tables 1 and 2.

Table 3 compares the principal statistics of the industrial groups for the years 1932 and 1933. From the standpoint of value of production, the wood and paper products group with an output valued at \$45,197,481 led all the others by a wide margin in both years. The next group of importance is vegetable products, followed by animal products, non-ferrous metal products, etc.

Table 4 reviews the principal statistics of the twenty leading industries of British Columbia in 1933. In value of production, sawmills headed the list with an output valued at \$21,592,153 as compared with an output valued at \$17,729,397 the previous year. Other leading industries are: pulp and paper \$11,098,400, fish curing and packing \$10,685,749, central electric stations \$9,892,781, petroleum products \$7,638,951, slaughtering and meat packing \$5,781,020, etc.

Table 5 reviews the principal statistics of the individual industries which make up the groups shown in table 3.

Table 6 covers the principal statistics of all cities, towns and villages in British Columbia and the Yukon Territory which have three or more establishments. The city of Vancouver with a production of \$55,160,883 leads by a very wide margin, accounting for 40.7 per cent of the total for the province excepting central electric stations. Other principal cities and the amount of their production were: New Westminster with \$7,540,382 and Victoria with \$5,537,980.

Table 7 gives the principal statistics of all the industries located in Vancouver.

Details of capital investment for 1933 are shown by industrial groups in table 8. The total capital investment in 1933 amounted to \$361,250,355 and of this amount \$271,090,393 represented the value of land, buildings, machinery, tools and other equipment. Inventories of raw materials, goods in process, fuel and other supplies on hand accounted for \$23,748,195, finished products \$27,158,984, while the balance of \$39,252,783 was made up of operating capital, (cash, bills and accounts receivable, prepaid expenses, etc.).

Statistics of power equipment and fuel consumption are shown in tables 9 and 10.

<sup>x</sup> The large decrease in the number of employees since 1930 is not, however, entirely due to the decline in manufacturing production. The decrease is in part due to the change in method of computing the average annual employment of wage-earners. Between 1925 and 1930 the average was obtained by summing the averages of individual plants, based on the number of months in actual operation and not by dividing by twelve the sum of the monthly employment figures. For example, if a plant operated only during three months of the year with an employment of 100 persons the first month, 125 the second month and 75 the third month, its average annual employment was taken as 100 (300 divided by 3) the same as that of another plant which operated the whole year with an average employment of 100 persons per month. In 1931, however, a change was made to the old method, whereby the aggregate of the monthly figures is divided by twelve. This

method gives the man year that each plant operates. The change in method, therefore, affects the average annual employment as well as the average wages paid in seasonal industries such as fruit and vegetable canning, fish canning, sawmills, etc.
