MANUFACTURING INDUSTRIES OF THE PROVINCE OF BRITISH COLUMBIA AND
THE YUKON TERRITORY, 1935.

The general improvement in manufacturing production commenced in the summer of 1933 was maintained during 1934 and 1935. Compared with the previous year, there was an increase in 1935 of 11.3 per cent in employment, with an increase of 15.5 per cent in the salaries and wages paid. An increase of 12.1 per cent was also recorded in the gross value of production, 19.9 per cent in the cost of materials used and only 4.1 per cent in the value added by manufacture. A change was made in the method of calculating the net value of production in the non-ferrous metal smelting and refining industry. The increase in 1935 is, for this reason, lower than what it would have been by the old method.

In 1935 reports were received from 1,819 establishments operating in British Columbia and the Yukon Territory. The combined output of these establishments was valued at \$198,106,542. Employment was furnished to 38,979 persons who were paid \$43,094,011 in salaries and wages. The cost of materials used was \$105,845,738, while the value added by manufacture amounted to \$86,196,093. To these figures the Yukon Territory contributed 7 establishments, \$476,952 in capital invested, 33 employees, \$52,789 in salaries and wages, \$21,156 to the cost of materials used and \$114,551 to the value of production.

In comparison with 1934 the industries of British Columbia and the Yukon Territory showed the following variations in their manufacturing activities. The number of establishments reporting increased by 42, with an increase in the capital invested of \$3,719,449. The number of persons employed increased by 3,914 with a gain in the payroll of \$5,791,270. The amount spent on materials was \$17,552,810 more, while the rise in the gross value of production was even greater, viz. \$21,385,144. Details are shown in tables 1 and 2.

Table 3 compares the principal statistics of the industrial groups for the years 1934 and 1935. From the standpoint of value of production, the wood and paper products group with an output valued at \$65,667,797 led all others by a wide margin in both years. The vegetable products group of industries ranked second with a value of production of \$29,600,977, being followed by animal products \$28,804,660, non-ferrous metal products \$26,257,230, etc.

British Columbia was, in 1935, the third most important manufacturing province in the Dominion with a gross value of production of \$198,106,542. About 18 per cent of this production, or \$35,713,189, was contributed by the sawmilling industry. The predominance of forest products industries in the industrial life of the province is still further emphasized if to this figure be added \$13,141,602, the value of production of the pulp and paper industry which ranks third. Second in importance among the industries of the Province is that of fish curing and packing with a gross production of \$14,421,861. The output of central electric stations was valued at \$11,278,402, petroleum products \$9,229,363, slaughtering and meat packing \$8,339,127, etc. Statistics of the leading industries are given in table 4, while the

statistics of the individual industries are given in table 5.

The principal statistics of all cities, towns and villages with three or more establishments are given in table 6. The City of Vancouver with a production of \$73,981,872 leads by a very wide margin, accounting for 39.6 per cent of the total for the Province excepting central electric stations. Other principal cities, with the amount of their production, are: New Westminster with \$12,349,255 and Victoria \$6,566,104. Trail is also an important manufacturing centre, statistics for which, however, cannot be published.

The principal statistics of all the industries located in Vancouver are given in table 7.

Details of capital investment in 1935 are shown by industrial groups in table 8. The total capital investment in 1935 amounted to \$371,039,792 and of this amount \$274,970,199 represented the value of land, buildings, machinery, tools and other equipment. Inventories of raw materials, finished products, fuel and other supplies on hand accounted for \$51,062,932, while the balance of \$45,006,661 was made up of operating capital, such as cash, bills and accounts receivable, deferred charges, etc.

Statistics of power equipment and fuel consumption are shown in tables 9 and 10.
