MANUFACTURING INDUSTRIES OF THE PROVINCE OF BRITISH COLUMBIA AND
THE YUKON TERRITORY, 1937.

The upward climb in manufacturing production begun in the summer of 1933 was greatly accelerated in 1937. Compared with the previous year, there was an increase in 1937 of 7.0 per cent in employment, and an increase of 13.3 per cent in the salaries and wages paid. An increase of 16.5 per cent was also recorded in the gross value of production, 19.0 per cent in the cost of materials used and 13.2 per cent in the value added by manufacture.

In 1937 reports were received from 1,713 establishments operating in British Columbia and the Yukon Territory. The combined output of these establishments was valued at \$251,924,258. Employment was furnished to 42,576 persons who were paid \$51,979,393 in salaries and wages. The cost of materials used was \$144,466,346, while the value added by manufacture amounted to \$99,359,051. The manufacturing activities of the Yukon Territory consisted of one bakery, one shipbuilding, one novelties and two printing and publishing plants.

In comparison with 1936 the industries of British Columbia and the Yukon Territory showed the following variations in their manufacturing activities. The number of establishments reporting increased by 18, with an increase in the capital invested of \$5,324,690. Current assets were down \$1,991,834 while fixed assets were \$7,316,524 higher. The number of persons employed increased by 2,780 with a gain in the payroll of \$6,125,019. The amount spent on materials was \$23,104,228 higher, while the rise in the gross value of production was even greater, viz., \$35,788,180. Details are shown in Tables 1 and 2.

Table 3 compares the principal statistics of the industrial groups for the years 1936 and 1937. From the standpoint of the value of production, the wood and paper products group with an output valued at \$96,620,195, led all others by a wide margin in both years. The non-ferrous metal products group of industries ranked second with a value of production of \$39,266,708, being followed by vegetable products with \$36,494,957, animal products \$32,791,666, etc.

British Columbia was in 1937 again the third most important manufacturing province in the Dominion with a gross value of production of \$251,924,258. About 21 per cent of this production, \$53,647,601, was contributed by the sawmilling industry. The predominance of forest products industries in the industrial life of the Province is still further emphasized if to this figure be added \$18,038,957, the value of production of the pulp and paper industry which ranks second, third in importance among the industries of the Province is that of fish curing and packing,

with a gross value of \$10,498,674, slaughtering and meat packing \$9,810,734, etc. Statistics of the leading industries are given in Table 4, while the statistics of the individual industries are given in Table 5.

The principal statistics of all cities, towns and villages with three or more establishments are given in Table 6. The City of Vancouver with a production of \$95,717,017 leads by a very wide margin, accounting for 38.0 per cent of the total for the Province. Other principal cities, with the value of the production, are: New Westminster with \$16,991,658 and Victoria with \$8,007,823. Trail is also an important manufacturing centre, statistics for which, however, cannot be published.

The principal statistics of all the industries located in Vancouver are given in Table 7.

Details of capital investment in 1937 are shown by industrial groups in Table 8. The total capital investment in 1937 amounted to \$253,011,093 and of this amount \$135,947,812 represented the value of land, buildings, machinery, tools and other equipment. Inventories of raw materials, finished products, fuel and supplies on hand accounted for \$56,360,770, while the balance of \$33,402,511 was made up of operating capital, such as cash, bills and accounts receivable, deferred charges, etc.

Statistics of power equipment and fuel consumption are shown in Tables 9 and 10.
