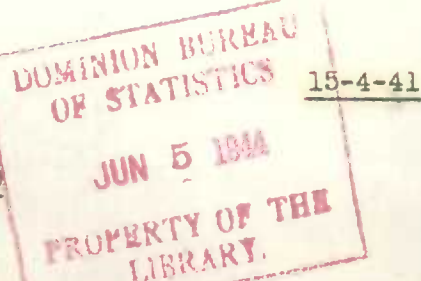


SPECIAL STATEMENT

ELECTRIC VACUUM CLEANERS - 1940



Factory sales of electric vacuum cleaners and parts totalled \$1,957,438 in 1940 compared with \$1,729,508 in 1939. Sales of floor models were higher in 1940 at 45,567 units worth \$1,772,317 compared with 44,767 units at \$1,560,838 in the previous year while shipments of hand models totalled 2,959 units valued at \$36,412 compared with 2,948 machines at \$27,629 in 1939. Sales of parts and attachments were valued at \$148,709 in 1940 and \$141,041 in 1939.
