

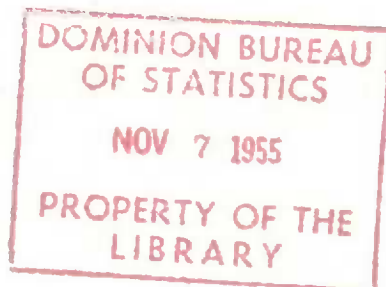

REFINED PETROLEUM PRODUCTS

MAY - 1955

Output of refined petroleum products in Canada during May, 1955, totalled 16,385,839 barrels compared with 13,894,333 barrels in May, 1954. The total for the month under review included 6,395,646 barrels of motor gasoline, 110,059 barrels of aviation gasoline, 3,360,032 barrels of heavy fuel oil (Nos. 4, 5 and 6), 1,689,830 barrels of diesel fuel, 1,882,535 barrels of furnace oil, 150,208 barrels of other light fuel oil, 896,240 barrels of kerosene stove oil (No. 1 fuel oil), 56,535 barrels of tractor fuel, 188,330 barrels of aviation turbine fuel, 1,656,424 barrels of naphtha specialties, and other refinery products such as lubricating oils, asphalt, coke, liquefied petroleum gases, etc.

Refineries in Canada used 16,208,718 barrels of crude oil during May, 1955, compared with 14,560,414 barrels in May, 1954. Receipts of crude oil during the current month totalled 16,830,150 barrels, including 8,042,188 barrels of imported oil and 8,787,962 barrels from Canadian sources of supply. Inventories of crude at the end of the month amounted to 18,365,231 barrels. This latter figure includes stocks held at the field, in pipeline systems and in refineries. Comparable figures on this basis are not available for 1954.

Net sales of liquid petroleum fuels in Canada, as computed from production, imports, exports, changes in inventories, etc., were as follows in May, 1955, all figures being in barrels of 35 Imperial gallons: Naphtha specialties, 110,194; aviation gasoline, 370,919; motor gasoline, 7,314,568; tractor fuel, 36,638; aviation turbine fuel, 214,013; kerosene, 44,704; stove oil (No. 1 fuel oil), 436,221; diesel fuel, 1,223,790; furnace oil, 1,343,521; other light fuel oil, 110,502; and heavy fuel oil (Nos. 4, 5 and 6), 3,801,449.

NOTE: It is the practice of the External Trade Section to close off their records for a particular month with entries received at Ottawa on the last working day; accordingly, there may be some carry over into the next month. That is to say, imports during the last few days of a month at customs' ports such as Halifax, Vancouver, Montreal, etc., do not reach Ottawa in time for inclusion in that month's figures but are carried over into the totals for the following month. Figures shown in Table 3 have been adjusted by examining the individual customs' invoices and by pulling back any such carry over; Table 3, therefore, shows totals for the full month. For this reason the figures differ slightly from the figures shown in the above table.
