



REFINED PETROLEUM PRODUCTS

June, 1958

Output of refined petroleum products in Canada during June, 1958 totalled 19,946,185 barrels compared with 21,630,448 barrels in June, 1957. The total for the month under review included 6,848,247 barrels of motor gasoline, 40,866 barrels of aviation gasoline, 3,205,065 barrels of heavy fuel oil (Nos. 4, 5 and 6), 2,241,519 barrels of diesel fuel, 2,871,497 barrels of light fuel, 809,345 barrels of kerosene, stove oil (No. 1 fuel oil) and tractor fuel, 432,379 barrels of aviation turbo fuel, 3,497,267 barrels of naphtha specialties, and other refinery products such as lubricating oils, asphalt, coke, liquefied petroleum gases, etc.

Refineries in Canada used 19,819,718 barrels of crude oil during June, 1958, compared with 21,459,202 barrels in June, 1957. Receipts of crude oil during the current month totalled 19,804,246 barrels, including 9,598,778 barrels of imported oil and 10,205,468 barrels from Canadian sources of supply. Inventories of crude at the end of the month amounted to 22,617,590 barrels compared with 23,132,479 barrels on the corresponding date of last year. These figures include stocks held at the field, in pipeline systems and in refineries.

Net sales of liquid petroleum fuels in Canada, as computed from production, imports, exports, changes in inventories, etc., were as follows in June, 1958, comparable figures for corresponding month of 1957 in brackets, all figures being in barrels of 35 Imperial gallons; naphtha specialties, 121,963 (108,519); aviation gasoline, 315,178 (323,006); motor gasoline, 8,255,891 (7,975,681); aviation turbo fuel, 380,703 (292,632); tractor fuel, kerosene and stove oil (No. 1 fuel oil), 397,143 (320,204); diesel fuel, 1,981,375 (1,708,788); light fuel oil (Nos. 2 and 3), 1,560,268 (1,176,238); and heavy fuel oil (Nos. 4, 5 and 6), 2,899,692 (3,831-282).

SPECIAL NOTICE

The January, 1958 report in this series carried an explanatory note outlining a change in concept involving the use of import data supplied by the External Trade Section of the Dominion Bureau of Statistics. At that time it was indicated that because of the unavailability of comprehensive import data it was decided an adjustment for full import data would have to be made with respect to the month in which the amount of correction became known, rather than the month to which it applies. In consequence, the January report in respect to imports and net sales showed totals which were understated by the amount of adjustment which in the past would have normally been made through the use of full import data for January. The adjustment applying to January imports was introduced into the tabulations presented in the February report and this schedule was maintained for the reports covering the first five months of 1958; however, it was found possible to affect certain improvements in data processing procedures in this period so it now appears that adherence to this schedule would delay preparation and, therefore, final release of the report. An extension of the original concept, that is, dropping back another month in the import adjustments would overcome this situation and it has been decided to introduce this feature for the month under review. Accordingly, import data shown in the June bulletin reflect only basic data supplied by respondents. The adjustments involving import data for May supplied by the External Trade Section will not be introduced until the July report. As in the past, of course, the report for each month will carry a statement indicating the month to which changes relate. Details of full imports will appear as usual in the appropriate table of the report, but because of the circumstances outlined above the May imports which would normally have been found in the June release will not be carried until July.
