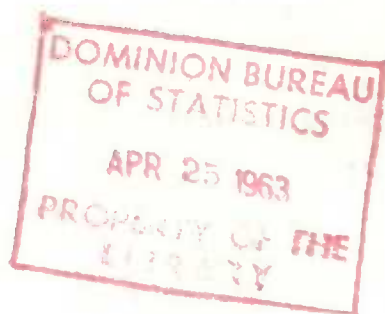

REFINED PETROLEUM PRODUCTS

Certain changes in concept and presentation are being introduced in this report to meet more adequately the needs of industry and government and, in some instances, to reflect more accurately current industry practices. One change in concept and terminology, affecting Tables 1 - 4, is the inclusion of condensate and natural gasoline with crude oil as "crude oil and equivalent". The effects of this and other changes are indicated below.

TABLE 1 - New Supply and Disposition of Crude Oil and Equivalent, by Source

This is a new table which will show the supply and disposition of (a) Canadian crude oil and equivalent, by province of origin, from production to its delivery to both domestic and export markets, and (b) foreign crude oil and equivalent entering Canada. Data for January 1963 were not available in time for inclusion of the table in this issue, but it is hoped that it will be included in the February report. Until production data are available on as current a basis as those for disposition, it is probable that this table will continue to be issued a month later than the rest of the information in this report.

TABLE 2 - Crude Oil and Equivalent Received by Canadian Refineries

Aside from the re-arrangement of sources in alphabetical order, the only change in this table is the inclusion of receipts from New Brunswick fields.

TABLE 3 - Raw Materials Supply, Canadian Refiners

The major changes in this table are the separation of refinery receipts by means of transportation, the deletion of a separate category for "Natural Gas Liquids", and the provision for refinery sales of crude oil and equivalent after receipt in refinery tankage. Receipts and inventories of condensate and natural gasoline, formerly included in "Natural Gas Liquids", have been included in crude oil beginning with July, 1962. Receipts of propane, butane and propane/butane mixes, part of which was formerly included under "Natural Gas Liquids", are now shown in two categories:

1. Refinery receipts of propane/butane/mixes from gas processing plants for commingling with crude and equivalent are shown in Table 3, item 1 (b), and
2. Other receipts of propane/butane/mixes are shown in Table 4 under "Propane, butane and propane/butane mixes".

TABLE 4

Commencing with the January 1963 issue, two changes have been made which affect all products. "Refinery production" now reads "From crude oil and equivalent, and commingled propane/butane/mixes" rather than "From crude". "Blending agents and additives" has been replaced by "Other materials used". The latter item no longer includes propane, butane and propane/butane mixes used for blending purposes. These are now included in production and receipts in the product "Propane, butane and propane/butane mixes".

Other changes affect individual products. The former product category, "Liquefied Petroleum Gas" is renamed "Propane, butane and propane/butane mixes". The figures shown in this section are those reported by refiners, distributors and natural gas processing plant operators listed in the back of this publication. Sales of propane, butane and mixes by gas processing plants, formerly shown in Table 5, are now included in the product "Propane, butane and propane/butane mixes" in Table 4. Production of the propane/butane content of petro-chemical feed stocks is now included in the production of propane, butane and propane/butane mixes and transferred into petro-chemical feedstocks via inter-product transfers.

A new item, "Receipts in Canada - From gas processing plants", is included for the first time and is equivalent to total domestic and export sales of propane, butane and propane/butane mixes by gas processing plant operators listed in the back of this publication, excluding the amounts reported in Table 3 as a raw material.
