

REFINED PETROLEUM PRODUCTS

DECEMBER - 1952

Output of refined petroleum products in Canada during December, 1952 totalled 11,848,146 barrels compared with 10,005,455 barrels in December, 1951. The total for the month under review included 5,261,136 barrels of motor gasoline, 28,014 barrels of aviation gasoline, 2,705,320 barrels of heavy fuel oil (Nos. 4, 5 and 6), 716,440 barrels of diesel fuel, 1,374,349 barrels of furnace oil, 185,417 barrels of other light fuel oil, 888,606 barrels of stove oil (No. 1 fuel oil), 15,656 barrels of tractor fuel, -10,235 barrels of aviation turbine fuel, 57,439 barrels of naphtha specialties, and 650,236 barrels of other refinery products such as lubricating oils, asphalt, coke, liquefied petroleum gases, etc.

Refineries in Canada used 12,733,906 barrels of crude oil during December, 1952 compared with 10,643,402 barrels in December, 1951. Receipts of crude oil during the current month totalled 12,481,307 barrels including 7,463,433 barrels of imported oil and 5,017,874 barrels from Canadian sources of supply. Inventories of crude at the end of the month amounted to 10,826,281 barrels compared with 8,183,535 barrels on the corresponding date of last year.

The consumption of liquid petroleum fuels in Canada, as computed from refinery shipments and from imports, exports and changes in marketing inventories of refiners, wholesalers and major consumers, was as follows in December, 1952, all figures being in barrels of 35 Imperial gallons: Naphtha specialties, 81,484; aviation gasoline, 182,621; motor gasoline, 4,581,369; tractor fuel, 2,731; aviation turbine fuel, 55,635; kerosene, 63,807; stove oil (No. 1 fuel oil), 1,343,221; diesel fuel, 730,673; furnace oil, 3,317,448; other light fuel oil, 247,893; and heavy fuel oil (Nos. 4, 5 and 6), 3,281,969.

Receipts of crude oil at refineries totalled 141.3 million barrels in 1952 compared with 130.3 million barrels in 1951. Receipts of Canadian crude rose to 58.9 million barrels from 47.2 millions, and receipts of imported declined slightly to 82.5 millions from 83.1 millions. The details by countries of origin and by fields are as follows: -
