## SALES OF MANUFACTURED AND NATURAL GAS

November, 1959

Historical File Copy

Natural gas sales during November, 1959 totalled 28,346,674 MCF, a rise of 43.8 per cent above the total of 19,710,580 in November, 1958. The number of customers increased 10.1 per cent to 1,106,731 from 1,005,485 last year and revenue from sales increased 47.8 per cent to \$16,128,208 from \$10,911,346.

During the eleven month period ended November 30, natural gas sales increased 39.0 per cent to 249,822,954 MCF from the comparable 1958 total of 179,735,257. During this period revenue from sales rose to \$139,490,612 from \$99,791,508.

Sales of natural gas to industrial consumers reached 13,529,558 MCF, a higher level than any previous month and were 44.7 per cent more than the total in November, 1958 of 9,350,573. Sales to domestic customers increased 44.1 per cent to 9,962,237 MCF from 6,912,606 last year and sales to commercial customers increased 40.7 per cent to 4,841,948 from 3,440,400.

Sales in Alberta during November totalled 13,670,878 MCF, 48.2 per cent of the total for Canada. Alberta accounted for 39.6 per cent of domestic sales, 50.6 per cent of industrial sales and 59.5 per cent of commercial sales. Ontario received greatest revenue from sales, obtaining 47.0 per cent of the total for Canada, 48.6 per cent of the revenue from domestic sales, 52.2 per cent from industrial and 34.3 per cent from commercial sales.

For the first time this year sales of manufactured gas showed an increase over the corresponding month of the previous year, up 22.6 per cent to 122,990 MCF from 100,330. For the eleven month period sales decreased 76.6 per cent to 1,303,900 MCF from 5,573,223. The number of customers using manufactured gas during November declined to 30,346 from 31,962 in November, 1958. Revenue from sales increased this month to \$193,759 from \$162,843. Revenue per MCF of manufactured gas was \$1.58, considerably higher than the average rate of \$0.57 per MCF for natural gas.

## Classification of Gas Sales

- (a) Domestic sales of gas for residential use, including house heating.
- (b) Industrial sales to industrial and manufacturing concerns such as manufacturers of chemicals, machinery, textiles, foodstuffs, as well as foundries, machine shops, wholesale bakeries, commercial laundries, etc.
- (c) Commercial sales to hotels, restaurants, retail bakers, delicatessens, tailor shops, department stores, wholesale dealers, professional and business offices, etc.
- (d) Miscellaneous includes all sales not classified above. Does not include sales to other distributing companies.
- N.B. In order to facilitate early compilation of these reports, the current monthly statistics contained herein include some preliminary estimates. However, actual figures, upon becoming available, are substituted for estimates in the cumulative totals. Hence, the addition of monthly totals may not agree with the cumulative figures.
