SALES OF MANUFACTURED AND NATURAL

May, 1959

Natural gas sales in Canada reached a total of 2,638 008 MCF in May a rise of 48.2 per cent above the total of 14,604,559 MCF in May last year. For the five months end a May 31, 1959, natural gas sales totaled 141,645,896 MCF, 43.9 per cent more transche total to 96 alo,813 MCF for the same period in the previous year. The total for May, however, decreased 112 per cent from 24,540,435 MCF in April, due mainly to reductions in the consumption of natural gas for heating purposes.

Number of customers using natural gas was 1,048,597 or 472 per cent more than the total of 712,382 one year earlier. Revenue from sales during the month under preview increased 36.1 per cent to \$11,361,406 from \$8,347,962 in May, 1958. During the January to May period of 1959 revenue increased 46.3 per cent over the first five months of 1950.

Industrial sales continued to show the greatest gain, rising 76.4 per cent during May, 1959 to 12,449,955 MCF from 7,056,457 MCF in May last year and 5.8 per cent from 11,770,578 MCF in April, 1959.

Sales of natural gas in Alberta amounted to 10,454,213 MCF, 48.3 per cent of the total sales in Canada. Alberta exceeded other provinces in all types of sales, accounting for 41.6 per cent of the domestic sales, 49.0 per cent of the industrial sales and 60.4 per cent of the commercial sales. Ontario, on the other hand, accounted for the greatest portion of revenue from sales, obtaining \$5,644,076 or 49.7 per cent of the total revenue for Canada. Ontario received 51.4 per cent of revenue from domestic, 53.5 per cent from industrial and 36.1 per cent from commercial sales.

Revenue per MCF varied greatly from \$2.75 in New Brunswick to \$0.23 in Alberta. Average revenue per MCF for industrial sales in all areas was much lower than that from domestic or commercial sales.

Sales of manufactured gas continued to decline sharply, dropping 75.0 per cent to 114,441 MCF in May of this year from 457,325 MCF one year earlier. In the five months ended May, 1959, sales decreased 84.3 per cent to 733,217 MCF from 4,658,410 during the same period in 1958. Average revenue per MCF was \$1.57, considerably higher than the average of \$0.53 per MCF for natural gas.

Classification of Gas Sales

- (a) Domestic sales of gas for residential use, including house heating.
- (b) Industrial sales to industrial and manufacturing concerns such as manufacturers of chemicals, machinery, textiles, foodstuffs, as well as foundries, machine shops, wholesale bakeries, commercial laundries, etc.
- (c) Commercial sales to hotels, restaurants, retail bakers, delicatessens, tailor shops, department stores, wholesale dealers, professional and business offices, etc.
- (d) Miscellaneous includes all sales not classified above. Does not include sales to other distributing companies.
