SALES OF MANUFACTURED AND NATURAL GAS

September, 1959

Natural gas sales during September totalled 17,070,841 MCF, a rise of 39.3 p.c. above the total of 12,256,460 MCF in September, 1958. For the nine month period ended September 30, 1959, sales of natural gas reached 199,364,681 MCF, 38.1 p.c. greater than the total of 144,380,358 MCF reported for the same period last year. September sales increased 17.6 p.c. from the total of 14,510,271 for the preceding month.

The number of customers using natural gas rose 10.2 p.c. to 1,061,467 from 963,277 one year ago.

Revenue from natural gas sales increased 35.6 p.c. to \$8,846,069 from \$6,521,781 in September, 1958. During the period under review, revenue was 24.9 p.c. greater than the August total of \$7,082,373.

All categories of natural gas sales were greater this September than in 1958. Industrial sales rose 49.4 p.c. to 11,821,480 MCF from 7,912,270, domestic sales 32.1 p.c. to 3,256,414 MCF from 2,464,902 and commercial sales 5.9 p.c. to 1,988,279 MCF from 1,876,896.

Sales in Alberta during September totalled 8,436,402 MCF, 49.4 p.c. of the total for Canada. Alberta exceeded all other provinces in all categories of sales, accounting for 44.9 p.c. of domestic sales, 50.1 p.c. of industrial and 52.7 p.c. of commercial sales. Revenue from sales in Ontario totalled \$4,159,517, largest provincial share (47.0 p.c.) of the total revenue for Canada. Ontario received 43.9 p.c. of the revenue from domestic sales, 51.2 p.c. from industrial and 45.7 p.c. from commercial sales.

Sales of manufactured gas in September decreased 20.7 p.c. to 85,099 MCF from 107,307 MCF in September of last year. For the nine month period sales decreased 79.8 p.c. to 1,085,494 MCF from 5,362,770 MCF. The number of customers using manufactured gas decreased to 30,711 from 32,662 in September of the previous year and revenue from sales decreased to \$144,363 from \$176,101. Revenue per MCF of manufactured gas amounted to \$1.70, considerably higher than the average rate for Canada of \$0.52 per MCF for natural gas.

Classification of Gas Sales

- (a) Domestic sales of gas for residential use, including house heating.
- (b) Industrial sales to industrial and manufacturing concerns such as manufacturers of chemicals, machinery, textiles, foodstuffs, as well as foundries, machine shops, wholesale bakeries, commercial laundries, etc.
- (c) Commercial sales to hotels, restaurants, retail bakers, delicatessens, tailor shops, department stores, wholesale dealers, professional and business offices, etc.
- (d) Miscellaneous includes all sales not classified above. Does not include sales to other distributing companies.
