## SALES OF MANUFACTURED AND NATURAL GAS LIBRARY

May, 1960

In order to ensure that statistics are presented on a uniform basis, gas utilities have been asked, as of January 1960, to report MCF sold at 14.73 p.s.i.a.,  $60^{\circ}F$ . and 1,000 BTU (for natural gas) or 500 BTU (for manufactured gas). In past years there have been some slight differences among companies regarding pressure, temperature and heat value conditions at which gas volumes were reported. Therefore, the volume of gas sold during 1958 and 1959 was recalculated at the specified standards and was published in the February, 1960 report. For comparison purposes, April, 1959 data are shown herein on the revised basis.

Sales of liquefied petroleum gas, which were previously included with sales of manufactured gas, are now tabulated separately. In order to properly assess the trend of manufactured gas sales, this breakdown for 1958 and 1959 sales was provided in the February, 1960 report.

Sales of natural gas during May, 1960 amounted to 24,165,168 MCF, an increase of 18.2 per cent over the 20,440,351 MCF sold in May, 1959 and revenue from sales rose 27.6 per cent to \$14,086,984 from \$11,041,472; the number of customers using natural gas rose 8.5 per cent to 1,135,511 from 1,046,739.

All categories of natural gas sales were greater this May than in 1959. Industrial sales rose 15.7 per cent to 13,232,745 MCF from 11,441,091, domestic sales 20.7 per cent to 7,481,009 MCF from 6,197,207 and commercial sales 23.1 per cent to 3,439,642 MCF from 2,795,091.

Sales in Alberta during the month under review totalled 10,967,419 MCF, 45.4 per cent of the total for Canada. Alberta accounted for 35.3 per cent of the domestic sales, 49.6 per cent of the industrial sales and 51.0 per cent of the commercial sales. Ontario recorded the greatest revenue from sales, obtaining 47.6 per cent of the total for Canada, 49.2 per cent of the revenue from domestic sales, 49.4 per cent from industrial sales and 39.4 per cent from commercial sales.

## Classification of Gas Sales

- (a) Domestic sales of gas for residential use, including house heating.
- (b) Industrial sales to industrial and manufacturing concerns such as manufacturers of chemicals, machinery, textiles, foodstuffs, as well as foundries, machine shops, wholesale bakeries, commercial laundries, etc.
- (c) Commercial sales to hotels, restaurants, retail bakers, delicatessens, tailor shops, department stores, wholesale dealers, professional and business offices, etc.
- (d) Miscellaneous includes all sales not classified above. Does not include sales to other distributing companies.
- N.B. In order to facilitate early compilation of these reports, the current monthly statistics contained herein include some preliminary estimates. However, actual figures, upon becoming available, are substituted for estimates in the cumulative totals. Hence, the addition of monthly totals may not agree with the cumulative figures.
