

NEW MOTOR VEHICLE SALES AND MOTOR VEHICLE FINANCING

AUGUST 1955

New Motor Vehicle Sales

Passenger car sales were down 6,547 units from last month and commercial vehicle sales were up 1,161 units, to bring the value of sales of vehicles in August to \$111,249,000, compared with \$126,378,000 the previous month. Comparing August, 1955, with the same month last year, a substantial increase took place in the number of vehicles sold and the value of sales. A comparison with other years reveals that the current month establishes a record for sales during the month of August.

Note:

Retail values quoted in this report are based on the retail price to individual purchasers at the Canadian point of manufacture. In the case of imported vehicles, the values are the retail price delivered at the nearest Canadian distributing centre. Retail values include sales and excise taxes, charges for standard accessories, dealers' commissions, etc. Transportation charges from Canadian point of manufacture to point of delivery are not included.

Financing of Motor Vehicle SalesNew Vehicles

The number of vehicles financed and the amount of financing were up slightly in August compared with July, 1955. Comparing the current month with the same month a year ago, a marked increase occurred. As in the case of sales, financing of new vehicles during the current month was a larger figure than during any previous August.


Used Vehicles

Compared with one month ago, not much change took place in the financing of used vehicles. Comparing August, 1955, with August a year ago, an increase of 15.5% is recorded. In no previous month of August did used car financing reach this magnitude.

Note:

The financing shown herein represents only that business done by sales finance and acceptance companies engaged in the purchase or discounting of notes receivable arising from retail instalment sales of new and used motor vehicles.

% CHANGE IN NEW MOTOR VEHICLE SALES BY PROVINCES 1955/1954


