



Travel Between Canada and the United States

May, 1958

1. Highway Traffic - May, 1958

The volume of highway traffic crossing the border between Canada and the United States was 3 per cent heavier in May than in the corresponding month of 1957. Total crossings numbered 1,558,800 as compared with 1,512,800 in the same month of last year, a gain of 46,000. The aggregate was made up of 800,700 foreign vehicles and 758,100 vehicles registered in Canada. The expansion in volume was more pronounced in foreign traffic than with vehicles registered in Canada.

Foreign Vehicles

The advance in volume of foreign traffic amounted to some 37,700 entries or nearly 5 per cent when compared with the corresponding month of 1957. Non-resident traffic was comprised of 202,400 units entering on travellers' vehicle permits, 559,700 local or non-permit entries and 38,600 commercial vehicles.

A new record for the month of May was established in the number of foreign vehicles entering Canada on travellers' vehicle permits. Entries totalled 202,400, an increase of 16,600 entries over the same month of 1957 and 1,700 higher than the previous record for the month in 1955. Cumulative entries for the first five months were between 3 and 4 per cent heavier than the same period of 1957. With the exception of New Brunswick and Quebec, all provinces shared in the increase of traffic during the five month period.

Entries of non-permit or local traffic advanced nearly 4 per cent or approximately 20,700 visits during the month. Cumulative entries for the first five months showed little change from last year, the increase for the period amounting to less than 1 per cent or approximately 17,900 entries. Entries of foreign commercial vehicles were 1 per cent heavier than in May 1957 but a reduction of 4 per cent was recorded for the cumulative period.

Canadian Vehicles

Re-entries of vehicles registered in Canada amounted to 758,100 in May, a gain of about 1 per cent or 8,300 additional crossings as compared with the same month of last year. Canadian vehicles returning were comprised of 100,600 units abroad more than 24 hours, 611,800 abroad for 24 hours or less and 45,700 commercial vehicles.

The volume of long-term Canadian traffic abroad for more than 24 hours declined nearly 9 per cent or 9,700 visits as compared with the same month of 1957. With the exception of New Brunswick, Manitoba and British Columbia, fewer re-entries were recorded in this category for all provinces. Cumulative re-entries for the first five months were some 4 per cent lower than last year, with decreases recorded in all provinces except Manitoba and British Columbia.

Short-term traffic was 4 per cent heavier in the month of May and between 1 and 2 per cent heavier than last year during the first five months. Re-entries of commercial vehicles were 11 per cent lower in May and nearly 14 per cent lower for the five month period.

11. Traffic By Long Distance Common Carrier - April, 1958

Traffic crossing the border between Canada and the United States by long distance common carrier recorded a decrease of 3 per cent in April when compared with the same month of last year. Aggregate crossings into Canada numbered 187,800 in comparison with 193,700 in April of last year, a decline of 5,900 during the month. Re-entries by Canadians were about 1 per cent lower while foreign entries were down some 6 per cent.

Foreign Travellers

The number of residents of the United States entering Canada by rail, through bus, boat and plane declined from 75,900 in 1957 to 71,100 in April 1958, some 4,800 crossings or more than 6 per cent.

There was no change in the number of entries by boat but arrivals by rail had dropped 29 per cent or 8,300 entries when compared with April 1957. Entries by bus advanced 9 per cent and arrivals by plane were 7 per cent heavier than the same month of last year. An additional 1,900 persons arrived by bus in April of this year while 1,600 more arrived by plane.

Cumulative data for the first five months show an increase in traffic by through bus, boat and plane but a substantial decrease in the number of arrivals by rail. The decline in rail traffic was sufficient to offset the gains appearing for other types of transportation, leaving the aggregate between 1 and 2 per cent lower than the same period of last year.

Canadian Travellers

Residents of Canada returning from the United States by long distance common carrier numbered 116,700 as compared with 117,800 in April 1957, a decline of 1,100 visits during the month.

The additional number of re-entries by boat and plane were not sufficient to offset a decrease in the number of persons returning by rail and bus, leaving the aggregate about 1 per cent lower than April 1957. The number of Canadians returning by rail dropped from 43,100 to 39,100, some 4,000 visits or over 9 per cent, while some 2,400 fewer persons returned by bus, representing a decrease of over 6 per cent. Compared with April 1957 an additional 600 persons returned by boat and 4,700 more returned by plane which represented gains of 13 per cent and 15 per cent, respectively.

Cumulative data for the first four months of the year followed a pattern somewhat similar to that of the current month. Additional re-entries were reported by boat and plane while fewer persons returned by rail and bus. Gains of 17 per cent and 8 per cent were recorded in the number of entries by boat and plane but declines of 16 per cent and 8 per cent were recorded in the number of re-entries by rail and bus. The aggregate for all types declined nearly 4 per cent or some 24,300 visits as compared with the same period of 1957.
