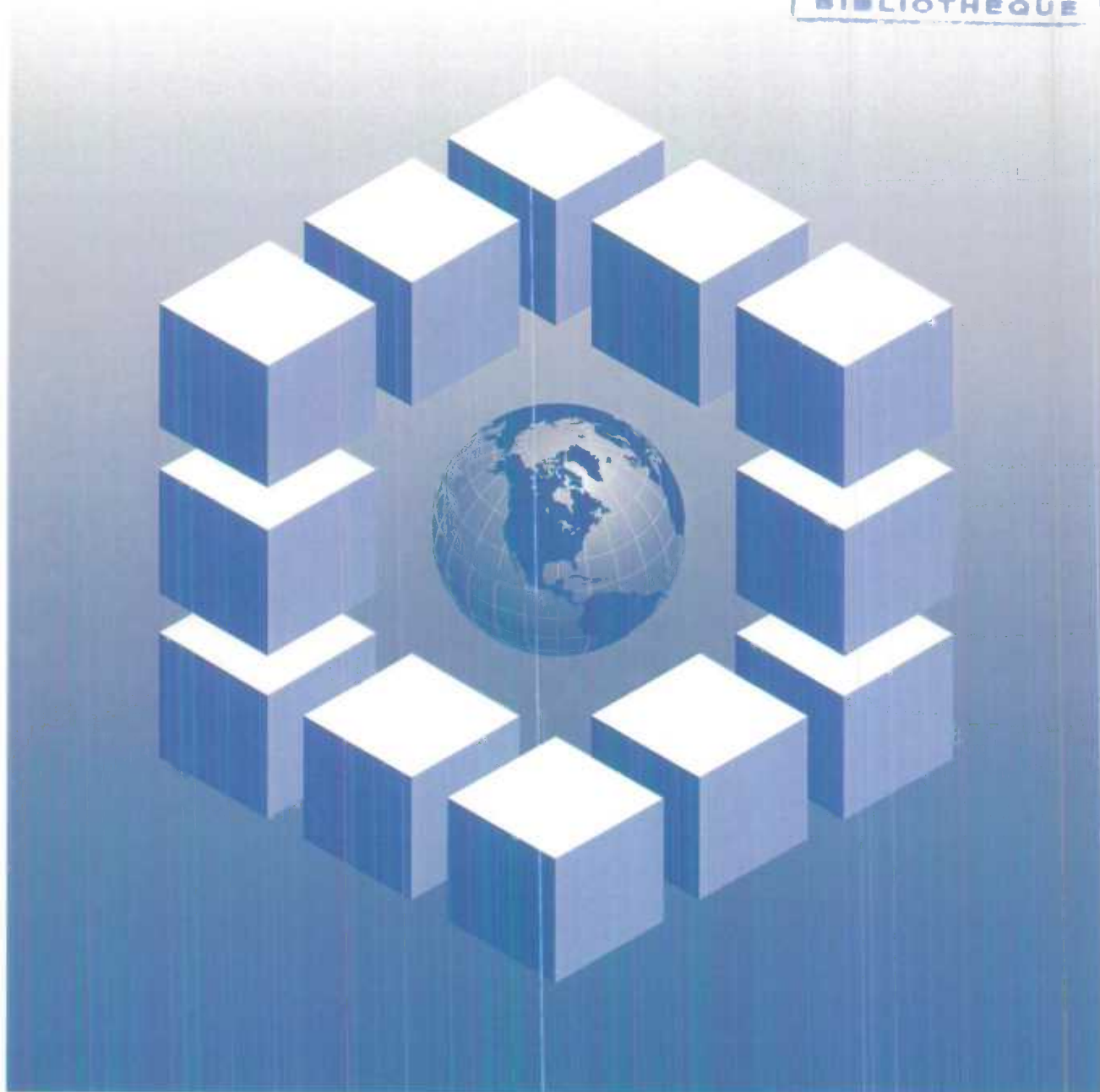
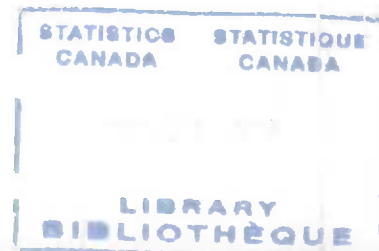

I - 1 AGRICULTURE

Produces information on the supply of agricultural commodities (production and inventory levels); resources employed to produce these commodities (land and capital); the returns to farmers arising out of production; revenues and expenses, off-farm income of operators and farm families by type of farm; socio-economic characteristics of farmers; and apparent per capita food consumption.

This section brings together most of the statistics dealing with the activities of the agricultural and food industries in Canada. Statistics on field crops, fruit and vegetable production, livestock and animal products and farm income are found within this section.

1. Crops

The data collected by this survey are part of supply-disposition statistics of major grains and allow the calculation of the domestic disappearance of grains for human and industrial uses. They are also required to verify grain production and farm stocks data. The information is used by the federal and provincial governments, as well as grain millers, farmers and other private businesses for the purpose of market research and consultation

2. Farm Finance

Farm cash receipts represent the cash income received from the sale of agricultural commodities as well as direct program payments made to support or subsidize the agriculture sector. The primary reason for compiling farm cash receipts is to estimate, on a provincial basis, the agriculture sector's contribution to gross domestic product. Consequently, all inter-farm sales within a province are excluded from farm cash receipts estimates, as their inclusion would result in double counting. It should be noted, however, that farm-to-farm sales between provinces are included as are all sales outside the sector.

The data are used by all levels of government, government agencies, the industry and individuals in assessing trends within the industry. The survey was developed to fill a data gap within a growth industry.

II - 1 BANKING AND FINANCE

This section provides data on the financial transactions of Industrial Corporations by size and industry as reflected on the balance sheets and statements of income, retained earnings, statement of change in financial position and selected ratios. Statistics are derived from a quarterly survey of financial statements. Similar financial statistics covering Financial Institutions are also included in this section. There are also data on Government Finance, Employment and Payrolls. Statistics derived from the application of the Corporations Returns Act, (CRA) include information on major financial characteristics, degree of concentration and foreign control. This section also contains the statistics used in the preparation of the Bank of Canada Review, mostly made up of data series on activities of financial institutions and financial markets and some general economic and international statistics.

1. Quarterly Financial Statistics for Enterprises (61-008-XPB)

The data collected by the Quarterly Survey of Financial Statistics for Enterprises (QFS) comprise financial statements typically prepared by incorporated businesses to record their financial position and performance. The data include asset, liability and equity items encompassed in a quarterly balance sheet. As well, revenue and expense items as reported on a quarterly income statement, along with additional supplementary items, are collected on the quarterly survey. Information collected as part of the Quarterly Survey of Financial Statistics for Enterprises provides data to serve two broad objectives. The first is to measure the financial position and performance of incorporated businesses by industry aggregations. This is the main focus of this publication. It is analogous to the use made of the financial statements for individual businesses by managers, investors and lenders. The statistics are used by a wide variety of economists and industry analysts, including federal and provincial regulatory bodies that monitor financial and other institutions in Canada. This information is also a critical input into the measure of corporate profits and capital consumption allowances in the Canadian System of National Accounts (CSNA).

The second broad objective is to provide information on financial holdings and transactions in the CSNA sector accounts. The accounts comprise the National Balance Sheet Accounts and the Financial Flow Accounts. Within the CSNA, the domestic economy is composed of several sectors, including the non-financial business sector, the financial business sector, the government sector, and the persons and unincorporated business sector, which includes non-profit institutions serving households. The quarterly survey data (used to prepare this publication) are combined with additional information for the business and other sectors in order to produce complete economy-wide accounts which show the creation and distribution of wealth as well as the financing of economic activity. This is made possible by presenting considerable detail on financial institutions within the sector accounts framework. In addition, the flow of funds and outstanding positions between Canadian residents and non-residents is measured in Canada's Balance of International Payments and in Canada's International Investment Position, respectively.

Annual estimates of Capital and Repair Expenditures on construction for up to 70 different structure types, by province and industrial sector, are included. The results of the Investment Intentions Survey from about 22,000 respondents in Canadian businesses, institutions and others provide the estimates for total outlay for construction and for acquisition of producers' machinery and equipment. Housing starts, building permits and shipments of building materials complete the offering.

1. National Wealth and Capital Stock

This program produces annual estimates of gross and net capital stocks and depreciation by industry, and by province and territory. The estimates are produced for building, engineering and machinery and equipment asset groupings. The estimates are available historically in constant, current and original (book value) dollars.

5. Building Permits (64-002-XPB)

The purpose of the monthly survey of building permits issued by Canadian municipalities is to collect data (values and number of dwellings) on construction intentions. Since the issuance of a building permit is one of the first steps in the construction process, these statistics are widely used as a leading indicator of building activity. The statistics on building permits are essential for the computation of residential capital expenditures; and inputs for the quarterly and annual estimates of net capital stock and depreciation by component, and by province and territory. The statistics on building permits are also a major indicator in the computation of non-residential capital expenditures on a sub-annual basis. Furthermore, the results of this survey are used by C.M.H.C. (Canada Mortgage and Housing Corporation) as a reference base for conducting a monthly survey of housing starts and completions in accordance with its mandate.

V - 1 LABOUR AND INCOME

This section conducts statistical programs of household surveys such as the Labour Force Survey, the surveys of income and expenditure, and establishment-based surveys of employment. The data originate from various sources. From a sample of approximately 62,000 households, the Labour Force Survey provides basic labour force characteristics data by sex, age, marital status and geographical areas. The Survey of Employment, Payroll and Hours a mail survey of firms, institutions and organizations of all sizes, measures the levels and changes in employment, paid hours and earnings. These statistics are available at detailed industrial and geographic levels. The rest of the section contains statistics derived primarily from administrative sources and covers such topics as labour income, wage developments from collective agreements, government employment, and unemployment insurance statistics.

1. Labour Force Survey (LFS)

The Labour Force Survey provides estimates of employment and unemployment which are among the most timely and important measures of performance of the Canadian economy. With the release of the survey results only 13 days after the completion of data collection, the LFS estimates are the first of the major monthly economic data to be released. The Canadian Labour Force Survey was developed following the Second World War to satisfy a need for reliable and timely data on the labour market. Information was urgently required on the massive labour market changes involved in the transition from a war to a peace-time economy. The main objective of the LFS is to divide the working-age population into three mutually exclusive classifications - employed, unemployed, and not in the labour force - and to provide descriptive and explanatory data on each of these. LFS data are used to produce the well-known unemployment rate as well as other standard labour market indicators such as the employment rate and the participation rate. The LFS also provides employment estimates by industry, occupation, public and private sector, hours worked and much more, all cross-classifiable by a variety of demographic characteristics. Estimates are produced for Canada, the provinces, and a large number of sub-provincial regions. For employees, wage rates, union status, job permanency and workplace size are also produced. For a full listing and description of LFS variables, see the Guide to the Labour Force Survey.

These data are used by different levels of government for evaluation and planning of employment programs in Canada. Regional unemployment rates are used by Human Resources Development Canada to determine eligibility, level and duration of insurance benefits for persons living within a particular employment insurance region. The data are also used by labour market analysts, economists, consultants, planners, forecasters and academics in both the private and public sector. The LFS covers the civilian, non-institutionalised population 15 years of age and over. Excluded from the survey's coverage are residents of the Yukon, Northwest Territories and Nunavut, persons living on Indian Reserves, full-time members of the Canadian Armed Forces and inmates of institutions. These groups together represent an exclusion of less than 2% of the population aged 15 and over.

2. Employment Earnings and Hours (NAICS)

The Survey of Employment Earnings and hours (Survey number 2612) is produced from the combination of the Business Payroll Survey (Survey number 2614) results and the payroll deductions administrative data received from Canada Customs and Revenue Agency's. The survey of Employment, Payrolls and Hours is Canada's only source of detailed information on the total number of paid employees, payrolls, hours at detailed industrial, provincial and territorial levels. In addition to providing the principal input to Labour Income estimates, it also serves as a proxy output measure for about 15% of Real and Gross Domestic Product. The data are also used by the private sector for contract escalation and wage rate determination, by Canada Customs and Revenue Agency (CCRA) to revise the maximum pensionable earnings and retirement savings plan contribution limits. This survey collected information on employees, payrolls, hours and on each component of employee compensation, percentage of employees 'exposed' to each type of employer expenditure and union membership.

6. Estimates of Trusteed Pension Funds.

It is an ongoing survey conducted by Statistics Canada since 1972 to meet the requirements of the Balance of Payments of the Canadian System of National Accounts (BOP). Through the years, questions directed at collecting detailed characteristics of travellers for market research and industry planning were gradually incorporated in the survey. Today, the ITS provides a full range of statistics on the volume of international travellers and detailed characteristics of their trips such as expenditures, activities, places visited and length of stay. The Questionnaires part of this survey cover both Canadian residents returning from trips outside Canada and international visitors to Canada. In addition to fulfilling BOP requirements, the information collected by questionnaires is used by the Tourism Satellite Account (TSA), Customs Canada, the Canadian Tourism Commission (CTC), provincial tourism agencies, the United States Department of Commerce and a number of private sector industries. The information is also used for reporting to international organizations such as the World Tourism Organization (WTO), the Organization for Economic Co-operation and Development and the Pacific-Asia Travel Association.

These respondents, represent either independent municipal police departments or police detachments of federal (RCMP) or provincial police services (Ontario Provincial Police, Surete du Quebec or Royal Newfoundland Constabulary) across Canada. This continuous survey measures and publishes annual data on the nature and incidence of crime and traffic enforcement in Canada. Aggregate data (UCR1) on police-reported crime have been collected since 1962 through the UCR Survey. In 1984, development of the microdata Revised UCR Survey (UCR2) began, with the first respondent reporting incident-based data in 1988. The revised survey collects much more detailed offence and accused information and collects victim characteristics in cases of violent offences. As of January 2001, 166 police forces/detachments were providing incident-based crime data, representing approximately 53% of the national volume of crime.

Data collection for the Transition Home Survey (THS) was undertaken during 1998. The fourth cycle of this survey captured aggregate data and snapshot information for April 20, 1998. Information was collected on the characteristics of the facilities and the services dispensed during the previous twelve months. The survey also provides a one-day snapshot of the characteristics of women and children residing in the shelters on April 20, 1998. The objective of the Transition Home Survey (THS) is to collect data on residential services for abused women and their children during the previous 12 months, as well as to provide a one-day snapshot of the clientele being served on a specific date. The survey is funded by the Federal Family Violence Initiative. Historically, information about transition homes was collected by the Residential Care Facilities (RCF) Survey. However data collected from the RCF were very limited. In 1991/92, the Transition Home Supplement to the RCF Survey was developed as an interim survey in response to information needs under the Federal Family Violence Initiative. In 1992/93, 1994/95, 1997/98 and 1999/2000, the Transition Home Survey was conducted as an independent survey.

These are Statistics Canada's most recent population projections for Canada, the provinces and territories. They supersede the previous ones which were released in 1985. They are generated by the Statistics Canada Population Projection Model (SCPM) using different hypotheses regarding future trends in fertility, mortality, immigration, emigration and interprovincial migration, presented here, from Projection 1 to Projection 4; the base population is the 1989 post-censal estimate population by age and sex. More information about the general methodology and assumptions is given in Population Projections for Canada, Provinces and Territories, 1989-2011, (91-520-XPB), Occasional (March 1990). Data on components of growth are also contained in the Publication (91-520-XPB) as well as extensions of these projections at Canada level up to 2036. In addition, Statistics Canada's projection model is capable of producing customized population, household and family projections and simulations based on user-specified input assumptions. In addition, the data helps in the preparation of population projections by Statistics Canada, where estimates of population by age and sex are used as the base population. Estimated population counts play a vital role under the "Federal-Provincial Fiscal Arrangements and Federal Post-Secondary Education and Health Contributions Act" and the "Canada Student Loans Act" in determining the amounts of federal-provincial/territorial transfers

The most familiar item is the Consumer Price Index which is a measure of percentage change through time of the cost of a constant basket of goods and services representing the purchases made by a subset of the population in a specified time period. Also included in this section are the Industry Price Indexes for twenty-two major industries in the manufacturing sector. Construction Price Statistics contain price indexes of inputs into construction, contractors selling prices and special purpose aggregations of price indexes for construction and machinery and equipment relating to specified categories of capital expenditures.

1. Consumer Price Index (62-001-XPB) (62-010-XPB)

The Consumer Price Index (CPI) is a general indicator of the rate of price change for goods and services bought by Canadian consumers. It is obtained by comparing, through time, the cost of a fixed basket of commodities purchased by Canadian consumers in a particular year. Since the basket contains commodities of unchanging or equivalent quantity and quality, the index reflects only pure price movements.

The System of National Accounts provides a conceptually integrated framework for the systematic recording of activities within the Canadian economy. The System consists of several parts. Data on Gross Domestic Product by industry provide measures of the output of each industry in the economy. The Income and Expenditure Accounts show how incomes are earned in the course of production and how they are spent. The Financial Flows Accounts comprise the aggregate records of financial transactions in the economy. The Balance of International Payments provides detail on our financial dealings with the rest of the world. The Input-Output Tables are a major integrating element of the system. They show the source of inputs and the purchasers of outputs by industry, and by final demand category. Aggregate Productivity Measures relate inputs to outputs, while Current Economic Analysis brings together selective indicators for evaluating the course and pattern of economic developments in Canada. Also included in this section are matrices demonstrating Interprovincial Trade Flows and selected data from the Human Activity and Environment area.

1. National Income and Expenditure Accounts (13-001-XPB), (13-201-XPB)

The Income and Expenditure Accounts are the centre of macroeconomic analysis and policy-making in Canada. They are used in a broad assortment of applications by a wide range of persons and groups in society. They are a means by which Canadians can view and assess the performance of the national and provincial economies. The accounts provide both a planning framework for governments and a report card on the results of the plans that governments carry out.

The Canadian Input and Output tables are rectangular. At the most detailed level, they consist of 243 industries by 679 commodities (including primary inputs, and various margins). Each cell of information in the Input table contains the dollar value of the parts, services, raw materials or labour used up in the production process of the associated industry. The Input table provides a detailed decomposition of the total production costs. The Output table works in a similar manner, but provides a detailed breakdown of the individual goods and services comprising the industry total output. The Final Demand table gives detailed information on goods and services that are bought by many categories of buyers (consumers, industries and government) for both consumption and investment purposes. The Final Demand table includes inventories, imports, exports and non-tax government revenues. Outputs and Intermediate Inputs (aggregation-s, current dollars), annual, in millions of dollars by commodity for: Canada Level and Provincial Level.
