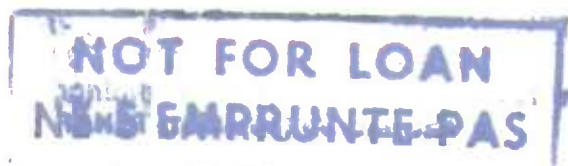

## INDUSTRY CLASSIFICATIONS

### STANDARD INDUSTRIAL CLASSIFICATION 1980 (SIC-E)

The SIC-E is a system for classifying establishments according to their primary activity. It is used to facilitate the collection, tabulation, presentation and analysis of production and related data. As a reference manual, the SIC-E provides a classification structure; a classified index which includes industry definitions and examples to clarify the content of each industry; an alphabetical index, comparison tables between this and the previous SIC; as well as an introduction specifying the concepts and definitions underlying the classification and providing a user's guide to the interpretation of the classification. ### CANADIAN STANDARD INDUSTRIAL CLASSIFICATION FOR COMPANIES AND ENTERPRISES 1980 (SIC-C)

The SIC-C is a system for classifying companies and enterprises according to the activity(ies) in which they are engaged and the organization of these activities. It is intended to facilitate the collection, tabulation, presentation and analysis of financial and related data. As a reference manual the SIC-C provides a classification structure, a classified index which includes the definition of subsegments and examples to clarify the content of each subsegment, an alphabetical index and comparison tables between this classification and the establishment based classification (SIC-E 1980). ### CODING MANUAL

This enables users to give SIC-E codes to businesses and establishments given a description of their activity and goods or services produced. This manual includes approximately 18,000 descriptions of pre-coded economic activities in alphabetical sequence. Each description is coded to the 1970 and 1980 Standard Industrial Classifications of Canada and the 1977 United States Standard Industrial Classification. The user can choose to order a manual containing any one or two of the above classification codes. The manual is particularly useful for those who wish to code individual records (e.g. the records of a client list) and to update or convert such records. It is available in hard copy, on diskettes or magnetic tape. Manuals are available in English or French.

The tables show the relationship between the four levels of the two classifications. The explanatory notes describe the assignment of the activities of an industry class when it relates to more than one class of the other classification.

## COMMODITY CLASSIFICATIONS

Beginning with 1988 data, commodity imports, exports and those reported in the Annual Survey of Manufacturers were classified according to the Standard Classification of Goods (SCG), a commodity classification, based upon the international Harmonized Commodity Description and Coding System (HS). Other commodity series are adopting the SCG as resources permit. The SCG is an expansion of the HS to identify commodities of particular significance in the Canadian economy.

### STANDARD CLASSIFICATION OF GOODS 1992

The Standard Classification of Goods (SCG) is available in the form of a manual. The Standard Classification of Goods is of particular interest to market researchers who need to know the level of detail for which import, export and shipment data are collected. ## **OCCUPATIONAL CLASSIFICATION**

These classifications were designed for use in statistical surveys. Both the Standard Occupational Classification (SOC) 1980 and 1991 have been implemented in the 1991 Census of Population. The 1991 SOC will eventually be implemented in other Statistics Canada surveys as a replacement to the 1980 SOC.

### **STANDARD OCCUPATIONAL CLASSIFICATION 1991**

The Standard Occupational Classification (SOC) 1991 is a revision of the 1980 Standard Occupational Classification, but is based on the National Occupational Classification developed by Employment and Immigration Canada. It is designed for use in statistical surveys including the Census of Population. The manual is available in English or French. It will be released in July, 1993.
