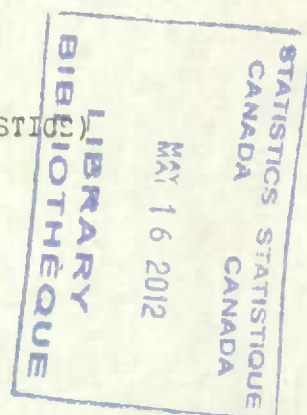

E. Manufactures

1. Vegetable Products

10. Coffee, Cocoa and Spices

100 Cocoa and Chocolate.

Includes cocoa, sweetened or unsweetened chocolate, but not bonbons, except where secondary in value to above products.

101 Coffee and Spices.

Includes establishments engaged in grinding or roasting coffee, spices, and peanuts.

11. Fruit and Vegetable Preparations

110 Fruits and Vegetables, Canned, Evaporated and Preserved.

Includes canned fruit, tomatoes, pork and beans, and other vegetables; dried and evaporated fruits, dried and evaporated vegetables and crystallized fruits; grapes and other jams, apple butter, fruit jellies, marmalade and mincemeat.

113 Pickles, Vinegar and Cider.

Includes pickles, sour and sweet, catsup, chow-chow, worcester, other sauces and relishes, and establishments engaged in the manufacture of vinegar and cider.

12. Flour and Cereals

120 Malt Mills.

Includes barley malt, malt extracts and malt flour.

121 Rice Mills.

Includes cleaned and polished rice, rice meal and flour.

122 Flour Mills.

Includes establishments manufacturing flour or flour and other cereals, or custom grinding of wheat.

123 Feed and Grist Mills.

Includes establishments only manufacturing other cereals (oatmeal, rolled oats, cornmeal, etc.) than flour, custom and merchant grinding of other grains than wheat.

13. Prepared Grain Foods and Confectionery

130 Bread and other Bakery Products.

Includes brown, white and fancy bread, buns, pies, cakes, cookies, and puddings.

131 Biscuits, Confectionery and Chewing Gum.

Includes plain and fancy biscuits, bon-bons, candy and chocolate, chewing gum. Ice cream may also be included as a subsidiary product.

133 Ice Cream Cones.

134 Macaroni and Vermicelli.

Includes macaroni, spaghetti and vermicelli.

139 Miscellaneous Food Products.

Includes cooked and prepared breakfast foods, prepared or proprietary stock and poultry foods, corn self-raising and other prepared flour, nut preparation, etc.

14. Liquors

140 Breweries.

Includes beer, porter and stout.

141 Distilleries.

Includes whiskey, brandy, rum, gin, liquors and high wines.

142 Wines and Grape Juice.

Includes grape juice and wines, fermented or unfermented, but not high wines.

Includes muff beds, comforters, quilted linings and pads.

32. Woollen Textiles

320 Woollen Cloths.

Includes cashmere, serges, tweeds, overcoatings, mackinaws, and flannels, but excludes knitted goods as chief product.

321 Woollen Yarns.

322 Carpets, Mats and Rugs.

3220 Carpets, Mats and Rugs, n.e.s.

Includes jutes and cocoa fibre mats, matting, rugs, axminster, wilton, brussels, tapestry, or oriental carpets and rugs made of wool and cotton, cork or linoleum.

3221 Custom and Rag Carpets.

Includes firms making new rugs and carpets from old carpets and making rag carpets and rugs.

329 Woollen Goods, Miscellaneous.

3290 Wool Fulling.

Includes firms engaged in detaching wool from hides and skins.

40. Pulp and Paper Mills

400 Pulp and Paper.

4000 Pulp Mills.

Includes wood pulp, chemical and mechanical.

4001 Combined Pulp and Paper Mills.

Includes chemical and mechanical wood pulp paper of all kinds, straw and other boards, roofing felts and other building paper.

4002 Paper Mills.

Includes paper of all kinds, roofing felts and other building paper, straw and other paper boards.

41. Paper Goods

410 Roofing and Building Paper Wallboard.

Includes felt and paper roofing, treated with asphalt, tar, rubber or oil: laminated wall board, beaver board, building paper treated.

411 Paper Boxes and Bags.

Includes paper bags, boxes and cartons, folding, collapsible, or stiff, cardboard, corrugated board, fibre, and spiral wound paper containers.

412 Stationery Goods.

Includes writing tablets, note paper and envelopes.

413 Wall Paper.

414 Paper Goods, n.e.s.

Includes fly paper, paper patterns waxed and oiled paper, blue print paper, milk bottle caps and photo mounts.

42. Printing, Publishing and Lithographing

420 Printing and Bookbinding.

Includes job printing, counter check book, ruling loose leaf systems, blank books and book binding.

421 Printing and Publishing.

Includes newspapers, periodicals, etc. which do their own printing.

422 Lithographing and Engraving.

Includes calendars, advertising show cards, greeting cards, playing cards, and map-making.

423 Stereotyping and Electrotyping.

Includes typesetting.

424 Blueprinting.

43. Saw and Planing Mills

430 Sawmills.

Includes rossed pulpwood, sawn timbers, products of stave, heading or hoop and veneer mills, and lumber, lath and shingles.

431 Sash Door and Planing Mills.

Includes sash, doors, frames, blinds, millwork, molding, matched and planed lumber.

4. Wood and Paper Products - Cont'd

44. Furniture

440 Furniture

Includes show cases and store fixtures, wickerware, upholstered furniture, camp chairs, beds, school, church and office furniture, and repairs and upholstering.

45. Vehicles, Chiefly of Wood.

450 Carriages, Wagons and Sleighs.

451 Carriage and Wagon Materials.

Includes wheels, runners, spokes, wheel rims, shaft splices, carriage woodwork, seats, wagon boxes and buggy bodies.

46. Containers.

460 Cooperage.

Includes barrels and tubs and all kinds of tight cooperage and stock.

461 Boxes, Baskets and Crates.

Includes boxes and containers, box shooks, fruit and vegetable baskets and crates, berry boxes, cheese boxes, cigar boxes, etc.

462 Woodenware.

Includes articles made almost entirely of wood and used in kitchens, bakeries, dairies, etc., such as pails and tubs, clothespins, washboards, toothpicks, skewers, ladders, etc.

47. Wood-Working and Turning

470 Handles, Spools and Wood-Turning.

Includes spools, bobbins and shuttles, axe and long tool handles, insulator pins and brackets, small tool handles, dowels, and all other wood-turning.

471 Sporting Goods.

Includes billiard and pool tables, hockey sticks, bowling alley construction, tennis and other racquets and billiard room supplies.

49. Miscellaneous

492 Boatbuilding.

Includes canoes, rowboats and launches and other smaller wooden vessels and pleasure craft.

494 Lasts, Trees and Shoe Findings.

Includes lasts, trees, pegs, shanks, heels and other wooden shoe findings.

495 Coffins and Caskets.

497 Excelsior.

Includes excelsior and wood wool.

499 Miscellaneous Wood-Using Industries.

Includes beekeepers' and poultrymen's supplies, wooden piping, foundry patterns, pulleys, children's toy vehicles, wooden pumps, baby carriages and sleighs, wooden rules and spinning wheels; also wood preservation.

5. Iron and Its Products

50. Furnaces and Rolling Mills.

- 500 Pig Iron and Ferro-Alloys, Steel Ingots and Castings, and Rolled Iron and Steel Products.
5000 Pig Iron and Ferro-Alloys.
5001 Steel Ingots and Castings.
5002 Rolled Iron and Steel Products.
Includes the hot and cold rolling of steel into blooms, billets, rails, bars, rods, etc.

51. Castings and Forgings.

- 510 Castings and Forgings.
Includes stoves, furnaces and other heating equipment, iron pipe and fittings, steel tubing, etc., and miscellaneous castings and forgings made to order, but excludes repair shops.

52. Machinery, Boilers and Engines

- 520 Boilers, Tanks and Engines.
Includes heating and power boilers, storage tanks, pressure tanks, steam, gasoline and other engines, pumps, smokestacks, etc.
521 Agricultural Implements.
Includes only plants making agricultural implements and machinery as main products.
522 Machinery.
Includes machinery other than agricultural implements, such as household machinery, pulp and paper machinery, woodworking machinery, elevators, water-wheels and turbines, and mining and metallurgical machinery.

53. Vehicles, principally of Iron and Steel.

- 530 Automobiles.
Includes passenger cars and commercial automobiles, and parts made by automobile manufacturers.
531 Automobile Parts and Accessories.
Includes industries manufacturing automobile parts and accessories as main products, such as auto wheels, rims, axles, trailers, springs, bodies, covers, tops, tire and luggage carriers, etc.
532 Bicycles.
Includes bicycles and motorcycles for men, women and children, tricycles and miscellaneous bicycle parts.

54. Railway Rolling Stock

- 540 Railway Rolling Stock.
Includes steam and electric cars, locomotives, and parts such as car wheels, brakes, tires, and larger shops of Canadian National and Canadian Pacific Railways repair shops.

56. Wire and Wire Goods

- 560 Wire and Wire Goods.
Includes the drawing of wire from rods, the production of nails and spikes, brads and tacks, staples, etc; the fabrication of woven wire products, such as fencing, gates, wire cloth, screens, etc; and the manufacture of springs, chains, rope and cable, hoops and similar articles.

57. Sheet Metal Products

- 570 Sheet Metal Products.
Includes tin cans, sheet metal building material, baths, sinks, galvanized sheets, auto stampings and tinware, etc.

5. Iron and Its Products - Cont'd

58. Hardware and Tools

580 Hardware and Tools.

Includes bolts, nuts and rivets, safety razors, blades and strops, saws and parts, spades, shovels, forks, hoes, rakes, etc., builders' hardware, axes, files and rasps, etc.

59. Miscellaneous

590 Miscellaneous Iron and Steel Products.

Includes structural steel work, ornamental iron work, railway track equipment, safes and steel boxes, metal furniture, etc.

6. Manufactures of the Non-Ferrous Metals

61. Aluminium Products

610 Aluminium Products.

Includes the manufacture of aluminium kitchen utensils and other fabricated products.

62. Brass and Copper Products

620 Brass and Copper Products.

Includes the rolling and casting of copper, brass and bronze and the fabrication of brass and copper products, such as castings and machinery fittings, brass, bronze and copper rods, plates, sheets and wire.

63. Lead, Tin and Zinc Products

630 Lead, Tin and Zinc Products.

Includes the manufacture of babbitt metal, lead bar and pipe, solders, lead, tin and zinc produced from scrap metal, collapsible tubes, phosphor-tin, and similar products.

64. Precious Metal Products

640 Precious Metal Products.

Includes the manufacture of silverware, production of dental supplies, jewellery, clocks and watches, and other articles of gold, silver and platinum.

65. Electrical Apparatus

650 Electrical Apparatus and Supplies.

Includes apparatus and supplies used in the transmission, generation and utilization of electrical energy, such as radio apparatus, telephone material, generators and motors, incandescent lamps, vacuum cleaners, etc.

69. Miscellaneous Non-Ferrous Metal Products

690 Miscellaneous Non-Ferrous Metal Products.

Includes lamps, lanterns, lamp and lantern burners, weather-stripping, and similar products.

Also in any compilation of manufactures the Non-Ferrous Smelt Industry, classified under "Mining", is included in the main group of "Manufactures of the Non-Ferrous Metals".

C.170 Non-Ferrous Smelting and Refining Industry.

Includes metallurgical industries operating mainly on Canadian ores, such as the smelting and refining of copper ores, silver-lead-zinc ores, nickel copper ores, silver-cobalt ores and the smelting of imported bauxite ores for aluminium ingots and bags, but excludes milling cyaniding of gold and silver ores which is included with mining operations owing to the difficulty of drawing the line of demarcation.

7. Manufactures of Non-Metallic Minerals

70. Asbestos and Allied Products

700 Asbestos and Allied Products

Includes asbestos packing, brake linings, pipe covering, paper sheathings, shingles and lumber, and magnesite stucco and flooring.

71. Coke and its By-Products

710 Coke and its By-Products.

Includes coke produced in beehive and by-product ovens, but excludes coke produced as a by-product in the manufacture of illuminating and fuel gas and in the refining of petroleum.

72. Illuminating and Fuel Gas.

720 Illuminating and Fuel Gas.

Includes coal gas, water gas, pintsch oil gas and acetylene gas, but excludes gas recovered as a by-product in the manufacture of coke and in the refining of petroleum.

73. Glass and its Products

730 Glass.

7300

Pressed and Blown Glass.

7301

Bevelling, Cutting and Bending of Imported Glass.

Includes leaded glass, ornamental glass, memorial windows, mirror plate, etc.

74. Imported Clay Products.

740 Imported-Clay Products.
