

FOREWORD

The data in the present Abstract of Empire Trade have been compiled for the use of the Imperial Economic Conference, 1932. According to the latest complete statistics available, viz.: 1930, the British Empire transacts from 28 to 29 per cent of the total trade of the world, the proportion for import trade amounting to about 30 per cent, and of export trade to about 26 per cent.

Table I presents a conspectus of world trade, both import and export, and the position the British Empire occupies in that trade. In the year 1930 the United Kingdom occupied first place in total world trade, being first in imports and third in exports; the United States second place, being second in imports and first in exports; Germany third place, being third in imports and second in exports; France fourth, in both imports and exports; and Canada fifth place, being fifth in imports and sixth in exports, British India occupying fifth place. The data in the following table illustrate this point.

Table II sets forth the imports of the British Empire for the year 1930, with the proportion of that trade with Empire countries, the United Kingdom, Canada and the United States, as well as the per capita figures and percentages of the import trade, not only for each unit of the Empire, but for each continent. In 1930, 36·0 per cent of the imports into the British Empire was from Empire countries, while the percentages of the import trade transacted by Empire countries in each continent with the Empire were: Europe, 31·8; North America, 26·3; South America, 75·9; Asia, 39·3; Africa, 61·1; and Oceania, 59·6. The statistics in the following table show for 1930 the percentages of the imports into Empire countries from Empire and foreign countries, arranged by continents:

Table III presents the exports of the British Empire with the proportion of the export trade with the Empire, the United Kingdom, Canada and the United States for the year 1930, as also the per capita and percentages of the export trade for each unit of the Empire, and for each continent as well. During the year 1930, 46·7 per cent of the exports from the British Empire was to Empire countries; while the percentages of the exports of Empire countries by continents with the Empire were: Europe, 47·1; North America, 36·8; South America, 68·5; Asia, 34·8; Africa, 69·8; and Oceania, 67·1. The statistics in the following table indicate the percentages of the exports from Empire countries to Empire and foreign countries by continents, 1930.

Table IV presents the total imports and exports of the principal Empire countries for the years 1913, 1921, 1926 and 1930, indicating the amount and percentage of the imports from and exports to (a) the British Empire and foreign countries; (b) the United Kingdom and other Empire countries; and (c) the United States and other foreign countries; while Table V sets forth the total imports and exports of the United Kingdom, the Dominions and India for the years 1921 to 1930 (or 1922 to 1931) indicating the amount of the imports from and exports to (a) All countries; (b) the British Empire; (c) foreign countries; and (d) principal countries with which these various British countries have exchange of commodities.

Table VI gives for each principal Empire country the import and export trade in certain leading staple products for the year 1930, indicating for each, the imports from and exports to (a) All countries; (b) the British Empire; and (c) the several Empire countries listed.


The charts in this statistical abstract have been designed to illustrate the general progress of Empire trade in its relation to world trade.

INTRA-EMPIRE TRADE SHOWN THUS:



EXPORT TRADE


