

GLOSSARY

Initial proposal community's statement on whether or not to explore the option of establishing a new legislative base for community government. If sufficiently developed, a "framework proposal" is developed by the community which sets out what it wishes to put in place of the existing arrangements. Framework submission sets out what the community wishes to put in place beyond the Indian Act, the proposed changes to its governing structures and the new legislative arrangements sought to enable these changes; a workplan and budget for substantive negotiations and the ratification process for any agreements. community provides information clarifying and elaborating the framework Framework documentation submission. Discussion paper the community and the federal government enter into a process of clarification and further development to the framework submission and documentation. Framework agreement a mutually acceptable document that describes the arrangement which the negotiations will attempt to put in place in each subject area, as well as establishing a schedule and workplan for the negotiation process. Substantive negotiations the community and the federal government work out in detail all aspects of the proposed new arrangement and determine what specifically will be required to put them into effect. The result is an "Agreement" which is submitted to community members and Cabinet for formal ratification. Workshop meeting held by a community or communities to explore and discuss selfgovernment issues.
