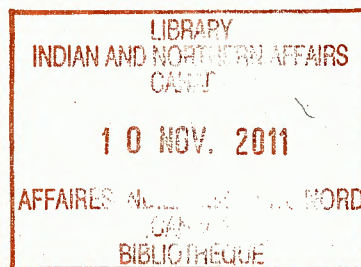

Hon. Adams George Archibald

- b. Truro, N.S. - 18 May, 1814
- Solicitor - Gen'l of N.S. - 14 Aug. 1856 - 14 Feb. 1857
- Att. - Gen'l of N.S. - 10 Feb. 1860 - 11 June 1863
- 1 July 1867 - Sect. of State for the Provinces
- May, 1870 - May, 1873 - Lieut.-Gov. of Man. and the North West Territories
- concluded treaties 1, 2 with the Chippewa and Swampy Cree Indians
- 24 June, 1873 - appointed Judge in Equity of N.S.
- 4 July, 1873 - became Lieut. - Gov. of Nova Scotia

Hon. Alexander Morris

- b. Perth, Upper Can. 17 Mar., 1826
- graduate of McGill University
- 1861 - elected to Legisl. Assembly for South Lanark
- Nov. 1869 - became Minister of Inland Revenue
- resigned 1872 - due to poor health
- appt'd Chief Justice of Manitoba
- during absence of Lieut. - Gov. Archibald he was appointed Administrator of the Province
- 5 Dec. 1872 - became Lieut. - Gov. of Man. & N.W.T.
- on its creation, became Lieut. - Gov. of Keewatin
- 16 June, 1873 - appt'd Chief Supt. of Indian Affairs in the Manitoba Superintendency
- one of commissioners who negotiated Tr. 3, 4, 5, and 6; revised Nos. 1 & 2
- 1876, Jan. - appointed Commissioner under 38 Vict. ch. 53 to deal with conflicting claims to lands of occupants in Manitoba.
