



NEW MEXICO'S PROFILE

Economic Indicators

- Gross domestic product (GDP): US\$93.3 billion (2016)
- GDP per capita: US\$44,800 (2016)
- Population: 2.1 million (2016)
- Merchandise exports to New Mexico: 49th among the 50 U.S. states (2016)
- Merchandise imports from New Mexico: 49th among the 50 U.S. states (2016)
- Estimated number of New Mexico jobs that depend on trade with Canada: 38,900 (2013)
- Best States for Infrastructure ranking: 38th among the 50 U.S. states (2017)
- Canada's ranking as a destination for New Mexico's international merchandise exports: 5th (2016)



NOTES

All figures were prepared using Statistics Canada customs-based merchandise trade data available in spring 2017.

All dollar amounts are in Canadian dollars unless otherwise noted.

Definitions appear at the end of this profile.

The five most highly valued merchandise export and import categories have been identified based on 2016 values. In the Economic Indicators section, data for GDP are from the U.S. Bureau of Economic Analysis, Canada's ranking as a destination for the state's international merchandise exports and data on population are from the U.S. Census Bureau, the ranking of the state as a destination for Canadian merchandise exports and a source of Canadian merchandise imports is based on Statistics Canada data, and the best states for infrastructure ranking is from U.S. News & World Report. GDP per capita was calculated by dividing state GDP by state population. The estimated number of jobs that depend on trade with Canada is from Peter B. Dixon and Maureen T. Rimmer, The Dependence of U.S. Employment on Canada, 2013, 3 December 2014.

CANADA'S MERCHANDISE TRADE WITH NEW MEXICO




Bilateral merchandise trade in 2016: \$471.0 million

- Exports: \$359.5 million,
 a 28.4% increase from 2015
- Imports: \$111.5 million, a 5.4% decrease from 2015

Trade surplus in 2016: \$248.0 million, an increase from \$162.2 million in 2015

Share of the Total Value of Canadian Trade




Exports in 2016:

0.1% of the total value of Canadian exports to the United States, unchanged from 2015

Imports in 2016:

statistically insignificant share of the value of Canadian imports from the United States, unchanged from 2015

Share of Exports by Province/Territory




Highest-valued exporters in 2016:

- Ontario \$198.2 million, an increase from \$146.7 million in 2015
- Quebec \$48.0 million, an increase from \$31.6 million in 2015


Share of Exports by Sector



Exports in 2016:

- Resource-based goods 1.3%, a decrease from 1.9% in 2015
- Manufactured goods 98.7%, an increase from 98.1% in 2015


Most Highly Valued Exports by Product Category



Highest-valued exports in 2016: Certain chemical radioactive elements, isotopes, and their residues and compounds, and solid residues resulting from the extraction of vegetable fats or oils, together accounting for 26.5% of the total value of Canadian exports to New Mexico

- Certain chemical radioactive elements, isotopes, and their residues and compounds: \$66.0 million, an increase from \$1.7 million in 2015
- Solid residues resulting from the extraction of vegetable fats or oils: \$29.2 million, an increase from \$18.2 million in 2015

Share of Imports by Sector




Imports in 2016:

- Resource-based goods 9.2%, an increase from 8.7% in 2015
- Manufactured goods 90.8%, a decrease from 91.3% in 2015

Most Highly Valued Imports by Product Category




Highest-valued imports in 2016: Potassic fertilizers, and mattress supports, mattresses and bedding, together accounting for 33.4% of the total value of Canadian imports from New Mexico

- Potassic fertilizers:
 \$25.5 million, a decrease from
 \$27.3 million in 2015
- Mattress supports, mattresses and bedding: \$11.7 million, an increase from \$10.6 million in 2015

DEFINITIONS

Balance of trade: The trade balance is the difference between the value of exports and the value of imports. There is a trade surplus if the value of exports exceeds the value of imports. There is a trade deficit if the value of imports exceeds the value of exports.

Customs-based data: Customs-based data are compiled from declarations filed with the Canada Border Services Agency and are used to track the flow of goods into and out of Canada, with one exception: exports to the United States. Since 1990, customs-based data on Canadian exports to the United States have been based on declarations filed with U.S. Customs and Border Protection.

Gross domestic product (GDP): GDP measures an economy's total production in a given year. As one entity's income is another entity's spending, GDP is equal to the total value of final sales or to the total value of incomes.

Manufactured goods: Manufactured goods are finished or semi-finished products resulting from the transformation of materials and substances into new products (North American Industry Classification System, or NAICS, codes 31 to 33) and the output of establishments primarily engaged in operating electric, gas and water utilities (NAICS code 22).

Merchandise trade: Merchandise trade refers to trade in physical goods, such as cars, wheat and iron ore.

Resource-based goods: Resource-based goods are products of the agriculture, forestry, fishing and hunting sector (NAICS code 11), as well as the mining, quarrying, and oil and gas extraction sector (NAICS code 21).
