## FPCC meeting

#### December 14, 2017

The FPCC met in Ottawa on December 14, 2017, where Council members discussed various issues and received from FPCC staff an update on current files, including the Judicial Review in the Complaint against Turkey Farmers of Canada and the administrative review of the Agricultural Products Marketing Act.

Also at this meeting, members met with the Canadian Poultry and Egg Processors Council (CPEPC) to discuss industry concerns and upcoming challenges faced by their members in the poultry and egg sectors. The CPEPC were represented by the President and CEO, Chairman, Directors from the four sectors as well as CPEPC staff. They took this opportunity to discuss their membership and present their 2017 achievements, strategic plan and major activities for 2018.

In addition, the FPCC considered the following agencies' proposed regulatory amendments:

## Egg Farmers of Canada (EFC)

Council members approved the Canadian Egg Marketing Levies Order, the Canadian Egg Marketing Agency Quota Regulations, 1986 (schedules 1, 1.1 and 1.2), as well as EFC's Chairman and Directors per diem rates for travel and meeting attendance.

## Chicken Farmers of Canada (CFC)

Council members approved CFC's amendment to their By-Laws thereby increasing per diem rates and conference call fees for the Chairman and Directors.


# APMA UPDATE
