About the CPP

This publication is made available to all levels of government, social security organizations and private sector.

The Canada Pension Plan (CPP) which came into force on the 1st of January 1966 is a contributory, earnings-related social insurance program. It ensures a measure of protection to a contributor and their family against the loss of income due to retirement, disability and death. The plan operates throughout Canada except in Quebec which has its own similar program, the Quebec Pension Plan (QPP). The QPP is closely associated with the CPP and both plans are operated and coordinated through a series of agreements between the federal and Quebec governments.

The CPP covers nearly all employed and self-employed persons in Canada (except Quebec) who are at least age 18, and under age 70 and not in receipt of a retirement or disability pension under the CPP and who earn more than a minimum level of earnings in a calendar year.

In 2011, employees contributed 4.95 percent of covered earnings and their employer paid a matching contribution. Self-employed persons contributed at the rate of 9.9 percent on the same range of annual earnings. The Year's Basic Exemption (YBE) was \$3,500 for 2011 and the Year's Maximum Pensionable Earnings (YMPE), which is indexed to the average Canadian wage, was \$48,300 in 2011.

Contributions are made on the portion of an individual's annual earnings above the YBE and up to a ceiling known as the YMPE.

The data appearing in this publication were compiled as aggregates of records from the Record of Earnings file, which contains the information on the earnings and contributions of each contributor. The information in these tables should not be mistaken for contributor information available from income data, which includes other sources such as pensions, interest and other investment income. Individual details are held in strict confidence.

À propos du RPC

La présente publication est mise à la disposition de tous les ordres de gouvernement, des organismes de sécurité sociale et du secteur privé.

Entré en vigueur le 1er janvier 1966, le Régime de pensions du Canada (RPC) est un régime d'assurance sociale contributif fondé sur les gains. Il protège un cotisant et sa famille contre la perte de revenu attribuable à la retraite, à l'invalidité et au décès. Le Régime est applicable dans tout le Canada, à l'exception du Québec qui a un programme semblable, soit le Régime de rentes du Québec (RRQ). Le RRQ est étroitement lié au RPC et les opérations des deux régimes sont coordonnées par une série d'accords entre le gouvernement fédéral et celui du Québec.

Le RPC s'adresse à presque toutes les personnes salariées ou travaillant à leur compte au Canada (sauf au Québec) qui sont âgées d'au moins 18 ans, mais moins de 70 ans, qui ne reçoivent pas une pension de retraite ou d'invalidité du RPC et dont les gains, au cours d'une année civile, dépassent le niveau minimal des gains prévu.

En 2011, les employés ont versé une cotisation égale à 4,95 p. 100 de leurs gains assurés et leur employeur a versé une cotisation équivalente. Les travailleurs autonomes ont cotisé au taux de 9,9 p.100 sur la même tranche des gains annuels. En 2011, l'exemption de base de l'année (EBA) était de 3 500 \$. Le maximum des gains annuels ouvrant droit à pension (MGAP) lequel est indexé au salaire moyen au Canada était de 48 300 \$ en 2011.

Des cotisations sont prélevées sur la tranche des gains annuels d'un particulier compris entre l'EBA et un plafond prescrit qui est le MGAP.

Les données de la présente publication ont été compilées à partir de l'ensemble des inscriptions au Registre des gains; ce dernier contient les renseignements sur les gains et les montants des cotisations de chaque cotisant. Les renseignements fournis dans ces tableaux ne doivent pas être considérés comme provenant des données sur les revenus, qui comprennent d'autres sources telles que les revenus de pensions, d'intérêts et d'autres investissements. Les renseignements particuliers sont strictement confidentiels.

About this Report

The tables that follow include information on the number of contributors and the amount of contributions paid, distributed by gender, age, earnings level, employment status and by province. It should be noted that the amount of contributions excludes refunded contributions made through tax filing.

In addition to information on contributions to the Canada Pension Plan in the year 2011, this publication also contains historical data dating from 1966 on the most often requested information.

It should be noted that for the Canada Pension Plan Contributors Report 2011, the methodology has changed to better reflect the impact of refunds on the number of contributors and dollar amounts contributed. All historical tables have been refreshed using consistent methodology. Therefore, results in the 2011 Contributors Report will not match the data published in previous reports.

In order to ensure client confidentiality, an 'X' has been placed where the number of contributor is equal to or below 9. In order to avoid residual disclosure, an 'X' has also been placed where the next lowest number of contributors was found, which may be below, equal to, or above 9.

In tables where are identified by 'unknown' location, values under 10 are not suppressed. In previous Contributions Reports, these contributors were not included.

À propos du présent rapport

Les tableaux qui suivent contiennent des renseignements sur le nombre de cotisants et le montant des cotisations versées, selon le sexe, l'âge, le niveau des gains, l'état relatif à l'emploi et la province. Il est à noter que le montant des cotisations exclut le remboursement des cotisations effectué lors des déclarations des revenus.

En plus de présenter l'information sur les cotisations au Régime de pensions du Canada durant l'année 2011, cette publication contient des données historiques datant de 1966 sur les renseignements les plus en demande.

Le rapport des Cotisants du Régime de pensions du Canada 2011 utilise une nouvelle méthodologie afin de mieux refléter l'impact du remboursement des cotisations sur le nombre de cotisants et sur les montants cotisés au Régime. Tous les tableaux contenant des données historiques de 1966 à 2010 ont été révisés. Par conséquent, les données contenues dans ce rapport sont différentes de celles publiées dans les rapports précédents.

En guise de protection des renseignements personnels des cotisants, un « X » a été placé dans le cas où le nombre de cotisants est égal ou inférieur à 9. Afin d'éviter la divulgation par recoupements, un « X » a aussi été mis au nombre suivant de cotisants le moins élevé, lequel peut être inférieur, égal ou supérieur à 9.





Faits saillants :


Le nombre de cotisants au Régime de pensions du Canada (RPC) a augmenté de 1,1 p. 100 à 13,0 millions en 2011.




Le montant des cotisations versées au RPC s'est accru de 4,4 p. 100 en 2011 (37,9 milliards) comparativement à 2010 (36,3 milliards).




En 2011, 6,2 millions de femmes ont cotisé au Régime, ce qui représente une augmentation de 1,1 p. 100 (68 223). Le nombre de cotisants du sexe masculin, quant à lui, s'est élevé en 2011 à 6,8 millions, soit une augmentation de 1,1 p. 100 (76 344).




Parmi les provinces, l'Ontario a enregistré la plus forte augmentation du nombre de ses cotisants en 2011 (67 636) comparativement à 2010.



Les hommes âgés de 55 à 59 ans ont connu une augmentation de 3,8 p. 100 en 2011. Le groupe d'âge des 45 à 49 ans représente la plus forte proportion de cotisants de sexe masculin, cependant le nombre de cotisants a diminué de 2,0 p. 100 comparativement à l'année précédente.



Parmi les cotisants de sexe féminin, les femmes du groupe de 55-59 ans ont connu une forte augmentation de leur nombre, s'accroissant de 4,2 p. 100 en 2011. Le groupe d'âge 45-49 ans représente 13,2 p. 100 du nombre total de cotisants du sexe féminin, et représente le groupe d'âge le plus nombreux, et ce, depuis 2006.



Definitions and Terminology

Contributor:

To contribute to the Plan, a person must be at least age 18, under age 70, and not be in receipt of a retirement or disability pension under the Canada Pension Plan. In addition, earnings for the year must exceed \$3,500 or this amount adjusted in line with the portion of the year the individual was a contributor.

Employment Status:

A contributor having earnings only from salary and wages is considered an “employee”. Contributors having only earnings from self-employment are classified as “self-employed”. Contributors with both employment and self-employment earnings are classified as “mixed”.

Contributions:

In 2011, contributions were payable on earnings between \$3,500 and \$48,300 for both employees and the self-employed. Employees contribute at the rate of 4.95% with a matching contribution being made by their employers. Self-employed persons contribute at the rate of 9.9%. Thus, in 2011 the maximum contribution payable by an employee was \$2,217.60 and \$4,435.20 by a self-employed person.

Earnings:

Earnings are essentially salaries from wages of employees and earnings from self-employment on which CPP contributions are made. Earnings do not include income from investments or pensions. Beginning with the 2008 Contributors Report, tables containing the distribution by earnings level utilize contributors’ actual earnings for the calendar year. Previously, contributors who started to receive CPP benefits (Disability or Retirement) had their accumulated earnings up to that time prorated for the full calendar year in order to represent their earnings at the time benefits commenced. Due to processing modifications, this method can not currently be recreated.

Définitions et terminologie

Cotisant:

Pour être cotisant au Régime, une personne doit être âgée d’au moins 18 ans, mais de moins de 70 ans, et ne pas recevoir une pension de retraite ou d’invalidité du Régime de pensions du Canada. De plus, les gains pour l’année doivent être supérieurs à 3 500 \$ ou à ce montant ajusté en fonction de la partie de l’année pour laquelle le particulier a été cotisant.

État relatif à l’emploi:

Un cotisant est considéré comme étant «salarié» si ses gains proviennent seulement de traitements et de salaires. Un cotisant ayant des gains provenant seulement d’un travail à son propre compte est classifié comme étant «travailleur autonome». Si un cotisant a des gains provenant à la fois de traitements et de salaires ainsi que d’un travail à son propre compte, il est classifié comme étant «mixte».

Cotisations:

En 2011, les gains cotisables étaient les gains compris entre 3 500 \$ et 48 300 \$, tant pour les travailleurs salariés que les travailleurs autonomes. Les travailleurs salariés versent une cotisation correspondant à 4,95% de leurs gains, et leurs employeurs en font autant. Les travailleurs autonomes ont un taux de cotisation de 9,9%. Ainsi, en 2011, la cotisation maximale payable par un employé était de 2 217,60 \$ et celle d’un travailleur autonome, de 4 435,20 \$.

Gains:

Revenus sur lesquels des cotisations au Régime de pensions du Canada ont été prélevées. Ces gains sont essentiellement des salaires et des traitements ainsi que des gains provenant d’un travail autonome. Les gains ne comprennent donc pas les revenus provenant d’investissements ou de pensions. Les tableaux référant à la distribution des cotisants selon le niveau de gains dans le Rapport des cotisants 2008 utilisent le gain réel pour l’année civile. Auparavant, lorsqu’un cotisant commençait à recevoir une prestation (invalidité ou retraite) leurs gains de l’année étaient recalculés en proportion du nombre de mois écoulés dans l’année au moment où la prestation débutait. En raison de changement du système d’exploitation, cette méthode ne peut présentement être reproduite.

Average Earnings:

Average of the earnings shown in the Record of Earnings. However, contributors having earnings of \$100,000 or over are considered as having earnings of \$99,999 for the purposes of the average.

Median Earnings:

The value of the distribution of earnings which divides the number of contributors into two equal parts, or the amount of earnings above which 50% of the contributors are located and below which the other 50% are located.

Year's Basic Exemption (YBE):

This is the minimum level of earnings in a calendar year to be covered by CPP. This figure changes annually and in 2011 the YBE was \$3,500. Legislation that became effective January 1, 1998, has now frozen it at \$3,500.

Year's Maximum Pensionable Earnings (YMPE):

Contributions are made on the portion of an individual's annual earnings to this ceiling. This is approximately the average Canadian wage and was \$48,300 in 2011.

Age:

Refers to the age of the contributor at the end of the calendar year.

Province:

Many contributors have earnings in more than one province. To avoid multiple counting of these contributors, all earnings were considered to have been made in the province in which the greatest amount was earned.

The figures shown for the province of Quebec relate only to contributions of certain federal employees (members of Canadian Armed Forces for example) who reside in Quebec.

In the section presenting the distribution of the number of contributors by earnings level and by age, details have not been included in Quebec, N.W.T., Yukon, Nunavut and Outside Canada because of the small numbers in these areas.

Moyenne des gains:

Moyenne des gains inscrits au registre des gains. Cependant, les cotisants dont les gains sont de 100 000 \$ ou plus sont considérés comme ayant des gains de 99 999 \$ pour le calcul de la moyenne.

Médiane des gains:

La valeur de la distribution des gains qui divise le nombre de cotisants en deux parties égales, ou le montant des gains au-dessus et au-dessous duquel se situent 50% des cotisants.

Exemption de base de l'année (EBA) :

Il s'agit du niveau minimal des gains dans une année civile qui sera assuré par le RPC. L'EBA change chaque année et, en 2011, elle était de 3 500 \$. Conformément à la loi en vigueur depuis le 1er janvier 1998, l'EBA est maintenant gelée à 3 500 \$.

Maximum des gains annuels ouvrant droit à pension (MGAP):

Les cotisations sont prélevées sur la tranche des gains annuels d'un particulier jusqu'à ce plafond. Le MGAP est approximativement équivalent au salaire moyen canadien, et il était de 48 300 \$ en 2011.

Âge:

L'âge utilisé est celui du cotisant à la fin de l'année civile.

Province:

Un grand nombre de cotisants ont des gains dans plus d'une province. Afin d'éviter de compter plus d'une fois ces cotisants, on considère que tous leurs gains ont été accumulés dans la province où ils ont gagné le plus.

Les données présentées pour la province de Québec ne concernent que les cotisations versées par certains employés fédéraux (par exemple, les membres des Forces armées canadiennes) résidant au Québec.

Dans la section présentant la distribution du nombre de cotisants par niveau des gains et par âge, les tableaux donnant les détails sur le Québec, les Territoires du Nord-Ouest, le Yukon, le Nunavut et l'extérieur du Canada ont été exclus en raison du petit nombre de cotisants dans ces régions.
