DEFINITIONS AND TERMINOLOGY

Terms are defined under the first table in which they appear.

TABLE 1

Net Amount

Data is taken from the HRDC, Financial and Administrative Services, Report on the Financial transactions, published each month.

Province

Province or territory of residence of the beneficiary. Beneficiaries living outside Canada appear in the Category "O outside Canada".

Outside Canada

People who are receiving a benefit while residing outside Canada.

Unknown Residence

The implementation of Information Technology Renewal Delivery System (ITRDS) created this new category due technical difficulties. This category now includes low volume of beneficiaries.

In order to ensure client confidentiality, an 'X' has been placed where the number of clients receiving a particular benefit is equal to or below 9. In order to avoid residual disclosure, an 'X' has also been placed where the next lowest number of clients was found, which may be below, equal to, or above 9.

TABLE 3

Number of Benefits

Number of benefits paid in the month including benefits paid for the first time. As of June 2009, the number of new benefits include benefit paid under the Program Exception Processing (PEP).

To obtain the number of beneficiaries, the number of combined pensions must be deducted from the "Total" column.

Children of Disabled Contributor and Children of Deceased Contributor

The age group 18-24 also includes those who are 25 for the month of their birthday.

TABLEAU 1

Montant net

Les données sont tirées du Rapport sur les opérations financières, Services financiers et administratifs, DRHC

Province

Province ou territoire de résidence du bénéficiaire. Les bénéficiaires qui habitent à l'extérieur du Canada sont présentés sous la rubrique «à l'extérieur du Canada».

À l'extérieur du Canada

Personnes qui reçoivent une prestation et qui résident à l'extérieur du Canada.

Résidence inconnue

Suite à la mise en place du système d'exécution du renouvellement de la technologie de l'information (SERTI), cette catégorie a dû être créée en raison de problèmes techniques. Une fois ceux-ci résolus cette catégorie ne devrait contenir qu'un très faible volume de bénéficiaires.

En guise de protection des renseignements personnels des clients, un « X » a été placé dans le cas où le nombre de clients recevant une prestation est égal ou inférieur à 9. Afin d'éviter la divulgation par recoupements, un « X » a aussi été mis au nombre suivant de clients le moins élevé, lequel peut être inférieur, égal ou supérieur à 9.

TABLEAU 3

Nombre de prestations

Nombre de prestations versées dans le mois incluant les prestations versées pour la première fois. Le nombre de nouvelles prestations à compter de juin 2009, inclut les prestations payées par le procédé d'exception de programme (PEP), anciennement le système de chèques supplémentaires.

Pour obtenir le nombre de bénéficiaires, le nombre de pensions combinées doit être soustrait de la colonne «Total».

Enfants de cotisant invalide et enfants de cotisant décédé

Le groupe d'âge 18-24 comprend ceux qui ont eu 25 ans le mois de leur anniversaire.

Combined Pensions

Persons receiving a survivor's pension may also be entitled to a retirement or disability pension based on their own CPP contributions. In these cases, the surviving spouse receives a combined survivor/retirement pension or a survivor/disability pension. These pensions are included in their respective category, as well as in the "Combined" category.

Data on combined benefits survivor/retirement and survivor/disability is unavailable due to technical difficulties. Once resolved, this data will be posted.

International Agreement

An agreement by which two countries agree to provide equal treatment to the residents of both countries under each country's laws on social security.

TABLE 4

New Benefits

Benefits paid for the first time. The month in which the first payment is issued may be later than the effective month of the benefit.

Benefits paid under international agreement on social security are not included.

TABLE 6

Gross Amount

Represents the benefit expenditures recorded at the time the cheques are issued from the main computer cheque system. Therefore, this amount is not taking into consideration overpayments, underpayments.

Benefits paid under international agreements on social security cannot at this time, be distributed by province, age, sex, etc.

TABLE 8

Average Amount Paid

The sum of the benefits paid in the month, divided by the number of entitlements above zero, not including retroactive payments.

Does not include benefits paid under international agreements on social security as well as underpayments or other adjustments.

TABLE 24

Country of Agreement

The country with which Canada has signed an Agreement on Social Security.

Pensions combinées

Les personnes recevant une pension de survivant peuvent aussi avoir droit à une pension de retraite ou d'invalidité d'après leurs propres cotisations au RPC. Dans ces cas, le conjoint survivant reçoit une pension combinée de survivant et de retraite ou de survivant et d'invalidité. Ces pensions sont déjà présentées dans leur propre catégorie ainsi que dans la catégorie «Combinées».

Les données sur les prestations combinées survivant/retraite et survivant/invalidité ne sont pas disponibles en raison de problèmes techniques. Une fois ceux-ci résolus, les données seront de nouveau publiées.

Accord international

Une entente par laquelle deux pays acceptent d'accorder à leurs résidents l'égalité de traitement lorsqu'il s'agit d'appliquer la loi pour la sécurité sociale propre à chaque pays.

TABLEAU 4

Nouvelles prestations

Prestations versées pour la première fois. Le mois au cours duquel le premier versement est effectué peut être postérieur au mois d'entrée en vigueur de la prestation.

Les prestations versées sous les accords internationaux de sécurité sociale ne sont pas incluses.

TABLEAU 6

Montant brut

Représente les dépenses enregistrées au moment où les chèques sont produits par le système informatisé d'émission des chèques. Ce montant ne comprend pas les trop-payés, les moins-payés.

Les prestations versées sous les accords internationaux de sécurité sociale sont présentées sous la rubrique «autres» et ces renseignements ne peuvent présentement être distribués selon la province, l'âge, le sexe, etc.

TABLEAU 8

Montant moyen versé

La somme des prestations versées dans le mois, divisée par le nombre de prestations mois, divisée par le nombre de prestations pas les paiements rétroactifs. Ne tient pas compte des prestations versées sous les accords internationaux de sécurité sociale ainsi que les sous-payés ou autres ajustements.

TABLEAU 24

Pays de l'accord

Le pays avec lequel le Canada a signé un accord sur la sécurité sociale.

Terms are defined under the first table in which they appear.

TABLE 27

Net Amount

Represents the amount paid for Old Age Security benefits including underpayments, special or manual cheques issued, returned cheques, journal vouchers, cash refunds. Recoveries of overpayments (Old Age Security, Guaranteed Income Supplement, Allowance) are not included, neither are refunds of the benefit repayment received from Revenue Canada.

Place of Residence

Province or territory of residence of the beneficiary. Beneficiaries living outside Canada are included under their last province or territory of residence in Canada.

International Agreement

Old Age Security Benefits paid to persons living in Canada and abroad under reciprocal Social Security Agreements.

Old Age Security Pension

Persons receiving an Old Age Security pension, paid by Regional Offices and International Operations Directorate. (See also the definition of "International Agreement" above).

Guaranteed Income Supplement

The Guaranteed Income Supplement is paid to Old Age Security pensioners who because of little or no income, qualified for such supplement. (See also the "Guaranteed Income Supplement" definition under Table 34).

TABLEAU 27

Montant net

Représente le montant versé pour les prestations de la Sécurité de la vieillesse, montant qui inclut les moins-payés, les chèques spéciaux ou émis manuellement, les chèques retournés, les pièces de journal et les remboursements d'argent comptant. Les recouvrements des plus-payés, pour la Sécurité de la vieillesse, le Supplément de revenu garanti et pour l'Allocation, ne sont pas inclus, ni les remboursement reçus par Revenu Canada.

Lieu de résidence

Province ou territoire de résidence du bénéficiaire. Le dernier lieu de résidence (province ou territoire) au Canada a été retenu comme lieu de résidence des bénéficiaires qui habitent à l'extérieur du Canada.

Accord international

Prestations de la Sécurité de la vieillesse versées aux personnes résidant au Canada ou à l'étranger en vertu d'accords réciproques sur la sécurité sociale.

Pension de la Sécurité de la vieillesse

Personnes recevant une pension de la Sécurité de la vieillesse, payée par les bureaux régionaux et la Direction générale des opérations internationales. (Voir aussi la rubrique «Accord international» ci-dessus).

Supplément de revenu garanti

Le Supplément de revenu garanti est payé aux pensionnés de la Sécurité de la vieillesse qui en raison d'un revenu faible ou nul, se sont qualifiés pour ce supplément. (Voir aussi la définition «Supplément de revenu garanti» sous le tableau 34).

Allowance

The persons to whom the Allowance, Extended Spouse's Allowance or an Allowance for the survivor was paid. (See also the "Allowance" definition under Table 43).

TABLE 31

GIS as % of OAS

The percentage of the total number of Old Age Security pensioners who are in receipt of a Guaranteed Income Supplement.

TABLE 32

Gross Amount

These are expenditures as recorded by the computer cheque issue system. This amount takes into consideration overpayments and underpayments.

TABLE 33

Old Age Security

Domestic – Persons receiving an Old Age Security pension in Canada.
Foreign – Persons receiving an Old Age Security pension outside Canada.
1-39/40th – Pensioners who meet the residence requirements for a partial OAS pension.
40/40th – Pensioners who meet residence requirements for a full OAS.

Allocation

TABLE 35Guaranteed Income Supplement

Single pensioner – OAS pensioners who are single, separated, divorced or widowed and receiving a maximum or partial GIS at the “single” rate.

Spouse is a pensioner – Married and common-law couples, where both spouses are OAS pensioners receiving a maximum or partial GIS at the “married” rate. Both spouses are counted.

Spouse is not a pensioner – Married and common-law couples, where one spouse is an OAS pensioner receiving a maximum or partial GIS at the “single” rate. The other spouse is not receiving the OAS pension or the ALW, and is not counted.

Spouse is in receipt of ALW – Married and common-law couples, where one spouse is an OAS pensioner receiving a maximum or partial GIS at the “married” rate, and the other spouse is receiving an Allowance. The spouse receiving ALW is not counted.

TABLE 40Allowance

Allowance – Allowance paid to the 60 to 64 year old spouse/common law of a pensioner in receipt of OAS and GIS.

Extended Spouse’s Allowance – Allowance paid to the 60 to 64 year old spouse of a deceased pensioner.

Allowance for the survivor – Allowance paid to a widow or widower aged 60 to 64.

Benefits paid for the first time.

TABLEAU 35Supplément de revenu garanti

Pensionné seul – Pensionnés de la SV qui sont célibataires, séparés, divorcés ou veufs et qui reçoivent le SRG maximal ou partiel versé au taux de «personne seule».

Le conjoint est un pensionné – Couples mariés ou vivant en union de fait, où les deux conjoints sont des pensionnés de la SV recevant le SRG maximal ou partiel versé au taux de «personne mariée». Les deux conjoints sont comptés ici.

Le conjoint n’est pas un pensionné – Couples mariés ou vivant en union de fait, où un conjoint est un pensionné de la SV recevant le SRG maximal ou partiel versé au taux de «personne seule». L’autre conjoint ne reçoit pas la pension de la SV ou ALC et il n’est pas compté.

Number and amount paid to persons receiving Old Age Security Benefits outside Canada according to the last province or territory of residence in Canada.

TABLE 47International Agreement

An agreement that allows for the coordination of two countries' social security programs and makes social security benefits portable between these countries.

Country of Agreement

Country with which Canada signed a reciprocal social security agreement.

Domestic

People who are in Canada, and are receiving a benefit due to an agreement between Canada and another country.

Foreign

People who are outside Canada, and are receiving a benefit due to an agreement between Canada and another country.
