CASH INCOME FROM THE SALE OF FARM PRODUCTS, 19581/

This preliminary estimate of cash income from the sale of farm products plus income from cash advances and participation payments on the previous years' Prairie grain crops is presented at this time to meet the need for farm cash income statistics as soon as possible after the close of the year. It is estimated that for the year 1958 this income amounted to 2,808.2 million dollars, about 8 per cent above the figure of 2,591.9 million dollars for 1957, and 5 per cent above the 2,663.5 million dollars for 1956. The all-time high cash income estimate was established in 1952, when it reached 2,859.1 million dollars. Supplementary payments in 1958 amounted to 61 million dollars compared with 2.0 million dollars for 1957. This increase can be attributed, in the main, to the Western Grain Producers Acreage Payment, P.C. 1958-1442. For supplementary payments see page 2.

The increase in cash farm income can be largely attributed to larger returns from the sale of livestock and animal products.

The regular annual estimates of farm cash income based on more complete data and including details by commodities, will be released in March.
