

The Value of Consumable Stores and Equipment Purchased and Expenditures for Freight and Insurance, by the Mining and Non-ferrous Metallurgical Industries in Canada, during the Calendar Year 1934

Data compiled from a statistical survey, recently conducted by the Mining, Metallurgical and Chemical Branch of the Dominion Bureau of Statistics at Ottawa, not only emphasize the great purchasing power of the Canadian mining industry but also reveal the great diversity of its purchases, the value of which is of ever growing importance to the economic welfare of Canadian industry as a whole.

The questionnaire which was used in conducting this survey was designed in collaboration with the Ontario Mining and Canadian Metal Mining Associations. The Bureau tenders its thanks to the officers of these associations and to the Canadian mining industry for their excellent co-operation in facilitating the completion of this work.

This survey is not absolutely complete since it was found impracticable to collect or obtain returns from individuals or companies whose records were either incomplete or entirely lacking. Then again, returns were not generally obtainable from prospectors or syndicates whose operations were of an exploratory nature and conducted in isolated or remote regions and whose expenditures would amount to a considerable sum in the aggregate.

The total value of purchases by the industry in 1934, as computed from returns made available, amounted to \$76,083,000. The survey covered the major groups of the mining industry, including metal mining, smelting and refining of non-ferrous domestic ores, non-metallic mineral mining, including coal, petroleum and natural gas production, and, to a lesser extent, the stone, lime and other structural materials industries.

It is also emphasized that the values shown in this report indicate only the direct purchasing power of the industry, and do not entirely reflect the increasing economic importance of the communities dependent, partially or entirely, on the development of our mineral resources.

An analysis of the values for 1934 reveals that the total of \$60,979,000 for metal mining and non-ferrous smelting and refining comprises 80 per cent of the total for the whole mining industry and of the total of \$60,979,000, the value of purchases by the Canadian gold mining industry alone constitutes 39.4 per cent, or \$23,994,000. Purchases by the copper-gold-silver mines and metallurgical plants smelting these ores, totalled \$9,777,000; \$16,170,000 was expended by the nickel-copper mining, smelting and refining industry; \$10,425,000 by the silver-lead-zinc mines and metallurgical plants, and \$594,000 by the cobalt-silver mining and smelting industries.

In the non-metal mining industries purchases by the coal mines totalled \$8,560,000 and \$2,024,000 was expended in the asbestos mining industry.

The returns received for the structural materials group aggregated \$2,569,000.

Of the total expenditures in all branches of the industry throughout the Dominion those of Ontario amounted to \$35,072,000 or 46.1 per cent; those of British Columbia (including Yukon) were second in importance with a total value of \$17,531,000 or 23.1 per cent; Quebec was third at \$9,714,000, and in the order of importance the other corresponding provincial expenditures were as follows: Nova Scotia, \$5,488,000, Manitoba (including Saskatchewan), \$4,843,000, Alberta, \$3,196,000, and New Brunswick, \$240,000.

The magnitude of certain particular expenditures, as shown in Table 1, is reflected in such items as \$9,139,000 for electric power, \$11,787,000 for freight, \$8,671,000 for coal, oil and other fuel, \$5,311,000 for explosives, \$4,154,000 for lumber and timber, \$2,301,000 for flotation reagents, cyanide and other chemicals, and \$1,050,000 for rock drills and parts. Other interesting items include \$1,665,000 for pipe and fittings, plumbing supplies and valves, \$2,343,000 for electrical equipment and supplies, \$385,000 for stationery, office equipment, etc., and \$58,400 for hospital equipment.

In addition to the values shown in the tables of this report, a partial survey of the Canadian diamond drilling industry reveals a total value of \$224,600 in expenditures incurred by diamond drillers in 1934, and of this total, \$105,884 represents purchases of diamonds and bort for drills.
