## MONTHLY PRODUCTION OF CARBONATED BEVERAGES

Production of Carbonated Beverages in December 1957, was 10,626,826 gallons, a 10.2% increase over the production for the same month in 1956. The cumulative production for the 12 months of 1957 was 128,853,035 gallons which is 5.9% larger than the 121,667,276 gallons produced in the same period last year.


