# MONTHLY PRODUCTION OF CARBONATED BEVERAGES 

March, 1960
Production of Carbonated Beverages in March 1960 was $10,752,848$ gallons, a $20.5 \%$ increase over the production for the same month in 1959. The cumulative production for the first 3 months of 1960 was $30,845,451$ gallons which is a $17.6 \%$ increase over the $26,219,592$ gallons produced in the same period last year.
