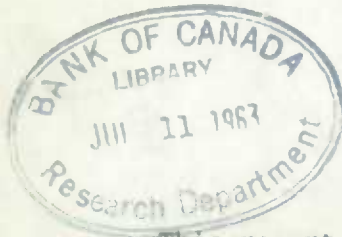

MISCELLANEOUS FOOD PREPARATIONS



Quarter ended March 31, 1963

This report includes data relative to the quarterly production of certain selected processed food commodities which were formerly included in Quarterly Processed Foods. When the data for the fourth quarter of 1962 was made available this latter release was discontinued in favour of the current quarterly report.

Quarterly production of these commodities will be released for periods ending March 31, June 30, September 30 and December 31 each year. Detail on selected items such as tea, coffee, skim milk powder, food drink powder, cake mixes and other major food commodities. The new presentation should be more easily prepared within the Bureau, with resulting improvement in timeliness.

A list of the participating firms is given in this issue. Said list will appear once a year in the respective March issue. In other periods, cumulative quarterly production data will be given.
