THE BISCUIT AND CONFECTIONERY INDUSTRY, 1920.

Ottawa, March, 1922:- The Dominion Bureau of Statistics here-with presents a separate report on the Biscuit and Confectionery Industry in Canada for the calendar year 1920, apart from the baking of bread, etc., in response to an appeal from the association of Biscuit and Confectionery manufacturers. The statistics cover the operations of 400 individual plants, located by provinces, as follows:- Ontario 225, British Columbia 49, Quebec 47, Alberta 28, Manitoba 17, Saskatchewan 13, Nova Scotia 10, New Brunswick 9, and Prince Edward Island 2, in the order named.

PRODUCTION.

The quantity and selling value at the factory of the various items of production are stated in the following summary table for the calendar year 1920, the total value amounting to \$54,658,833. As some factories also operate bakeries in connection, it has been impossible to entirely segregate the statistics of the two industries:-
