THE MALT LIQUOR INDUSTRY, 1919 and 1920.

Ottawa, June, 1922: The Dominion Bureau of Statistics presents a report on the Malt Liquor Industry in Canada during the calendar years 1919 and 1920. Reports were received covering the operations of 57 breweries for each of the two years. The location of establishments by provinces, was as follows:-

## PRINCIPAL STATISTICS BY PROVINCES.

The statement following shows for the years 1919 and 1920 the relative importance of the industry by provinces. THE MALT LIQUOR INDUSTRY IN CANADA, 1919 and 1920.

PRODUCTION.

An increase of \$9,526,785 is reported in the value of Browery products in 1920 over the preceding year. The quantity of beer, ale, etc., in barrels show a decrease, though there is an increase in value. Bottled liquors increased by 5,199,635 gallons and the value reached \$20,227,059 in 1920. The total value of beer, ale, stout and porter was reported at \$19,122,837 in 1919 and at \$28,588,622 in 1920, an increase of \$9,465,785. The total value of all products increased from \$20,169,074 in 1919 to \$29,695,859 in 1920.

The following table gives detailed statistics of production for 1919 and 1920 and comparative values by provinces and by items for 1920.

EMPLOYEES, SALARIES AND WAGES

Salaried employees and wage-earners are shown for the calendar years 1919 and 1920 in the accompanying table. There is a total increase of 681 male and one female employee in 1920. The total of salaries and wages paid also increased by \$1,248,195 from a total of \$3,131,465 in 1919 to \$4,379,660 in 1920.

MATERIALS USED.

The largest outlay for materials was made for Malt, costing \$6,188,300 for 2,113,924 bushels in 1920, and \$3,912,966 for 1,440,819 bushels in 1919. The total cost of materials was reported at \$8,093,403 in 1919 and at \$12,525,107 in 1920, an increase of \$4,431,704. The cost of bottles also increased from \$1,539,983 in 1919 to \$2,530,284 in 1920, a difference of \$1,000,301. The table below gives the quantities and cost value (including duties) of all materials used during the years 1919 and 1920. Canadian and foreign malt are shown separately.

IMPORTS AND EXPORTS.

The value of imports in 1920 more than doubled those of 1919, the respective totals being \$131,615 and \$63,173. Exports were reported at 241,994 gallons valued at \$157,150 in 1919 and 756,381 gallons valued at \$859,364 in 1920, the increase in value being of 447 per cent.
